After some discussion it was moved by Dr. Kroll, seconded by Ms. Roos-Marr, and unanimously carried to approve the application for Ms. Klaft.

Old Business:

a. World Education Services ("WES") – Evaluation Reports

WES is an international credential evaluation service. WES generated over 200,000 reports last year for various organizations, individuals, boards, and colleges. Accreditation is reported if the institution is regionally accredited in the U.S., or affiliated with an accredited degree granting institution ("mother"). They authenticate documents (same as AACRAO) and will detail any abnormalities in their report.

Executive Officer Kramer researched foreign-schooled Hawaii licensees and appeared no one submitted a WES report.

Dr. Wai Low was asked which credential evaluation service they use at their school. He said he uses both WES and AACRAO. Dr. Low said that WES is a little bit more expensive than AACRAO, but WES reports are more user friendly and AACRAO reports aren't as clear to understand.

It was moved by Dr. Kroll, seconded by Dr. Tsuchiyama to accept WES as the sole evaluation agency.

At 1:48 p.m., Dr. Tsuchiyama was excused from the meeting. Dr. Kroll took over as Chair Pro Tem.

b. Review Final draft of HAR 16-72, Subchapters 1-5

Subchapter 2

Definitions: agree with revisions

Subchapter 3

Question: Does the board want to set a maximum number of students that the supervisor can be responsible for? Up to school to determine, ACAOM doesn't require a maximum, California state requires direct supervision at any time, not one on one

Subchapter 4

§16-72-14 (c) (1) Add to last sentence "or according to ACAOM standards, or whichever is greater."

§ 16-72-14 (c) (2) ... and not less than 350 patients <u>or by ACAOM</u> standards, whichever is greater.

c. Proposed Rule Revisions, HAR Title 16, Chap. 72

Subchapter 7

§16-72-46 Renewal: Any additional requirements to the renewal process requires an amendment to the law

§16-72-47 Renewal due date. "...a cashier's check, <u>online payment</u> or a postal money order."

§16-72-48 Failure to renew; forfeiture; restoration. Revise second sentence to: "However, a license which has been forfeited for failure to pay the renewal fee on time may be restored within one year after the date of forfeiture via licensing renewal requirements provided by law when a written application and payment of the restoration fees are provided in the rules (adopted by the director in accordance with chapter 92, HRS) are submitted."

Subchapter 8

§16-72-53 Sanitation practices

- 2) hands shall be washed with soap and water <u>or minimum 70%</u> <u>alcohol germicide</u> before handling a needle and <u>between before and after</u> treatment of different patients;
- 3) A piercing needle shall be previously unused and sterilized disposable;
- 6) delete
- 7) Prior to its usage on a patient, a reusable instrument or a nonpiercing acupuncture needle shall be sterilized in an autoclave according to manufacturer's specifications at a minimum temperature of 250F (or 121 C) for not less than thirty minutes at fifteen pounds of pressure per square inch or by a disinfectant agent;

By consensus of the Board, they will review and discuss Subchapters 9 – 11 at its next meeting and will revisit the final draft of HAR Title 16, Chapter 72, Subchapters 1 – 6.
