Executive Officer Taniguchi informed the Committee that the Appraisal Subcommittee has yet to adopt their proposed federal appraisal management company regulation and reiterated that states will have three (3) years to implement those rules into their administrative rules.

the Committee on January 15, 2015.

Executive Officer Taniguchi stated that two vacant public member seats are currently available, and further that Chairperson Cool's second term to the Committee ends on June 30, 2015; thus, an industry member seat will also need to be filled. Discussion ensued on the qualifications for an industry member - whom shall be an appraiser, actively performing appraisal work for a period of not less than five years preceding the date of the member's appointment.

Executive Officer Taniguchi also stated that Mr. Yamada's first term to the Committee ends on June 30, 2015. Mr. Yamada commented he was unsure whether he would be interested in serving another

> four (4) year term, noting that he plans to retire from the banking industry in May. Discussion ensued on the qualifications for a financial institution member - whom shall have been employed in a position requiring familiarity with loan transactions by a savings and loan, a commercial bank, credit union, thrift, or similar institution for at least five years.

> Mr. Walther inquired about the course requirement that supervising appraisers must complete; whether the course must be taken with exam. Executive Officer Taniguchi stated that it may be voluntary by each state whether they would require a course with or without exam. DAG Paige advised the Committee to include this topic, supervisor trainee course, for discussion in the subsequent meeting agenda.
