c. <u>Legislation</u>

None.

d. <u>Appraisal Subcommittee ("ASC") Compliance Review</u>

Committee members were provided with a copy of the final ASC Compliance Review Report. Executive Officer Taniguchi stated that the Program was awarded an ASC Finding of "Good", subsequent to the audit by ASC for the Program's compliance with Title XI of the Financial Institutions Reform, Recovery, and Enforcement Act of 1989, as amended. He briefly summarized the report:

 In practice, the State is complying with AQB Criteria for Trainee Appraisers and must continue the process to amend its Rules.

e. Hawaii Administrative Rules ("HAR") Proposed Amendments

Committee members were provided with a copy of the proposed amendments to HAR chapter 16-114. Executive Officer Taniguchi commented the proposal should codify the state's regulations on supervisory and trainee appraisers to comply with AQB Criteria requirements. After discussion, it was moved by Vice-Chairperson Walthers, seconded by Mr. Leong, and unanimously carried to approve the proposed amendments to HAR chapter 16-114.

<u>Unfinished</u> Business:

Executive Officer Taniguchi reiterated that the ASC's final rules on Appraisal Management Companies ("AMCs") regulations and its' mandatory audit process/oversight controls were published, and its effective date is August 10, 2015. Also, that the Department of Commerce and Consumer Affairs ("Department") has three (3) years to decide whether or not to regulate AMCs.

Mr. Taniguchi inquired with Messrs. Leong and Larson for their comments/opinions as financial institution members to the Committee, whether AMCs should be regulated by this state. Mr. Larson commented that his employer's commercial appraisals are completed in house with oversight within their bank. Mr. Larson further commented that they are actively looking at AMCs, as assuring reliability and consistency. Mr. Leong commented that

Executive Officer Taniguchi commented that the Committee/Department should deliberate on the opinions of appraisers, financial institutions, and the public to determine if the Department should regulate AMCs
