The eleven (11) barber shop/beauty shop applications were preliminarily reviewed by staff, the Executive Officer, Ms. Tokunaga and Ms. McKay (the designated Board members to review the barber shop/beauty shop applications for consideration for this Board meeting).

Ms. McKay stated that she and Ms. Tokunaga reviewed the eleven (11) applications, including applicant #8, and concluded that they meet all requirements for barber

shop/beauty shop new and shop relocation licenses, and recommends approval. After discussion, it was moved by Ms. McKay, seconded by Mr. Choi, and unanimously carried to approve the barber shop/beauty shop applications listed above.

C. Restoration of License

(1) AKIYAMA, Masayo ( BEO 16485 )

After discussion, it was moved by Mr. Nelson, seconded by Mr. Choi, and unanimously carried to defer the restoration application of the beauty operator license of Masayo Akiyama, pending clarification of citizenship, and authorization to work in U.S.

Executive Officer Kai provided an update on the proposed rule amendments, and stated that comments from the Attorney General's office were received. The proposed rule amendments are currently pending consideration by the Small Business Regulatory Review Board at its March 18, 2015 meeting.

Open Forum: Ms. McKay commented on the high school education requirement for licensure as a Hawaii Beauty Operator; she stated that Honolulu Community College ("HCC") professor, Jessie Aki, requested that the Board send a letter to the Department of Education to obtain clarification of its definition of a qualified high school diploma, including but not limited to high school education received online, through correspondence and home schooling, and other alternative learning options.

Mr. Choi stated that he will not be able to attend the next scheduled Board Meeting due to a conflict in schedule.
