He is now reapplying for licensure and is requesting that the FE and PE exam requirement be waived for him again.

Old Business: a. Rules Committee Report

The Committee again reviewed and discussed the draft prepared by Mr. Yumol regarding the definition of "supervise", "supervision", "supervision of design", or "under the supervision of" as it applies to a successor licensee. Mr. Yumol reported that he met with Mr. Tim Hiu of the Honolulu Building and Permitting Department and Mr. Hiu indicated they handle successor licensee situations the same way as specified in the draft.

The Committee approved the draft with a non-substantive change and recommended sending it to the full Board for consideration.

Moreover, Mr. Yumol prepared a Rules Committee Action Plan for the Committee's review. The Action Plan included assignments for the members of the Committee and staff. The Action Plan will be discussed at the next meeting.

Also, the Committee approved the minutes of the Rules Committee Meeting on September 11, 2014.

It was moved by Mr. Yumol, seconded by Mr. Constantino, and unanimously carried to approve the minutes of the October 9, 2014 Rules Committee meeting with the following amendment:

On page 1, third paragraph, delete "and time frames".

Mr. Yumol reported that the Rules Committee will be working to push through the changes already approved on and requested approval from the Board on the proposed amended language regarding "supervise", "supervision", "supervision of design", or "under the supervision of" in Hawaii Administrative Rules section 16-115-2:

- ""Supervise", "supervision", "supervision of design", or "under the supervision of" means that a licensed engineer, architect, surveyor, or landscape architect, as the case may be, shall:
- (1) Exercise direct control and oversee the subject activity through physical presence or through the use of communication devices; provided the licensee has both direct control and detailed professional knowledge of the work being supervised; or
- [(2) Substantially redraft, redraw, redesign, or recalculate the plans, specifications, and other related documents; and be responsible for all work within the licensee's discipline performed on plans, specifications, and other related documents.]
- (2) In circumstances where a licensee in responsible charge of the work is unavailable to complete the work in instances such as death, incapacity, termination of employment or relocation, a successor licensee may take responsible charge by performing all professional services, including design criteria, recalculations, code research and compliance, and any other necessary and appropriate changes, in order to complete the project.

In case original documents have already been signed and sealed at the time of assumption of responsible charge of the project by the successor licensee, the successor licensee shall have control of and responsibility for the work product and the signed and sealed originals of all documents. The burden is on the successor licensee to show such compliance.

The successor licensee, when required by agencies and other authorities having jurisdiction over the project, shall stamp and seal documents subsequently developed and produced under the successor licensee's supervision and responsible charge.

The non-professional service, such as drafting, need not be redone by the successor licensee, but must clearly and accurately reflect the successor licensee's professional work."

After discussion, it was moved by Mr. Katayama, seconded by Mr. Murray, and unanimously carried to approve the above language be included in the Board's proposed rules regarding "supervise", "supervision", "supervision of design", or "under the supervision of".

New Business: a. <u>Professional Engineer's Report</u>

Mr. Kobashigawa reported on the following:

- NCEES's 2015 Board Presidents' Assembly is scheduled for February 7, 2015 in Atlanta, GA with funding available for one board member and a member board administrator.
- Upcoming changes for the April 2015 NCEES exams and supporting materials:
 - ✓ The civil PE exam will have new specifications with new design standards for the civil construction, geotechnical, structural, and transportation modules, which are posted on NCEES' website.

- ✓ The 16-hour structural exam will have revised design standards which are posted on NCEES' website.
- ✓ The renamed agricultural and biological engineering PE exam will have new specifications, which are posted on NCEES' website. This exam will be administered every spring thereafter.

The spring exams will be administered on April 17 and 18, 2015 with the PS and PE exams as well as the vertical forces component of the SE exam administered on April 17 and the lateral forces component of the SE exam administered on April 18.

b. Architect's Report

 2014 NCARB Member Board Chairs/Member Board Executives Conference

Mr. Kobashigawa and Mr. Yumol attended the Member Board Chairs/Member Board Executives Conference Meeting in Indianapolis, IN.

The current proposals regarding changes to the Intern Development Program ("IDP"), Broadly Experienced Architect ("BEA"), and Broadly Experienced Foreign Architect ("BEFA") were discussed. However, it appears that there needs to be more discussion regarding these matters before the next Annual Meeting.

During the Region VI meeting, it was announced that a there will be a new website launched in March 2015 with a video site where impressive projects completed in each State within Region VI can be viewed.

d. <u>Landscape Architect's Report</u>

Mr. Kurokawa reported on the following:

 The next CLARB Annual Meeting is scheduled for September 16-19, 2015 in New Orleans.

- This year's Annual Meeting had their highest attendance to date with 115 people attending representing 41 member boards.
- He participated in this month's "In The Know" webcast which discussed meeting the experience requirements. For some jurisdictions it can be a challenge to gain the required experience for licensure under the direct supervision of a licensed landscape architect. Alternative pathways to meet the experience requirement were discussed as well as how other jurisdictions handle this issue.

b. <u>E-mail from Eric Zielke</u>

Mr. Zielke inquired whether the Board has a flow chart similar to that of the Texas Board of Professional Engineers that explains if an engineer license is required based upon the type of project and work involved.

Hawaii's laws are not as complicated as Texas' as generally anyone who performs engineering work in Hawaii is required to be licensed. The Board will take this matter under advisement.

The Professional and Vocational Licensing Division will be having a Board/Commission Orientation for new board/commission members. Topics to be discussed are ethics in government, Sunshine Law, contested case hearings, administrative procedures, handling complaints, etc. Mr. Iwamoto, Mr. Hirota, Mr. Kurokawa, and Mr. Kayatama will be attending.
