Regarding section 16-115-9, the Committee recommended specifying that "design drawings and other documents" be stamped as required by an authority having jurisdiction of the submittals. Also, the proposal to have only one original set of design drawings to have every sheet stamped and contain an original signature should be deferred and taken out of this proposal due to concerns raised regarding electronic submittals and to obtain additional feedback from County building officials.

Regarding the definition of "supervise", "supervision", "supervision of design", or "under the supervision of", the Committee recommended that the Attorney General prepare a draft of creating separate sections of the definitions as he had recommended.

Regarding section 16-115-10, Misconduct in the practice, the Committee recommended replacing "scope of competency" with "rules of professional conduct".

The Committee recommended that Mr. Tim Hiu of the City and County of Honolulu, Department of Planning and Permitting, be invited to provide information to the Board at its May meeting.
