# MINUTES OF MEETING

<u>Agenda</u> :	The agenda for this meeting was filed with the Office of the Lieutenant Governor, as required by section 92-7(b), Hawaii Revised Statutes ("HRS").
1. Call to Order:	There being a quorum present, Chair Nagashima called the meeting to order at 9:05 a.m.
2. <u>Additions/</u> <u>Additional</u> <u>Distribution</u> <u>to Agenda</u> :	Chair Nagashima announced that the following was distributed to the Board members as additional distribution:

3. <u>Approval of</u> <u>Minutes of the</u>	Chair Nagashima asked if there were any corrections to the May 4, 2016 minutes.
May 4, 2016 Meeting:	Ms. Bath noted that she had no corrections, however, she would like to clarify one of her statements in the minutes. On page 2, under "4. Executive Officer's Report,

a. Legislation Update, 1) HB 2233", the second paragraph states "The Board reviewed Ms. Bath's follow up report, in which she stated that she had not come up with language at this time." Ms. Bath would like to clarify that the reason she did not provide language was because in researching the issue, she did not feel it was appropriate to do so.

After some discussion, the following changes to the minutes were requested (underlined material added, while bracketed material is to be deleted):

- On Page 3, under "5. Unfinished Business, b. Hawaii Massage Exam", the fourth paragraph should read "<u>DAG</u> [EO] Tam noted that as the pass/fail percentages are dependent on the candidates, the exam provider would not be able to adjust the content to change those percentages."
- On Page 5, the first sentence of the second paragraph should read "Ms. Bath said she feels apprenticeships are problematic because some <u>businesses</u> solely for <u>profit</u> [business], and not to train apprenticeships."
- On Page 7, the last sentence of the last paragraph should read "She noted that once the Board can come to an agreement on a full draft, the rules review process can begin."

There being no further discussion or amendments to the minutes, Ms. Bath voted to approve the minutes of the May 4, 2016 meeting as amended. It was seconded by Ms. Behnken, voted on and unanimously carried.

4. <u>Election of Officers</u>: After some discussion, Ms. Behnken moved to nominate Vice Chair Davis as Chair. Ms. Bath seconded the motion. It was voted on and unanimously carried.

After some discussion, Vice Chair Davis moved to nominate Ms. Behnken as Vice Chair. Ms. Bath seconded the motion. It was voted on and unanimously carried.

5. <u>Executive Officer's</u> EO Kramer announced that this is Chair Nagashima's last meeting as a board member. She presented Chair Nagashima with a certificate of appreciation and thanked her for devoting valuable time while serving on the Board.

EO Kramer reminded the Board that there will be an orientation for board members on Tuesday, August 30, 2016 from 8:30 a.m. to 12:30 p.m. at the State Capitol Auditorium. Topics to be discussed include Ethics in Government, the Sunshine Law, Contested Case Hearings, Administrative Procedures, Handling Complaints, and the Role of a Board/Commission Member. Ms. Behnken is already attending. If any other members are interested in attending, they should let her know as soon as possible. EO Kramer reported that SB 2863 was signed into law as Act 146 by Governor Ige on June 29, 2016. A copy of Act 146 as well as the updated HRS Chapter 452 have been distributed to the board members.

## 6. Correspondence: a. Email from RICO regarding an MAE license

The Board reviewed an email from RICO regarding asking if Harry Frank dba Awakening Hands Bodywork needs a massage establishment ("MAE") license. RICO attached a letter from Mr. Frank in which he states in part "The office sessions are primarily my mainland & local friends and the occasional Maui Guest from the B-units at the Mana Kai or Day's Inn where the units are too small for a bodywork session. The Office: Out Call ratio is only 9.4%."

Ms. Bath notes that a printout of Mr. Frank's website states "Visit South Kihei Office".

Ms. Behnken stated she feels because Mr. Frank advertises his office as an option and, thus, creates an expectation that he practices there, he should obtain an MAE license for the office location.

Chair Nagashima agreed.

DAG Tam also noted that his practice appears to fall within the definition of a "massage therapy establishment" under HRS section 452-1: "…premises occupied and used for the purpose of practicing massage therapy…".

After some discussion, upon a motion by Ms. Behnken, seconded by Vice Chair Davis, it was voted on and unanimously carried that based on the information provided in Mr. Frank's letter and website, it is the Board's informal interpretation that a massage therapy establishment license would be required in order to provide massage therapy services at his office location.

This is an informal interpretation for informational and explanatory purposes only and is not an official opinion or decision and therefore is not to be viewed as binding on the Board.

# b. Letter from Marguerite Pennington requesting to accept her program as an approved school

The Board reviewed Ms. Pennington's request that "my new students be granted the same rights as my old ones have been".

EO Kramer reported that previously, the Board agreed to accept the training and education of students taught by Ms. Pennington, provided the curriculum is in

accordance with Hawaii Administrative Rules ("HAR") § 16-84-23 and also must be conducted in a licensed massage establishment or a Department of Education licensed school. EO Kramer noted that HAR § 16-84-23 is the section listing requirements for apprentices.

After some discussion, upon a motion by Ms. Behnken, seconded by Ms. Bath, it was voted on and unanimously carried that based solely on the information provided in Ms. Pennington's letters, it is the Board's informal interpretation to reaffirm its decision to accept the training and education of students taught by Ms. Pennington; provided that the curriculum satisfies the requirements of HAR § 16-84-23, and the training is conducted at a licensed MAE or a Department of Education licensed school.

With respect to the location of her MAE, the Board requested that EO Kramer inform Ms. Pennington that having an MAE in a doctor's office is acceptable; provided that the applicant submits an agreement between the applicant and the owner/rental management company of the building (not between the applicant and the doctor they are subleasing the space from). Alternatively, the applicant could have the doctor apply for an MAE license with the applicant as the principal massage therapist.

This is an informal interpretation for informational and explanatory purposes only and is not an official opinion or decision and therefore is not to be viewed as binding on the Board.

7. <u>Unfinished</u> <u>Business</u>: a. <u>Rule Revisions – Title 16, Chapter 84, Hawaii Administrative Rules ("HAR")</u>

EO Kramer noted that the Rules Committee's latest draft was provided to the Board last week.

Vice Chair Davis noted that the Rules Committee has completed proposed language up to Subchapter 4.

DAG Tam reminded the Board that currently the Rules Revisions Investigative Sub-Committee currently consists of Chair Nagashima and Vice Chair Davis, however, Chair Nagashima's term will be ending soon.

After discussion, upon a motion by Ms. Behnken, seconded by Ms. Bath, it was voted on and unanimously carried to dissolve the Rules Revisions Investigative Sub-Committee ("Sub-Committee") and delegating authority to Vice Chair Davis to continue working on the draft.

DAG Tam noted that Vice Chair Davis can consult with Chair Nagashima on the draft once her term is over.

By consensus, this matter was deferred to allow time for the draft to be reviewed by the members.

## 6. New Business: a. Shamanic Visionary Craniosacral Work

The Board reviewed a letter from Mana Jampa asking for written confirmation that he is not required to have a massage therapist ("MAT") license in order to perform "transformational sessions" which include "shamanic visionary craniosacral work". Mr. Jampa states that his sessions combine sensitive handson light touch with the meditative use of intuitive vision and heart-felt presence. There is no rubbing, stroking, tapotement, pressing, shaking, or kneading with the hands, feet, elbows or arms.

After some discussion, upon a motion by Vice Chair Davis, seconded by Ms. Behnken, it was voted on and unanimously carried that based solely on the information provided by Mr. Jampa, it is the Board's informal interpretation that "shamanic visionary craniosacral work" falls within the definition of "massage therapy" under HRS section 452-1 and therefore, this work would require a Hawaii massage therapist license.

This is an informal interpretation for informational and explanatory purposes only and is not an official opinion or decision and therefore is not to be viewed as binding on the Board.

## b. Breast Massage and Draping

The Board reviewed an email from Barbara Heard in which she asks "Does Hawaii have any laws, rules or requirements governing either breast massage and/or draping?"

Vice Chair Davis said that there are currently nothing in the laws and rules regarding breast massage or draping, however, there is language in the proposed rules which address draping.

Ms. Bath said that she has previously performed lymphatic massage on women who have had mastectomies.

Vice Chair Davis noted that he feels that if a client comes in and requests no draping and both the client and the MAT agree, then it is okay.

After some discussion, upon a motion by Ms. Behnken, seconded by Vice Chair Davis, it was voted on and unanimously carried to inform Ms. Heard that the Hawaii laws and rules governing massage therapy do not specifically address breast massage and/or draping, however, as the Board is currently revising their rules, if Ms. Heard has any recommendations or suggestions, she may submit them to the Board for consideration.

c. Cupping

EO Kramer stated that she is also the EO for the Board of Acupuncture and they were asking if cupping is also within the scope of practice of a massage therapist.

Chair Nagashima noted that the technique, which is used to manipulate soft tissue, is common in mainstream practice.

Ms. Behnken noted that Chair Nagashima is only referring to massage therapists using a cup applied to the skin and does not include the use of needles. She stated that massage therapists are not allowed to puncture skin.

After some discussion, upon a motion by Ms. Behnken, seconded by Vice Chair Davis, it was voted on and unanimously carried that based on the information provided, it is the Board's informal interpretation that cupping, in which cups are placed on the skin to create suction, falls within the definition of "massage therapy" under HRS section 452-1 and therefore, can be performed by a Hawaii massage therapist who is properly trained to perform this technique.

This is an informal interpretation for informational and explanatory purposes only and is not an official opinion or decision and therefore is not to be viewed as binding on the Board.

# 9. Applications: a. Ratifications

Upon a motion by Ms. Behnken, seconded by Ms. Bath, it was voted on and unanimously carried to approve the attached ratification list.

Chair Nagashima noted that the Board would be going into Executive Session. She asked Mr. Sioxson if he had any questions or concerns for the Board.

Mr. Sioxson stated that he decided to attend the meeting so he could speak to the Board about his application. He has a conviction in California and has provided a Hawaii criminal abstract and supporting documents but says that he has been notified that the California Penal Code prohibits an individual from giving a copy of their record to an unauthorized third party such as the Board. He asked the Board for advice.

DAG Tam noted that Mr. Sioxson's application was not on the agenda.

Upon a motion by Chair Nagashima, seconded by Vice Chair Davis, it was voted on and unanimously carried to add the following item to the agenda:

At 10:24 a.m., it was moved by Vice Chair Davis, seconded by Ms. Behnken, and unanimously carried to move out of Executive Session.

2) <u>Ruben Sioxon</u>

- A letter from his probation officer that he has successfully completed his probation;
- Letters of support from the community (e.g. employers, teachers, pastors);
- A copy of the letter from California stating that he cannot provide his record to an unauthorized third party;
- A letter from him stating that the California conviction for evading a peace officer is his only conviction.

After discussion, it was moved by Ms. Behnken, seconded by Vice Chair Davis, and unanimously carried to approve the Settlement Agreement.

b. In the Matter of the Massage Therapist License of Sherona K. Cobb-Adams, MAS 2014-47-L, Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order

After discussion, it was moved by Ms. Behnken, seconded by Vice Chair Davis, and unanimously carried to approve the Settlement Agreement.

Following the Board's review, deliberation and decision on this matter, pursuant to Chapter 91, HRS, the Chair announced that the Board was reconvening its scheduled meeting at 10:32 a.m. pursuant to Chapter 92, HRS.
