1. <u>Call to Order</u>: There being a quorum present, Chair Davis called the meeting to order at

9:05 a.m.

Chair Davis asked if there were any comments or concerns regarding the board meeting minutes of the February 1, 2017 meeting.

ry 1, There were none.

February 1, 2017 Meeting:

Upon a motion by Vice Chair Behnken, seconded by Ms. Bath, it was voted on and unanimously carried to approve the minutes of the February 1, 2017 meeting as circulated.

# 4. Executive Officer's Report:

### a. 2017 Legislative Session Update

EO Kramer reported that Senate Bill No. 1286, S.D. 2, H.D. 2, C.D. 1 passed on 4/5/17. She noted that the bill still requires the State Department of Education ("DOE") to license private trade, vocational and technical schools. The bill provides funds to the DOE for one staff position to handle these licenses. The licensing fees will be \$2,000 for the initial license and \$2,000 for each subsequent biennial renewal. The bill also requires that upon request, the Board review a massage school's curriculum and if approved, issue a letter to that effect to be submitted to the DOE with an application for massage school license.

After some discussion, it was the consensus of the Board that any requests to review a massage school's curriculum for purposes of licensure by the DOE as a massage school will be handled on a case-by-case basis and conducted based solely on the documents provided by the requestor.

#### b. Regulated Industries Complaints Office ("RICO") Open House, January 27, 2017

Copies of the materials provided at the Open House were distributed to the Board members.

Chair Davis noted that RICO collects fines for violations. He asked where those fines go.

EO Kramer said she believes RICO uses the funds to support staff with RICO's compliance and enforcement activities.

Chair Davis noted that the Compliance Resolution Fund report states the Professional & Vocational Licensing ("PVL") Division is planning to upgrade their website in the future. He commented that he has had difficulty finding insurance and workers compensation rates for massage therapists.

EO Kramer noted that insurance and workers compensation are not under the purview of the Board, therefore, that information would not be posted on the Board's website.

Vice Chair Behnken stated that Hawaii is a no-fault state so there is no published list of rates and fees available.

Ms. Meehan-Vandike said she believes all professions in Hawaii have the same issues with insurance and workers compensation rates. Each individual decides how much to bill. The individual submits the claim to the insurance company and waits to see if it is accepted.

#### 5. <u>Correspondence</u>: a. <u>Letter from Jeffrey Tidrick regarding Somatic Experiencing ("SE")</u>

The Board reviewed an email from Jeffrey Tidrick requesting clarification on whether Somatic Experiencing ("SE") falls under the definition of massage therapy, and if so, what his ability would be to promote himself as a trauma therapist who uses a combination of talk and touch as a form of trauma resolution. He further asks if he can combine trauma therapy and massage therapy in advertising and practice.

Vice Chair Behnken said she spoke to someone who teaches SE. That person feels that massage therapy and SE are two different practices because SE generally does not involve touch. She expressed concern regarding the following language in Mr. Tidrick's letter: "However, I have read HRS chapter 452 and am not clear if Somatic Experiencing falls under the definition of massage therapy, and if so what my ability would be to promote myself as a trauma therapist who uses a combination of talk and touch as a form of trauma resolution. I am seeking clarity on whether I can combine trauma therapy and massage therapy in advertising and in practice."

Ms. Bath suggested that the Board inform Mr. Tidrick that they only govern the practice of massage therapy and if SE does not involve touch, it would not be considered "massage" as defined in HRS, Chapter 452.

Vice Chair Behnken agreed, noting that massage therapy and trauma therapy are two entirely separate things. The education requirements for massage therapist licensure do not include any trauma therapy training, therefore, she feels the two should not be practiced or advertised together.

By consensus, it is the informal interpretation of the Board that Somatic Experiencing is a technique that does not fall under the scope of practice of a massage therapist. The practice of massage therapy should be kept separate from any other professional practices, including Somatic Experiencing and trauma therapy.

This is an informal interpretation for information and explanatory purposes only and is not an official opinion or decision and therefore is not to be viewed as binding on the Board.

The Board also requested that EO Kramer remind Mr. Tidrick that as a Hawaii licensed massage therapist, he is bound by the laws and rules applicable to massage therapy, including HRS, Chapter 452 and Hawaii Administrative Rules ("HAR") Chapter 16-84.

Board members agreed by consensus that this matter will be deferred to the August meeting pending their review of the current list of exam references, the list of references provided by Hawaii licensed massage schools as well as their own suggestions for additional references to determine if they want to make any changes, whether additions or deletions, to the list.

#### b. Review of Board member roles and duties

Board members discussed the effectiveness of its members and meetings.

DAG Moriarty summed up the discussion with a question each Board member should keep in mind, "Is the Board being protective or is the Board protecting (the public)?".

After discussion, it was moved by Ms. Bath, seconded by Ms. Meehan-Vandike, and unanimously carried to approve the Settlement Agreement.

e. In the Matter of the Massage Therapy License of Susan M.S. Vigil, and the Massage Establishment License of Susan M.S. Vigil (MAS 2016-99-L) — Settlement Prior to Filing of Petition for Disciplinary Action and Board's Final Order

After discussion, it was moved by Ms. Bath, seconded by Vice Chair Behnken, and unanimously carried to approve the Settlement Agreement.

9. <u>Unfinished</u> Business:

a. Rule Revisions – Title 16, Chapter 84, Hawaii Administrative Rules - Subchapter 1 and 2

The Board discussed and agreed with the following definitions, however, the definitions are subject to change pending discussion of the entire proposed draft:

 "Affiliated with" means "a massage therapist or massage therapy apprentice who is an independent contractor or employee of an establishment."

- "Apprentice" means "a person who has been issued a permit by the board to learn the practice of massage therapy under the direct supervision of a sponsoring massage therapist."
- "Anatomy" means "the identification of the gross structures of the human body."
- "Compensation" means "any payment, monetary or otherwise, given in exchange for massage therapy."
- "Current" means no more than 2 years old.
- "Direct supervision" requires a sponsoring massage therapist or instructor to be on premises and physically available, at the massage therapy establishment or classroom where the massage therapy is being performed, in order to control, direct, and instruct the apprentice or student. This requirement shall remain in effect during the entire apprenticeship or student training period.
- "Draping" means "the use of a covering intended to preserve the client's privacy, modesty and warmth, and should be done in a way that is comfortable for and agreeable to both client and massage therapist."
- "Frequency" is determined through the perception of the public that the massage therapy services will be offered on a dependable and regular basis."
- "Instructor" means "a massage therapist who is teaching a workshop and has held a current active massage therapist license for a minimum of three (3) consecutive years in a state that meets or exceeds the education and licensing requirements of the State of Hawaii, or is certified by a nationally recognized professional organization approved by the Board."
- "Lewd and Lascivious" means "any form of sexual conduct, innuendo, impropriety, action, harassment, abuse, gesture, or contact between the client and massage therapist, massage therapist apprentice, or massage therapist student."
- "Kinesiology" means "the study of the principles of mechanics and anatomy in relation to human movement."

- "Massage therapist" means "a person licensed to practice massage therapy."
- "Massage school" or "school" means "an educational institution that
  provides an instructional training program for massage therapy
  students, and is approved or accredited by a government educational
  agency or organization approved by the Board."
- "Off-site massage location" means "a location outside of a licensed massage establishment (e.g. a hotel room, private residence, corporate/office facility, etc.). The location shall practice the same sanitation guidelines as described in Chapter 16XX19(I)\* or in the established Department of Health Sanitation Rules for Massage Establishments."
  - \* The exact citation will be determined after review of the entire proposed draft.
- "Open air venues" means "a location that is portable with no solid walls at which massage therapy services are offered or provided."
- "Out-call" or "out-call massage service" means "massage therapy services that are provided by a licensed massage therapist in a location that has been designated by the client and is not used primarily to provide massage therapy services."
- "Pathology" means "the study of the origin, nature, and symptoms of diseases."
- "Permanent fixed location" means "a location in a structure that is not portable or movable at which massage therapy, massage therapy training, or both, are offered or provided."
- "Person" means "an individual, sole proprietor, partnership, corporation, or limited liability company."
- "Physiology" means "the functions of the anatomical structures of the human body."
- "Practical educational experience" means "the academic knowledge gained under the direct supervision of a sponsor or instructor."

- "Practical hands-on training" means "the physical components of massage therapy gained under the direct supervision of a sponsor or instructor."
- "Premises" means "a permanent fixed location."
- "Principal massage therapist" means "the licensed massage therapist
  designated by a licensed massage therapy establishment as being
  responsible for all massage activities, all massage therapists, and all
  massage therapist apprentices affiliated with the massage
  establishment."
- "Sexual act" means "any type of solicited or unsolicited direct physical contact of a sexual nature at any time during the professional relationship including touching the genitals or anus, touching a female's breasts without permission and therapeutic intent, sexual intercourse of any kind, any behavior or gesture that may be interpreted as inappropriate or sexual, and inappropriate sexual comments about a person."
- "Sponsoring massage therapist" or "sponsor" means "a massage therapist who has held a current active State of Hawaii massage therapy license for at least three consecutive years, is affiliated with a licensed massage therapy establishment, and is registered with the Board as being the person responsible for the direct supervision of an apprentice."
- "Theory of massage" means "the study of the basic principles and procedures of massage therapy techniques."
- "Workshop" means "a course of study that is taken as a pathway leading to an apprentice permit or taken to fulfill deficient hours required to be licensed in Hawaii. Workshop hours taken to fulfill a deficiency must be specific to the lacking deficient content. Workshops shall be approved by the Board."

After some discussion, by consensus, the Board deferred the discussion on Subchapter 2 and add an additional meeting in June or July for the main purpose of discussing the entire proposed draft. Board members were asked to submit their comments on the entire proposed draft to the staff by the end of May.
