Executive Officer's

Report:

Penske clarified that it wanted the Board to approve it CASE certification program as an alternative to ASE certifications. Requesting the Board to waive ASE certifications, if a mechanic applicant is Penske certified, for state licensing. Executive Officer Kramer emphasized that Penske's certification program had to be available to all mechanic applicants, not just Penske employees. Penske, subsequently, withdrew its request.

Chapter 91, HRS, Adjudicatory Matters:

At 1:50 p.m. the Chair called a recess to discuss the following adjudicatory matter, pursuant to Chapter 91, HRS.

In the Matter of the Motor Vehicle Repair Dealer's License of Pacific Power Products Company, dba Pacific Power Products Washington; ARP 2012-16-L. Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order

The Board reviewed this Settlement Agreement. After much discussion, it was moved by Mr. Figaroa, seconded by Mr. Tetsutani, and unanimously carried to approve the Settlement Agreement, in which:

- The Respondent does not admit that it has violated any law or rule, but acknowledges that RICO has sufficient cause to file a Petition for Disciplinary Action against its motor vehicle repair dealer's license.
- 2. The Respondent agrees to pay a fine in the amount of FIVE HUNDRED AND NO/100 DOLLARS (\$500.00), which payment shall be due at the time this fully executed Settlement Agreement is returned to RICO.
- 3. If Respondent fails to fully and timely comply with the terms of this Settlement Agreement, Respondent's license shall be automatically revoked for a period of five (5) years upon RICO's filing of an affidavit with the Board attesting to such failure. In case of such revocation, Respondent shall turn in all indicia of its licensure to the Executive Officer of the Board within ten (10) days after receipt of notice of revocation. Upon completion of the revocation period, Respondent understands that it will need to apply to the Board for a new license pursuant to HRS §§92-17, 436B-21, and all other applicable laws and rules.

Following the Board's review, deliberation and decision in this matter pursuant to Chapter 91, HRS, at 2:15 p.m., the Chair announced that the Board was reconvening its scheduled meeting.
