a. Record of Candidates Examined: For the Examination for

Professional Practice in Psychology (EPPP)

Executive Officer Ferrer reported that there were three (3) candidates who took the EPPP exam as of December 31, 2014; one

(1) passed and two (2) failed.

Members reviewed Senate Bill No. 13, Relating to Psychology.

The purpose of this Act is to recognize American Psychological Association accredited doctoral programs that provide broad and general training in scientific psychology and in the foundations of practice and strive to prepare students for the practice of psychology.

It was relayed that the bill would amend §465-7, Hawaii Revised Statutes, as follows:

- (a) Every applicant for a license as a psychologist shall submit evidence satisfactory to the board that the applicant meets the following requirements:
 - (1) The applicant for licensure shall possess a doctoral degree from:
 - (A) An American Psychological Association approved program in clinical psychology [;], counseling psychology, school psychology, or programs offering combinations of two or more of these areas;

Executive Officer Ferrer informed members that Senator Rosalyn Baker, Chairperson, Commerce and Consumer Protection, introduced Senate Bill No. 13, Relating to Psychology on January 22, 2015.

Executive Officer Ferrer reported that she and Executive Officer Quiogue met with Representative Justin Woodson, Vice-Chairman, Committee of Consumer Protection & Commerce, regarding the proposed legislation. She went on to say that Representative Woodson will be introducing the proposed legislation on behalf of the House of Representatives.

Old Business:

a. <u>Proposed amendments to Hawaii Administrative Rules</u>
<u>Chapter 98</u>

Members reviewed proposed amendments to Hawaii Administrative Rules Chapter 98 ("HAR").

After discussion, it was determined that HAR § 16-98-9(b)(1-3), should be amended to reflect:

(b) The [graduate level training] <u>doctoral degree</u> program shall require each student to demonstrate competence in each of the subject areas set forth in this section. This shall be met by including a minimum of three graduate semester hours (or the equivalent in graduate quarter <u>or trimester</u> hours) <u>from a single, three semester or trimester credit hour core course or</u>

from one, four quarter hour core course, in each of the following subject areas:

- (1) [Scientific and] Professional ethics and standards;
- [(2) History and systems;
- (3)](2) Research design and methodology; and
- (3) Statistics and psychometrics.

After discussion, it was determined that HAR § 16-98-9(c)(4), should be amended to reflect:

- (c) The [core training] <u>doctoral degree</u> program shall require each student to demonstrate competence in each of the [substantive] content areas set forth in this subsection. This shall be met by including a minimum of six graduate semester hours (or the equivalent in graduate quarter <u>or trimester</u> hours) <u>from two, three semester credit hour core courses or from two, four quarter hour core courses,</u> in each of the following [substantive] content areas:
 - (4) Individual differences; personality theory, human development, [and] abnormal psychology[;], and cultural and individual diversity[;]. Courses consisting of general courses on history and systems in psychology and personality assessment, shall not satisfy the requirements of this subsection;

New Business:

Members discussed adopting the American Psychological Association's Ethical Principles of Psychologists and Code of Conduct ("APA Ethics Code") when considering ethical issues such as multiple relationships that may be brought to the Board's attention.

Currently, the Board's proposed amendment to HAR § 16-98-34 reflects:

<u>Unethical practice of psychology.</u> "Unethical practice of psychology" means [willful disregard for any or all of the matters covered in this section] any conduct or practice contrary to the APA Ethical Principles of <u>Psychologists and Code of Conduct</u>.

After discussion, it was moved by Dr. Peter, seconded by Mr. Oliphant, and unanimously carried to incorporate the APA Ethics Code into HAR § 16-98-34.
