## The following agenda item was taken out of order.

Legislation: a. House Bill No. 1072, H.D. 1 Relating to Prescriptive Authority for Certain <u>Psychologists</u>

This measure authorizes the board of psychology to issue certificates of prescriptive authority to medical psychologists who meet certain education,

training, and registration requirements.

The House Committee on Finance held a decision making hearing on March 3, 2015 and recommended that the measure be passed unamended.

The measure crossed over to the Senate on March 12, 2015 and referred to the Senate Committees on Health/Judiciary and Labor, and Commerce and Consumer Protection.

Members discussed drafting amendments to House Bill No. 1072, H.D. 1. Discussion followed. The following was the consensus of the Board:

- Amend the term "Drug" to "Psychotropic medication," which shall include controlled substances except narcotics; provided further that the term psychotropic medication shall be limited to only those agents related to the diagnosis and treatment of mental and emotional disorders pursuant to the practice of psychology, as that term is defined in section 465-1.
- Amend all references to the term "medical psychologist" to "prescribing psychologist."
- Amend all references to "primary care physician" and "attending physician" to "physician of record."
- Add the definition of "Physician of Record" to mean a physician licensed in the state pursuant to chapter 453, Hawaii Revised Statutes.
- Page 8 line 3 (c) to read as follows:

Every applicant for a prescriptive authority privilege shall be considered qualified if they have met the requirements of HRS §465-7, and have met the requirements for the prescriptive authority privilege of HRS §465-**Prescriptive authority privilege; requirements.** 

- Page 9 delete lines 7–21.
- Page 10 (3) be amended to (2)
- Page 10 section (B) to read as follows:

"Clinical experience within no less than 12 months and no more than 48 months, and includes the supervision of a minimum of 100 patients. Such experience shall include no less than 2 hours per week of supervision by a licensed physician."

• Page 10 delete lines 17–21.

- Page 11 delete lines 1–17.
- Page 11, line 18 (4) be amended to (3)
- Page 11, line 18 to read as follows:
  - (4) "The applicant has successfully **passed** the ..."
- Page 12, line 21 to Page 13, lines 1–2 to read as follows:

"has completed at least **<u>eighteen hours</u>** within every licensing biennium of acceptable continuing education, as determined by the Board for the purposes of this section, relevant to the pharmacological treatment of mental and emotional disorders."

• Page 13, add (d) to read as follows:

"The board may conduct random audits of licensees to determine compliance with the continuing education requirement. The board shall provide written notice of an audit to a licensee randomly selected for audit. Within sixty days of notification, the licensee shall provide the board with documentation verifying compliance with the continuing education requirement established by this section."

• Page 14, lines 11–12 to read as follows:

(d) A prescribing psychologist shall not prescribe for any patient who does not have a physician of record.

• On page 15, delete lines 3–14.

Executive Officer Ferrer would consult with the Board of Pharmacy's Executive Officer to determine if the Board must provide: an annual list of prescribing psychologists holding valid certificates of prescriptive authority; the names of any prescribing psychologists who are added or deleted from the list; and notification in a timely manner of the revocation, suspension, or reinstatement of any certificate of prescriptive authority.

These measures expand doctoral degree requirements for licensing of psychologists to include additional doctoral programs accredited by the American Psychological Association.

<u>Correspondence</u>: a. <u>E-mail dated January 30, 2015 from Rachel Stankowski, PhD,</u> regarding research via telemedicine in Hawaii

Members reviewed an email dated January 30, 2015 from Rachel Stankowski, PhD, regarding research via telemedicine in Hawaii.

The Board informally opined that anyone engaged in telehealth medicine as it relates to the practice of psychology, as defined by Hawaii Revised Statutes ("HRS") § 465-1, is required to have a license in the state of Hawaii. HRS § 465-1, defines the practice of psychology as:

"the observation, description, evaluation, interpretation, or modification of human behavior by the application of psychological principles, methods, or procedures, for the purpose of preventing or eliminating symptomatic, maladaptive, or undesired behavior and of enhancing interpersonal relationships, work and life adjustment, personal effectiveness, behavioral health, and mental health. The practice of psychology includes, but is not

limited to, psychological testing and the evaluation or assessment of personal characteristics, such as intelligence, personality, abilities, interests, aptitudes, and neuropsychological functioning; counseling, psychoanalysis, psychotherapy, hypnosis, biofeedback, and behavior analysis and therapy; diagnosis and treatment of mental and emotional disorder or disability, alcoholism and substance abuse, and disorders of habit or conduct, as well as of the psychological aspects of physical illness, accident, injury, or disability; and psychoeducational evaluation, therapy, remediation, and consultation. Psychological services may be rendered to individuals, families, groups, organizations, institutions, and the public. The practice of psychology shall be construed within the meaning of this definition without regard to whether payment is received for services rendered."

The Board stated that as an alternative to becoming licensed in Hawaii, the psychologist licensed in the state of Wisconsin who would be engaged in the second intervention arm could provide telehealth services under the direction of a Hawaii licensed psychologist. Pursuant to HRS §465-3(a)(2), "Any person who performs any, or any combination of the professional services defined as the practice of psychology under the direction of a licensed psychologist in accordance with rules adopted by the board; provided that the person may use the term "psychological assistant", but shall not identify the person's self as a psychologist or imply that the person is licensed to practice psychology".

The Board advised that in accordance with Hawaii Administrative Rules § 16-201-90, the above interpretation is for informational and explanatory purposes only. It is not an official opinion or decision, and therefore is not to be viewed as binding on the Board or the Department of Commerce and Consumer Affairs.
