It was moved by Dr. Sutherland-Choy, seconded by Dr. Hashimoto, and unanimously carried to approve the applications of Drs. Wihera, Nolan, Roberts, Forrest and Moonshine.

The Board deferred the application of Dr. Phillips pursuant to HRS § 465-7.

Legislation: a. <u>HB 241/SB 224, Relating to Psychology</u>– Establishes licensure and registration requirements for school psychologists to be administered by the board of psychology. Amends the composition of the board to include two school psychologists.

> DAG Moriarty informed the Board that HB 241 has not been referred to its final committee and therefore, will not be moving forward. SB 224, however, was referred to its final committee and will be moving forward.

> Dr. Loker from the HASP introduced himself to the Board and staff and indicated that he was in attendance to address any questions the Board may have with regard to the bill.

Executive Officer Ferrer informed the Board that there was a hearing with the Senate Committee on Education on February 10, 2017. The measure was passed with amendments in the form of a S.D. 1., which was provided to members for review in advance of the meeting.

Dr. Oliveira Gray noted that SB 224 should include the exemptions that were in House Bill 1937, H.D. 2 from the previous legislative session.

The executive officer stated that the Board had reviewed similar proposals during the previous legislative session and supported the intent; however, those measures proposed a new chapter for the regulation of school psychologists. She added that during the last session, the Board had recommended continuing education as a part of the licensing framework.

After discussion, the Board expressed its support of the intent of the regulation of school psychologists under a separate licensing area, and indicated that if the bill was to move forward as proposed under the Board, then the measure should address continuing education requirements; exemptions; code of ethics; and enforcement provisions.

Dr. Loker left the meeting at 2:35 p.m.

### The following agenda items were taken out of order:

Legislation: c. <u>HB 916/HB 916, HD1/SB 1078, Relating to Loan Repayment for</u> <u>Health Care Professionals – Makes an appropriation for the health</u> <u>care professionals loan repayment program administered through</u> the John A. Burns School of Medicine. (HB 916 HD1)

> HB 916, HD1 was referred to the House Committee on Higher Education. There was a hearing on February 16, 2017. It passed the Committee unamended and was referred to the House Committee on Finance.

SB 1078 – There was a hearing on February 7, 2017 with the Senate Committees on Commerce, Consumer Protection, and Health, and Higher Education. Both Committees passed the measure with amendments and the measure was referred to the Senate Committee on Ways and Means.

The Board felt it was not necessary to take a position on these measures.

> d. <u>SB 184, Relating to Health – Provides an income tax credit to</u> <u>primary health care providers that recruit and employ licensed</u> <u>nurse practitioners, physician assistants, and psychologists to</u> <u>provide primary health care services.</u>

> > The Board felt it was not necessary to take a position on this measure.

- e. <u>SB 191, Relating to Health Care Practitioner Transparency –</u> <u>Requires advertisements for health care services that name a</u> <u>health care practitioner to identify the type of license held by the</u> <u>health care practitioner and be free of deceptive and misleading</u> <u>information. Requires health care practitioners to conspicuously</u> <u>post and affirmatively communicate the practitioner's specific</u> <u>license and related information.</u>
- f. <u>SB 726, Relating to Health Care Practitioners Requires health</u> <u>care providers to conspicuously post and communicate their</u> <u>specific type of licensure in their offices, communicate that</u> <u>information to patients in their practices, and include that</u> <u>information in their advertising. Imposes penalties for licensed</u> <u>health care providers who include deceptive or misleading</u> <u>information about their qualifications in their advertising, or</u> <u>misrepresent their qualifications to patients.</u>

A hearing with the Senate Committee on Commerce, Consumer Protection, and Health is scheduled for February 22, 2017.

g. <u>SB 738, Relating to Health Care Practitioners – Requires specified</u> <u>health care practitioners to disclose to patients the practitioner's</u> <u>name, license, highest level of academic degree, and board</u> <u>certification, where applicable.</u>

The Board felt it was not necessary to take a position on SB 191, SB 726 and SB 738 as the Board's statutes and rules sufficiently address the elements of those measures.

h. <u>HB 800, Relating to Minors – Prohibits persons licensed to provide</u> professional counseling from engaging in, attempting to engage in, or advertising sexual orientation change efforts on persons under eighteen years of age.

	i.	HB 1266/SB 270, Relating to Minors – Prohibits persons licensed to provide professional counseling from engaging in, attempting to engage in, or advertising sexual orientation change efforts on persons under 18 years of age.
		The Board stated that, at its meeting on January 23, 2015, the Board voted unanimously to incorporate the American Psychological Association's Ethical Principles of Psychologists and Code of Conduct ("APA Ethics Code") into section 16-98-34, Hawaii Administrative Rules ("HAR").
		The Board made clear its commitment to the APA Ethics Code and expressed its support of HB 800, HB 1266, and SB 270.
	j.	HB 1484, relating to Assault – Establishes that an offense is assault in the second degree if a person intentionally or knowingly causes bodily injury to a health care or human services professional. Defines health care or human services professional.
		There was a hearing with the House Committee on Health on February 14, 2017. The measure passed with amendments in the form of a HD 1 and referred to the House Committee on Judiciary.
		The Board expressed its desire to testify in support of this measure.

Legislation:	b.	HB 767/HB 767, HD1/SB 384, Relating to Prescriptive Authority for Certain Psychologists – Authorizes and establishes procedures and criteria for prescriptive authority for clinical psychologists who meet specific education, training, and registration requirements. Requires the Board of Psychology to report to the Legislature prior to the Regular Session of 2021. (HB 767 HD1)
		HB 767 was scheduled for decision making by the House Committee on Health on February 9, 2017. The measure passed with amendments in the form of a HD 1 and referred to the House Committee on Consumer Protection & Commerce. The measure was later re-referred to the House Committees on Health and Finance.
		SB 384 was scheduled for a hearing with the Senate Committee on Commerce, Consumer Protection, and Health. The measure was passed with amendments in the form of a SD 1 and referred

		to the Senate Committees on Judiciary and Labor, and Ways and Means.		
		Dr. Smith introduced himself. He had coordinated psychopharmacology training for students at the University of Hawaii at Hilo for more than 10 years.		
		Dr. Smith noted that as the bills are currently written, there are concerns regarding the duration, content and quality of the training. He raised the question of whether continuity of care would become an issue upon change in insurance and indicated that issues may come before the Board if collaboration elements are not met.

	The meeting reconvened at 8:37 a.m.			

Legislation: b. HB 767/HB 767, HD1/SB 384, Relating to Prescriptive Authority for Certain Psychologists – Authorizes and establishes procedures and criteria for prescriptive authority for clinical psychologists who meet specific education, training, and registration requirements. Requires the Board of Psychology to report to the Legislature prior to the Regular Session of 2021. (HB 767 HD1) Executive Officer Ferrer summarized the measures. Focusing first on HB 767, HD1, Dr. Sutherland-Choy noted that she found the language in the Illinois Act favorable and expressed the importance of clinical rotations. She suggested that the bill would be strengthened if language regarding rotations was added. Dr. Oliveira Gray said that it would be difficult to put together specific rotations as the training programs are already established. Dr. Adam-Terem indicated that there needs to be a balance between what is ideal and what is realistic, particularly for rural areas. The Board expressed its support of HB 767, HD 1 with the following amendments: - Supervision of 100 patients should include vulnerable populations, including pediatrics, geriatrics, and pregnant women. - Modify the language on page 11, lines 11 – 16 as follows: "The applicant has successfully passed . . . American Psychological Association's Practice Organization's College of Professional Psychology, or other authority relevant to establish . . ." - Include in the 800 hours of training experience a minimum of 8 weeks of rotation in each of the following areas: 1) internal medicine/family medicine; 2) women's health; 3) pediatrics; and 4) geriatrics. - Delayed implementation date to July 1, 2020 to allow for the development of forms and fees, implementation procedures to review the education and training credentials

of an applicant for prescriptive authority and determining the

exclusionary formulary. The Board expressed its support of SB 384, SD 1, noting that the measure should reflect the same amendments as proposed by the Board for HB 767, HD 1, including language regarding vulnerable populations; clarifying that the national psychopharmacology exam may be administered by the American Psychological Association's Practice Organization's College of Professional Psychology or other authority; addressing the minimum requirements for clinical rotations; and delaying the implementation date. The Board further acknowledged that SB 384, SD 1 proposed a minimum of 400 hours of clinical experience, which the Board believed should be increased to a minimum of 800 hours as proposed in the house bill. There being no further business to discuss, it was moved by Adjournment: Dr. Hashimoto, seconded by Ms. Chun-Fat, and unanimously carried to

adjourn the meeting at 10:17 a.m.
