Call to Order:	There being a quorum present, the meeting was called to order by Chairperson Adam-Terem at 1:30 p.m.
Approval of the Meeting Minutes:	It was moved by Dr. Sutherland-Choy, seconded by Mr. Oliphant, and unanimously carried to approve the minutes of the April 21, 2017 meeting as circulated.
	Executive Officer Ferrer suggested a correction to the January 20, 2017 open session minutes on page 5 under d. Applicant for License Reactivation, last paragraph, line 4, should read as follows: "465-13(a)(19). The motion carried with none voting no. "
	It was moved by Mr. Oliphant, seconded by Ms. Chun Fat, and unanimously carried to approve the open session minutes of the January 20, 2017 with the correction as stated above.

<u>Chairperson's</u> <u>Report</u> :	a.	The Association of State and Provincial Psychology Boards (ASPPB) 2017 Mid-year Meeting, April 27 – 30, 2017, Memphis, TN
		Chairperson Adam-Terem briefed the Board on the ASPPB meeting she attended in Memphis, TN on behalf of the Board. She stated that it was a very good meeting, which included discussions about the EPPP and the Psychology Interjurisdictional Compact (PSYPACT).
		There were discussions on where would they put the EPPP1 (i.e., during the postdoc year, during the internship year, or right after graduation). They noted the pass rate varies greatly by school, from 13% - 99%. The schools with the 13% pass rate have very alternative structures.
		Chairperson Adam-Terem shared that PSYPACT, which is an interstate compact, would allow for practice across state lines. She noted that ASPPB is hoping for standardization to facilitate mobility while allowing each state to have jurisdiction.
	b.	Examination for Professional Practice in Psychology (EPPP) Step 2
		Chairperson Adam-Terem stated that this exam will be computer- based. It will be like a vignette. Test items are being developed and are based on a study of individuals in practice. The EPPP is viewed as a foundational knowledge of the profession. If they are going to go out and practice then there should be a clinical test to see if you can do it. That is the purpose of the EPPP Step 2. It is anticipated the EPPP Step 2 will be rolled out in 2019. They are working with Pearson View.
