1. Call to Order: There being a guorum present, Chair Shimabukuro called the meeting to order at

9:07 a.m.

Board Meeting Minutes of the

Chair Shimabukuro asked if there were any comments or concerns regarding the board meeting minutes of the January 10, 2017 meeting.

January 10, DAG Tam requested the last sentence on page 3 be corrected to read

2017 Meeting: (underlined material added, while bracketed material is to be deleted) "DAG Tam

stated that the Board could change the criteria by policy, however, he

recommends placing language in the rules eventually.[and that a]An RFP is not

required.

Upon a motion by Ms. Wakabayashi, seconded by Ms. Kubota, it was voted on and unanimously carried to approve the minutes of the January 10, 2017 meeting as amended.

Executive Officer's Report:

a. License Renewal - Update

EO Taniguchi reminded the Board that all PT licensees who renewed at the "active" status signed an attestation that they completed their required continued competence ("CC") units. The Board determined that they would do an audit of those licensees which is now in progress. Some states do a 100% audit and require all licensees to submit their documents electronically to the FSBPT's aPTitude service.

Ms. Wakabayashi asked what kind of penalty the licensee would be assessed.

EO Taniguchi said based on other professions, the first violation is a fine.

Mr. Turner asked if the licensee would still be required to provide proof of compliance with the CC requirement.

EO Taniguchi said yes, any audited licensee would still have to comply. If the licensee did not complete their CC requirement, they should not have renewed their license at "active" status and therefore, should not be practicing in Hawaii.

5. Old Business:

a. Requirements for Ethics, Laws and Rules Courses

EO Taniguchi noted that the Board previously expressed concern about the quality of some of the ethics, laws and rules courses previously approved by the Board. At the last meeting, the Board deferred discussion on this matter. Board members were asked to come up with topics they would like required in ethics, laws and rules courses. Ms. Kubota provided a list of topics for review.

After some discussion, upon a motion by Ms. Kubota, seconded by Vice Chair lopa, it was voted on and unanimously carried to that all courses must be based on the amended list of topics from Hawaii Administrative Rules Chapter 110, HRS Chapter 461J and HRS Chapter 436B and must require the licensee obtain a passing score of 80% on an exam consisting of a minimum of 25 questions on those topics. The Board delegated to EO Taniguchi the task of coming up with guidelines for course approval for ethics, laws, and rules (jurisprudence) by the Board.

6. New Business:

a. <u>Federation of State Boards of Physical Therapy ("FSBPT") 2017 Annual Meeting, November 2-4, 2017, Santa Ana Pueblo, New Mexico</u>

EO Taniguchi stated that the FSBPT will fund three people to represent the board at their annual meeting – a voting delegate, a primary alternate delegate and an administrator. He asked who would be interested in attending the conference.

Ms. Kubota stated that as a member of the FSBPT's education committee, her attendance is already funded by the FSBPT.

After some discussion, upon a motion by Vice Chair lopa, seconded by Ms. Kubota, it was voted on and unanimously carried to approve the following individuals to represent the Board at the FSBPT 2017 Annual Meeting: 1) EO Taniguchi as the Administrator; 2) Ms. Wakabayashi as the voting delegate; and 3) Chair Shimabukuro as the non-voting delegate.

b. FSBPT 2017 Leadership Issues Forum, July 29-30, 2017, Alexandria, Virginia

EO Taniguchi stated that voting delegate for the Annual Meeting is expected to attend the Leadership Issues Forum ("LIF"). The LIF provides an overview of topics and projects that are currently on the "front burner" for the FSBPT.

After some discussion, upon a motion by Chair Shimabukuro, seconded by Mr. Turner, it was voted on and unanimously carried to approve Ms. Wakabayashi to attend the FSBPT 2017 Leadership Issues Forum.

c. <u>Inquiry from Gerlie Matahum regarding whether becoming a BLS instructor is considered a teaching activity for continuing education</u>

The Board reviewed an email from Ms. Matahum which asks if becoming a BLS instructor would be considered a teaching activity for continuing education.

After some discussion, it was the consensus of the Board to defer this matter and directed EO Taniguchi to request that Ms. Matahum provide more information regarding what she is requesting, specifically, what exactly she is requesting (i.e. whether she is asking if she can receive CC units ("CCUs") for the training to become a BLS instructor or if she is requesting CCUs for teaching the BLS course), more information regarding the course including course content and length, and the number of CCUs she is requesting.

8. Continuing Education Audit Reviews:

a. Discussion regarding late submissions by audited licensees

EO Taniguchi noted that HRS §461J-10.15(d) requires that each licensee provide copies of their CC documentation to the board or its designee within fourteen calendar days after being requested to provide such documentation. He asked the Board what they wanted to do for those who do not comply within fourteen calendar days.

After some discussion, it was the consensus of the Board that all licensees who do not comply within fourteen calendar days be referred to the Regulated Industries Complaints Office ("RICO").

b. Discussion regarding non-compliance by audited licensees

After some discussion, it was the consensus of the Board that any licensees who either notify the Board that they did not meet the CC requirement at the time of renewal or do not respond to the Board's audit notification be referred to RICO.

Chair Shimabukuro asked what would happen after the licensee is referred to RICO and if the licensee would be required to submit proof of completing their required CC units to RICO.

EO Taniguchi said that he is not sure. If the Board would like, he can invite a member of the RICO staff to address the Board at the meeting.

By consensus, the Board asked EO Taniguchi to request that a RICO staff member attend their next meeting to discuss RICO referrals for CC violations.

c. <u>Email from Virginia Zarsadias regarding non-compliance with continuing</u> competence audit

The Board reviewed an email from Ms. Zarsadias in which she states "I am writing in response to the letter I received asking that I send in documentation of continuing competence. I am not able to do so." Ms. Zarsadias goes on to explain that she has not worked as a PT in Hawaii since 2011 but kept her license at the "active" status. She states that when the time of renewal came, she made several attempts to call the office but was not able to make contact with anyone so she went ahead and renewed her license online on December 31, 2016 at the "active" status, hoping to change her status to "inactive" after the deadline as she had no intention to work in Hawaii as a PT this year. She was afraid that if she allowed her license to lapse, she would have to do something drastic like take the board exam all over again.

EO Taniguchi noted that the online renewal included a certification which stated "By submitting this renewal, unless I am requesting an exemption or my license is on "inactive" status, I certify that I have met the CC requirement as contained in § 461J-10.1, HRS." He informed the Board that HRS §461J-10.14(a) requires an exemption request to be submitted prior to the expiration of the renewal period. No exemption request was received from Ms. Zarsadias prior to 12/31/16, nor was her license on "inactive" status at the time of renewal.

After some discussion, upon a motion by Vice Chair lopa, seconded by Ms. Wakabayashi, it was voted on and unanimously carried to submit a RICO referral for Ms. Zarsadias for renewing her license at "active" status without completing the CC requirement.

d. Review of Continuing Competence Documents submitted by Audited Licenses

Vice Chair lopa noted that some of the audits she reviewed included courses in dry needling. She asked for confirmation that the Board cannot approve courses in dry needling.

EO Taniguchi reminded the Board that they previously determined that courses relating to the dry needling technique would not be accepted towards the continued competence requirement as their scope of practice does not allow for dry needling, pursuant to § 461J-2.5, HRS.

DAG Tam noted that the Board regulates the scope of practice of PTs in Hawaii, therefore, all courses for renewal of a Hawaii PT license must be in subjects related to the practice of PT in Hawaii. This would include dry needling.

After some discussion, it was the consensus of the Board that all continuing competence courses for renewal of a Hawaii physical therapist license must be in subjects related to the practice of a physical therapist in Hawaii, therefore, courses outside of the scope of practice of a Hawaii physical therapist will not be accepted.

Upon a motion by Ms. Wakabayashi, seconded by Ms. Kubota, it was voted on and unanimously carried to accept the audit documents submitted by the following licensees:
