# 4. Executive Officer's Report:

#### a. License Renewal – Update

EO Taniguchi reported of the 80 licensees audited, 61 have completed the audit. 15 licensees are still submitting additional documents requested and four licensees either did not respond to the original request or did not complete the continuing competence requirement. Those four licensees have been referred to RICO.

He also reminded the Board members to file their annual Disclosure of Financial Interests with the Hawaii State Ethics Commission ("Commission") by Wednesday, May 31, 2017. The Commission is encouraging everyone to file early.

#### 5. Old Business:

#### a. Requirements for Ethics, Laws and Rules Courses

EO Taniguchi reported that Deputy Attorney General Rodney Tam ("DAG Tam") drafted an "Ethics, Laws, and Rules (Jurisprudence) Course Content Outline" ("Outline") based on the discussion at the Board's March meeting. He noted that the Outline did not include a minimum amount of questions or a passing score percentage which was also discussed. He asked if the Board wanted to add those items to the Outline.

After some discussion, upon a motion by Ms. Kubota, seconded by Ms. Wakabayashi, it was voted on and unanimously carried to approve DAG Tam's "Ethics, Laws, and Rules (Jurisprudence) Course Content Outline" with the additional requirements that all course participants are required to receive an 80% or better score on an examination which consists of a minimum of 25 questions. All course providers requesting approval for any ethics, laws, and rules (jurisprudence) course must submit a written request to the Board with the required course information, including all exam questions and answers, to the Board for review.

#### 6. New Business:

a. <u>Discussion with Daria A. Loy-Goto, Complaints and Enforcement Officer, Regulated Industries Complaints Office ("RICO") regarding non-compliance with the continuing competency requirement</u>

Ms. Loy-Goto thanked the Board for inviting her to attend the meeting. She provided copies of the materials that were recently distributed to Board members at the recent RICO open house and gave a brief overview on the functions and duties of RICO. She noted that in general, compared to other professions, physical therapy does not have much disciplinary action. With regards to the new continued competency ("CC") requirement, she noted this first time will be a learning experience for both RICO and the Board. She stated that in addition to those licensees who are audited, the Board may have

some licensees who did not renew on-time due to not completing the CC requirement and will need to restore their license. She said if the licensee restores their license, RICO will check the licensee's record to make sure that they were not practicing during their lapse in licensure.

Mr. Turner asked how that is accomplished.

Ms. Loy-Goto said that RICO has worked hard to develop and maintain good relationships with law enforcement agencies, insurance providers and government offices such as Homeland Security, Medicare and Medicaid. Typically, for a health care provider such as a physical therapist, they will work with those agencies. She noted that for CC violations, for the most part, RICO will look at revocation as one of the last options.

EO Taniguchi asked how RICO finds the licensee if they are no longer at the address of record.

Ms. Loy-Goto noted that it is a question of resources. RICO will try the best they can to contact everyone. She stated there were very few instances where RICO could not find someone.

Mr. Turner asked if RICO takes anonymous tips and complaints.

Ms. Loy-Goto said yes, however, in the past they did not. She also feels the public as well as those in the same profession are becoming more aware of how to file complaints regarding issues/problems they have encountered. She noted that RICO may not be able to do as much with anonymous complaints but they are still important.

#### b. Continued Competence ("CC") Audit Review

1) Discussion on Audit Review Procedures by Board Members

Chair Shimabukuro reported during the audit, a licensee submitted a certificate for a course which was not approved by the Board. The certificate did not indicate approval by any other state or authority approved by the Board. He noted it was clear by the course title that it would fall under professional practice of physical therapy, however, the required information was not on the certificate, therefore, the licensee was sent a deficiency requesting course approval information. As he knows this licensee, the licensee called him to question why he was asked for this information when other colleagues who had been audited had the course accepted.

The secretary noted that this course actually was approved by the Board, however, the certificate did not include the index number, nor did the course title or provider match what was originally submitted and approved, therefore, there was no way any reviewers could have known the course was previously approved by the Board.

By consensus, the Board agreed that for all courses approved by the Board, the certificate of completion must include at minimum the Hawaii index number, course title, sponsor's name and the number of CC units awarded.

 Discussion on CC Courses – Professional Practice and Patient/Client Management Topics

EO Taniguchi noted that this matter was added to the agenda as the Board received feedback from members about reviewing audit documents for courses they were unsure would fall under either "professional practice" or "patient/client management".

Mr. Turner noted that one of his audits included a course titled "Basic Spanish Grammar and Vocabulary for Physical Therapy Evaluation and Treatment". As it is a foreign language course, though it is geared specifically towards PTs and PTAs, he was not sure if this could be counted.

After some discussion, it was the consensus of the Board that if the course is specifically geared towards physical therapists and their professional practice, the course would generally be accepted if it is either approved by the Board or an organization/jurisdiction approved by the Board.
