

REQUIREMENTS FOR LICENSURE -- VETERINARIAN

REQUIREMENTS

1. Fulfill the education requirements as described below; **AND**
2. Pass the National Board of Veterinary Medical Examiners (NBVME) examination (currently the North American Veterinary Licensing examination (NAVLE)); **AND**
3. Pass the State of Hawaii Board of Veterinary Examiners licensing examination.

EDUCATION

You must be a graduate of a veterinary college accredited by the American Veterinary Medical Association (AVMA). However, you will be allowed to take the NAVLE if you are expected to graduate within 6 months from an AVMA accredited veterinary college, upon submittal of written verification from an official of the college.

(NOTE: You must graduate before being able to take the Board licensing exam.)

FOREIGN EDUCATION

Graduates of foreign veterinary colleges must have their foreign education evaluated by the AVMA if they wish to have their college degree(s) considered and accepted by the Board. For this evaluation, contact the AVMA Educational Commission for Foreign Veterinary Graduates (ECFVG) at:

NATIONAL (NBVME) EXAMINATION

Currently, the National (NBVME) examination is the North American Veterinary Licensing Examination (NAVLE), which is a computer-based examination scheduled twice a year with testing windows usually in April and November-December. **The NAVLE is administered only on Oahu.** The filing deadline is 104 days prior to the first test day of the selected testing window.

If you have not passed the NAVLE, we will notify the NBVME of your eligibility to take the examination **upon the Board's approval of your license application**. Once approved, we will send you a Candidate Information Packet. In addition, candidate information can be downloaded from the NBVME website at: www.nbvme.org/information.html.

Once you have been deemed eligible to take the NAVLE, you will need to contact the NBVME to register for the examination at:

Note: Even if you register to take the NAVLE and submit payment to the NBVME, you will not be allowed to take the examination until the Board has determined that you are eligible to do so.

APPLICANTS FOR HAWAII LICENSURE VIA ENDORSEMENT of an out-of-state veterinarian license:

In addition to the above, you must verify your license(s). You must **send** the "Verification of License" form (VET-04) to all of the states in which you have held a license within the last 10 years. This verification should be sent back **directly** to the Board. Please note that some states charge a fee for this service. The "Verification of License" form may be photocopied if additional copies are needed.

If the Clinical Competency Test (CCT) was not required at the time you were licensed out-of-State, the Board requires:

1. A statement or your resume with your experience in the practice of veterinary medicine; **AND**
2. Notarized statements from at least two veterinary colleagues attesting to your veterinary experience.

STATE OF HAWAII BOARD OF VETERINARY EXAMINERS LICENSING EXAMINATION (the "state boards"):

1. Offered monthly on Oahu only.
2. If you do not pass the examination, you must wait **3 months before retesting**.
3. **The filing deadline is 60 days prior to the examination date you are requesting;**
4. The examination fee is \$30 (payable to Commerce & Consumer Affairs);
5. If you need to postpone or withdraw from the examination, you must provide written notice to the Board at least **4 weeks** prior to the examination date, otherwise your \$30 fee will be forfeited;
6. To obtain a list of study reference materials, please call the DCCA Examination Branch at (808) 586-2711;
7. If you require special accommodations to take the examination, please contact the DCCA Examination Branch at (808) 586-2711, no later than the examination filing deadline, (60 days prior to the examination date), to obtain a Disability Certification Form that will need to complete and return to the Board. No action will be taken to provide special testing accommodations until your license application is completed and you are approved to take the examination.

NOTE: You must graduate before being able to take the Board licensing exam.

TEMPORARY PERMITS

A temporary permit allows you to work for a maximum of 11 months under the supervision of a veterinarian licensed to practice in Hawaii until you pass the State of Hawaii Board of Veterinary Examiners licensing examination. You must have filed all required documents, paid all applicable fees, and you must provide to the Board a letter of verification of employment with the supervising Hawaii veterinarian. Please refer to Hawaii Administrative Rules §§16-101-29.1 and 16-101-30 for more details on these conditions.

LICENSE FEES

\$460 If your license is issued between July 1 of even-numbered years and June 30 of odd-numbered years.
\$280 If your license is issued between July 1 of odd-numbered years and June 30 of even-numbered years.

WHAT NEEDS TO BE COMPLETED AND SUBMITTED TO THE BOARD

1. Complete and sign the application (VET-01);
2. **Attach the non-refundable application fee of \$100 (made payable to Commerce & Consumer Affairs);**
3. Provide an official or certified copy of your diploma or an original or certified* transcript from an AVMA-accredited veterinary school or college;
4. If you graduated from a foreign veterinary college, provide a photocopy of your diploma (with an original or certified* English translation if the diploma is not in English) **and** an original or certified* copy of the AVMA ECFVG educational credential evaluation;
5. If you expect to graduate within 6 months of the National (NBVME) exam you select to take, you must provide written verification from your veterinary school or college of your expected graduation;
6. If the CCT was not required at the time you obtained your out-of-State veterinary license, you must provide:
 - a. A statement or resume with your experience in the practice of veterinary medicine; **AND**
 - b. Notarized statements from at least two veterinary colleagues attesting to your veterinary experience.
7. Verification of your NBVME examination scores from VIVA (if applicable);
8. "Verification of License" form from any states licensed (if applicable);

* A certified document is one that has been officially determined, by an appropriate authority, to be true, certain, valid, and authentic. A certified copy has been authenticated by an appropriate authority to be a true and correct copy of the original.

Complete the attached application form (VET-01) using a typewriter or printing legibly in black or dark-colored ink. Answer all questions, provide explanations and supporting documents when required, sign, and date the application form. **If your application lacks the required documentation for the examination or for licensure, it will not be considered or reviewed by the Board.** It is the applicant's responsibility to ensure that all documents are received.

SOCIAL SECURITY NUMBER

Your social security number is used to verify your identity for licensing purposes and for compliance with the below laws. **For a license to be issued you must provide your social security number or your application will be deemed deficient and will not be processed further.**

The following laws require that you furnish your social security number to our agency.

FEDERAL LAWS:

42 U.S.C.A. §666 (a)(13) requires the social security number of any applicant for a professional license or occupational license be recorded on the application for license; and If you are a license health care practitioner, **45 C.F.R., Part 61, Subpart B, §61.7** requires the social security number as part of the mandatory reporting we must do to the Healthcare Integrity and Protection Data Bank (HIPDB), of any final adverse licensing action against a licensed health care practitioner.

Hawaii Revised Statutes ("HRS"):

§576D-13(j), HRS requires the social security number of any applicant for a professional license or occupational license be recorded on the application for license; and

§436B-10(4) HRS which states that an applicant for license shall provide the applicant's social security number if the licensing authority is authorized by federal law to require the disclosure(and by the federal cites shown above, we are authorized to require the social security number).

FEES

Note: One of the numerous legal requirements that you must meet in order for your new license to be issued is the payment of fees as set forth in this application. You may be sent a license certificate before the payment you sent us for your required fees is honored by your bank. If your payment is dishonored, you will have failed to pay the required licensing fee and your license will not be valid, and you **may not** do business under that license. Also, a \$25.00 service charge shall be assessed for payments that are dishonored for any reason.

BOARD'S RESPONSE

You will receive either a **deficiency notice** or an **approval notice** from the Board upon receipt of all required forms, documents, and fees, and review of your application.

If for any reason you are denied the license you are applying for, you may be entitled to a hearing as provided by the Hawaii Administrative Rules, Title 16, Chapter 201, and/or Hawaii Revised Statutes, Chapter 91. Your written request for a hearing should be directed to the Board of Veterinary Examiners and must be received by the Board within 60 days of the date that your application for licensure was denied.

ABANDONMENT

Pursuant to HRS §436B-9 your application shall be considered abandoned and shall be destroyed if you fail to provide evidence of continued efforts to complete the licensing process for two consecutive years. The failure to provide evidence of continued efforts includes but is not limited to: (1) failure to submit any required information and documents requested by the licensing authority within two consecutive years from the last date the documents and information were requested, or (2) failure to complete any additional requirements for licensure that remain after approval of your application, such as attempting to complete an exam requirement, within two consecutive years from the date your application was approved, or (3) failure to provide the licensing authority with any written communication during two consecutive years indicating that you are attempting to complete the licensing process. If an application is deemed abandoned the applicant shall be required to reapply for licensure and comply with the licensing requirements in effect at the time of the reapplication.

THE BOARD'S LAWS & RULES

By signing your application form (VET-01), you are certifying that you have read and will abide by the provisions of Hawaii Revised Statutes Chapter 471 (the Board's laws), Hawaii Administrative Rules Title 16, Chapter 101 (the Board's rules) and Hawaii Revised Statutes Chapter 436B (the Professional and Vocational Licensing Act).

LICENSURE & BIENNIAL RENEWAL

After all requirements are met, license fees will be due. You will be sent notification of amounts of these fees at the appropriate time.

All veterinary examiners licenses (**regardless of issuance date**) expire on June 30 of each EVEN-NUMBERED year and must be renewed on or before the license expiration date. Renewals that are received after the license expiration date are subject to late renewal fees.

A forfeited (non-renewed) veterinary examiners license can be restored up to 3 years from the date of forfeiture, upon the filing of a restoration application and payment of all required fees.

After three (3) years from the date of license forfeiture, a forfeited license may be restored upon the filing of a restoration application, payment of all required fees, **and** verification provided to the Board that the former licensee is qualified to practice veterinary medicine.

CHANGE OF ADDRESS

You must immediately report any changes of address to the Licensing Branch in writing, so that your records can be updated.

IMPORTANT NOTICE

BOARD OF VETERINARY EXAMINERS

New License Requirement

Effective June 17, 2003 and pursuant to Hawaii Revised Statutes section 436B-10 and federal law, it is the policy of the State of Hawaii ("**State**") Board of Veterinary Examiners ("**Board**") that, in addition to meeting the education, experience, and examination requirements for licensure, an applicant for a Hawaii veterinarian's license is required to be either **a United States citizen, a United States national, or an alien authorized to work in the United States.**

This means that, even if an applicant meets the education, experience, and examination requirements for licensure, that applicant shall not be issued a license if that applicant is not a U.S. citizen, a U.S. national, or an alien authorized to work in the U.S.

However, the Board will issue the applicant a **conditional approval** that signifies that the applicant has met the education, experience, and examination requirements for licensure; provided that this conditional approval shall **not** be considered a license to engage in the profession and shall **not** authorize the applicant to work in our State. To obtain authorization to work in our State, the applicant shall be required to contact the U.S. Citizenship and Immigration Services ("**USCIS**"). In addition, federal law [42 U.S.C.A. 666 (a)(13)] requires that once an applicant is authorized by the USCIS to work in the U.S., the applicant must supply his/her Social Security Number ("**SSN**") so that states can use this information for child support enforcement purposes.

Once the applicant submits evidence to the Board that the USCIS has authorized the applicant to work in the U.S. (without conditions or other encumbrances), **provides a SSN**, and meets all of the licensing requirements in effect at that time (including, but not limited to, the requirement that the applicant has not been convicted of any crime that is directly related to the profession), the applicant shall be issued a full and unrestricted license.

This conditional approval shall be valid for two (2) years. An applicant must obtain the appropriate USCIS authorization within this two (2) year period in order to have a license issued. If the applicant is unable to meet this deadline, the applicant may be required to reapply for licensure and meet all of the requirements in effect at that time.
