**Approval of the Minutes:**

The Chair called for a motion in regards to the minutes of the September 5, 2013 meeting.

There being no amendments, upon a motion by Ms. Tali, seconded by Mr. Joslyn, it was voted on and unanimously carried to approve the minutes of the September 5, 2013 meeting as circulated.

**Chair's Report:**

The Chair reported that Dr. Gardner has resigned from the Hawaii State Center for Nursing (HSCFN) and that she would be reporting on a meeting between representatives from the HSCFN, herself and the DCCA later in the meeting.

**Executive Officer's Report:**

**Conferences/Seminars/Meetings**

**2013 NCSBN Annual Meeting – Report from Ms. Stone Murai**

Ms Stone Murai reported on her attendance at the 2013 NCSBN Annual Meeting which included the following:

- In the Business Book, which is available online, there was a white paper on nursing regulation perspective of distance education and pre-licensure nursing programs she thought the Education Committee might be interested in;
- 2014 proposed NCLEX-PN test plan;
- Criminal background checks;
- Development of a tool kit for Executive Officer succession;
- NCSBN interactive classes

There was discussion on the NCSBN membership agreement, which was voted on by the delegate assembly.

The EO reported that she is working with the DAG in review of the membership agreement and will keep the Board apprised.

**2013 NCLEX Conference – Report from Dr. Cohen**

Dr. Cohen reported on her attendance at the 2013 NCLEX Conference at which the following was discussed:

- New RN test effective April 2013;
- Scores dropped from 92% to 86% pass rate for RN since inception of new test;
- Test for entry level acute care nursing, test competency of entry level nurse;
- New LPN test starting in April 2014;
- In 2015, Canadian nurses will be able to take the NCLEX exam and half of the item writers will be from Canada

#### 2013 NCSBN Leadership and Public Policy Conference - Report from Dr. Fleming

Dr. Fleming reported on her attendance at the 2013 NCSBN Leadership and Public Policy Conference which included the following topics:

- The California Board of Nursing no longer recognizes Excelsior;
- Arizona and Texas attempting to obtain authority over finances;
- NCSBN funding and resources available for member boards for research;
- Boards of Nursing proactive in establishing best practice in nursing practice

#### **Report on APRN Prescriptive Authority**

The EO reported that:

- In mid October, all "RX" licenses will indicate "law repealed";
- There were under a hundred APRNs with prescriptive authority who had not yet submitted their continuing education (CE) and proof of current national certification, therefore, their prescriptive authority has not been indicated under their APRN license as a special privilege;
- No further notices will be sent as we will accept the CE and proof of national certification until the end of December.

#### **Hawaii State Center for Nursing**

The Chair reported that she attended a meeting with Dean Boland, Acting Director for the HSCFN, Kathy Yokouchi, Keali'i Lopez, Director of the Department of Commerce and Consumer Affairs (DCCA), Jo Ann Uchida, Deputy Director of DCCA, Celia Suzuki, Licensing Administrator, Art Gladstone, representing the HSCFN, and Lee Ann Teshima, Executive Officer. At the meeting the group discussed a memorandum of understanding/agreement between the Professional and Vocational Licensing Division, the Board of Nursing and the HSCFN to work more collaboratively so that the HSCFN may accomplish the tasks for which they were established.

The group also discussed the HSCFN's report on continued competency for nurses where it was recommended that the HSCFN inform the Board, at one of their monthly meetings, of what exactly their recommendation is and the specifics of implementation of a program. There was concern of a nurse who fails to perform the continued competency assessment losing their license; however, Dean Boland assured the group that there would be no punitive repercussions.

#### **RICO Nursing Advisory Committee**

The Board reviewed the list provided from RICO and upon a motion by the Vice Chair, seconded by Ms. Elvenia, it was voted on and unanimously carried to approve the RICO list of Nursing Advisory Committee members.

#### **2014 Board Meeting Schedule**

The 2014 Board meeting schedule was distributed to the members for their information.

After some discussion, upon a motion by Ms. Tali, seconded by Ms. Elvenia, it was voted on and unanimously carried to accept the meeting dates for 2014 with the following changes:

#### **Education Committee Report for September 5, 2013 Meeting**

Dr. Cohen reported the following for the September 5, 2013 Education Committee meeting:

- Hawaii Nursing Programs – The annual reports are due October 1, 2013 and the University of Phoenix's quarterly report for the period covering April – June 2013, has not yet been received.
- Foreign Educated Applications:
  1. Wossen Gebremedhin – RN exam application deferred, insufficient information to substantiate applicant's education meets the requirements under HAR 16-89-47.
  2. Olga Gudima – RN exam application deferred, insufficient information to substantiate applicant's education meets the requirements under HAR 16-89-47. Committee also request that applicant submit course description from Spokane Community College for review.
  3. Xia Shan - RN exam application deferred, insufficient information to substantiate applicant's education meets the requirements under HAR 16-89-47. The Committee also request that the additional course be reviewed by CGFNS International and a new CES report be submitted for the Committee's review/consideration.
  4. Meiping Li - RN exam application deferred, insufficient information to substantiate applicant's education meets the requirements under HAR 16-89-47.
- U.S. Educated Applications:
  1. Jeneba Sheriff - RN exam application deferred, insufficient information to substantiate applicant's education meets the requirements under HAR 16-89-47.
  2. Hencie Barreau - RN exam application deferred, insufficient information to substantiate applicant's education meets the requirements under HAR 16-89-47. The Committee also request additional information regarding the courses taken at Florida National College's Nursing AS Bridge degree.

Upon a motion by Ms. Tali, seconded by Ms. Elvenia, it was voted on and unanimously carried to accept the Education Committees recommendations.

Correspondence:                    **RN Consultants Providing Educational Training, Debora Philips**

The Board reviewed an email inquiry from Ms. Philips in which she states that they have RN consultants that travel to several different states to provide consulting services which consist of educational training only with no hands on nursing care, to nursing facilities. She is asking if these RN consultants need to be licensed in Hawaii.

After some discussion, based solely on the information provided in Ms. Philips' email, it was the consensus of the Board that no license is required since the RN will not be "practicing nursing".

**Concerns with Dental Rules Regarding CRNAs, Matthew Bishop**

The Board reviewed and discussed an email from Dr. Bishop, that was sent to Director Lopez, Deputy Director Takeguchi and the Executive Officer for the Board of Dental Examiners, James Kobashigawa, in which he expressed his concerns with the Board of Dental Examiners administrative rules, specifically, section 16-79-78 and how this section states that a dentist may have a practicing certified nurse anesthetist administer general anesthesia to a patient, provided the dentist is present at all times and supervises the procedures.

Dr. Bishop points out that the current nurse practice act for advanced practice registered nurses (APRNs) do not require an APRN to practice under the "supervision" of a dentist and that there is no credible evidence that imposing additional restrictions increases patient safety.

The EO explained the rules adoption process for the new Board members.

After some discussion, it was the consensus of the Board to inform the Board of Dental Examiners that the Board supports Dr. Bishop's position and ask for their consideration to remove the supervision requirement for CRNAs in the dental rules during the next amendment of their rules. The Board also offers to address any concerns the Board of Dental Examiners may have regarding this matter.

**CNS and APRNs, Sheena Jacob**

The Board reviewed a list of emailed questions regarding CNSs and APRNs from Ms. Jacob and after some discussion, directed the EO to respond to Ms. Jacob's questions.

**LPN Refresher Course, Kauai Community College**

The Board reviewed a course, NURS 301 Introduction to Evidence Based Practice and Health Promotion from Kauai Community College for an individual LPN who has not practiced nursing in the last five years.

After some discussion, upon a motion by Dr. Cohen, seconded by Mr. Joslyn, it was voted on and unanimously carried that based on the information submitted, this course does not appear to meet the requirements under HAR §16-89-132(b)(3) as it does not include any "clinical" hours.

The Chair wanted to refer further discussion on "refresher" courses to the Education Committee, specifically what constitutes "clinical" hours.

#### **RN Refresher Course, A New Day: RN Refresher Program**

The Board reviewed a request for inclusion as an approved program for refresher students; re-entry process for RNs utilizing independent study RN refresher program.

After some discussion, it was the consensus of the Board to defer discussion of the course to the Education Committee for their review and recommendation.

#### **CE Course for APRN-Rx – Integrated Pharmacotherapy II, UH Hilo, College of Pharmacy Course**

The Board reviewed a pharmacotherapy course from the UH Hilo, College of Pharmacy.

After some discussion, it was the consensus of the Board to defer discussion of the course to the Education Committee for their review and recommendation.
