Call to Order: The Chair called the meeting to order at 8:48 a.m. at which time quorum was established.

Approval of the Minutes: The Chair called for a motion in regards to the minutes of the October 3, 2013 meeting.

There being no amendments, upon a motion by Dr. Cohen, seconded by Ms. Tali, it was voted on and unanimously carried to approve the minutes of the October 3, 2013 meeting as circulated.

Chair's Report: None.

Executive Officer's Report: **Conferences/Seminars/Meetings**

NCSBN 2014 Annual Institute of Regulatory Excellence (IRE) Conference

The EO asked if anyone was interested in attending the NCSBN 2014 Annual Institute of Regulatory Excellence (IRE) Conference, January 28-30, 2014 in San Diego, California to let her know.

**Report on APRN Prescriptive Authority**

The EO reported there are fewer than 100 APRN's with prescriptive authority who have not submitted their CE's. She also reported that she will be changing all prescriptive authority privilege designations to state "prescriptive authority" and not have a separate indicator for controlled substance prescriptive authority privilege designation. The reason is that APRNs were previously required to submit a copy of their current registration with the NED and DEA and since those registrations have an expiration date, she did not want pharmacist or the public relying on the online license verification for an APRN's prescriptive authority for controlled substances as we would not be aware if the NED or DEA registrations have expired.

**Hawaii State Center for Nursing**

The EO reported they are still working on a Memorandum of Understanding with the Center. There was a meeting with the DCCA's Deputy Director and IT personnel from the University of Hawaii regarding how the mailing address for nurse licensees would be maintained and guarded and restrictive access to the information provided by PVL.

The EO also reported that Ms. Yokouchi from the Hawaii State Center for Nursing informed her they will be submitting legislation for the 2014 session that may include a bill regarding the APRN "recognition" to "license" and a continuing education bill.

**Opioid Analgesics Risk Evaluation and Mitigation Strategy**

The EO reported that she met with a representative from Purdue Pharma L.P. who provided an information sheet regarding risk evaluation and mitigation strategy (REMS) for extended-release and long-acting (ER/LA) opioid analgesics. A copy of the information sheet was distributed to the Board members for their information.

**NCSBN Membership Agreement**

The EO distributed a copy of the Terms and Conditions of NCSBN Membership with recommendations from the Board's DAG.

After some discussion, upon a motion by Dr. Cohen, seconded by Mr. Joslyn it was voted on and unanimously carried to accept the agreement with the Deputy Attorney General's recommendations.

Correspondence:            **APRN Scope of Practice Questions**

Can an APRN perform a vasectomy

The Board discussed an inquiry asking if an APRN can perform a vasectomy.

Mr. Joslyn stated if it is in their scope of practice then they can do it.

The Chair stated it is a surgical procedure.

Ms. Tali stated she looked at the ANCC test plan for adult nurse practitioner, family nurse practitioner and clinical nurse specialist in adult health and it does not mention anything about doing surgical procedures.

After further discussion it was the consensus of the Board to defer the inquiry to the Practice Committee for research and a recommendation.

If an APRN "consults" with an out-of-state practitioner, is that considered "telehealth"

The Board discussed an inquiry asking if an APRN consults with an out-of-state practitioner, is that telehealth.

The Chair stated telehealth involves a patient.

The EO asked if consulting with another practitioner that pertains directly to the treatment of a patient, is this telehealth?

The Chair stated yes, however, if the consult is in general, and does not involve a specific patient then it would not be telehealth. If it is a consult regarding a specific patient then it would be telehealth.

After further discussion it was the consensus of the Board to refer the inquiry to the definition of telehealth as stated in Hawaii Revised Statutes §457-2.
