Agenda: The agenda for this meeting was filed with the Office of the Lieutenant Governor, as required by section 92-7(b), Hawaii Revised Statutes ("HRS").

Call to Order: There being a quorum present, the Chair called the meeting to order at 9:00 a.m.

Announcements and Introductions

The Chair asked the audience to introduce themselves.

Upon a motion by Mr. Lau, seconded by Ms. Keefe, it was voted on and unanimously carried to add the above mentioned application to the agenda.

Approval of the Previous Minutes – October 17, 2013

Dr. Oliveira Gray stated the last sentence on page four under Correspondence should read, “will be referred to the Department of Public Safety”, not the Department of Health.

The Chair stated the first sentence on page four is incomplete. It should read, the Chair recommended that **the information sheet include a warning for penicillin regarding bad reactions, rash or allergies.**

Mr. Lau stated on page two, second to the last paragraph, first sentence under Executive Officer’s Report should read, “there was also a pool reduction initiative”, not the also conducted a pool reduction initiative.

The Chair called for a motion in regards to the minutes of the October 17, 2013 meeting. Upon a motion by Ms. Keefe, seconded by Mr. Lau, it was voted on and unanimously carried to approve the minutes for the August 15, 2013 with the above mentioned amendments.

Executive Officer’s Report:

2014 Board Meeting Schedule - Amended

The Board amended their 2014 Board meeting schedule at the October 17, 2013 meeting. An amended schedule was distributed to the members for their information.

Conferences/Seminars/Webinars/Meetings

Tri-Regulator Webinar – Free Sterile Compounding Webinar

The EO asked the members if they would be interested in participating in a two part Tri-Regulator Webinar being held December 12, 2013 and February 20, 2014. Ms. Keefe and Ms. Okamura expressed they wish to participate.

Walgreen's Model – Information from Patrick Adams and Additional Information Regarding Expanded HIPAA Privacy Rules

The EO reported on an article received from Patrick Adams questioning if some Walgreen's pharmacies are violating HIPAA laws.

The EO stated after the Board's last meeting she contacted Al Carter via email to tell him the Board was not notified that a pharmacy with the new model in place had opened. Mr. Carter replied that he mistakenly sent the information to the wrong email address. He then sent the information to the correct email address. Mr. Carter states in his email that the store opened on June 28, 2013 and offered to set up a tour and demonstration for members of the Board. He also provided the pharmacy's policies and procedures and stated that as of November 18, 2013 (date of the email) that there have been no incidences within the new model.

The EO recommended the Board defer discussion on this matter to allow review of the policies and procedures that were provided to the Board today.

The Chair stated one of the issues the Board had previously was not being able to see physically how the store operates. The Chair suggested scheduling a tour of the pharmacy.

The EO stated she will check with Al Carter to see if they can accommodate some members for a tour before or after the next Board meeting.

The Chair announced that discussion regarding the tour of the pharmacy will be deferred to later in the meeting but asked Patrick Adams if he had any comments or concerns.

Mr. Adams stated he provided the Board with information from other state boards questioning the Walgreen's model so the Board is aware of what is happening with Walgreens and HIPAA. Mr. Adams does not have an opinion on this matter; he just wanted to make sure the Board had the information.

2014 Legislature

Relating to Pharmacists – Requires pharmacists to complete a training program approved by the board of pharmacy to dispense veterinary prescriptions

The EO reported on a proposed bill requiring pharmacist to complete a training program approved by the Board of Pharmacy to dispense veterinary prescriptions. The bill would amend Chapter 461 by stating "A pharmacist who dispenses veterinary prescriptions shall complete a training program approved by the board within every other biennial renewal period and submit proof of successful completion of the training program to the board; provided that the pharmacist shall meet these requirements prior to dispensing veterinary prescriptions."

Ms. Okamura stated her concerns are if you require a pharmacist to complete a training program in order to dispense a prescription for an animal you are limiting access to animal prescriptions. Prescriptions for animals are not common and usually only come in if the veterinarian does not carry the medication. If this were to pass, the owner would now have to find a pharmacist who is allowed to fill the prescription. Also, the availability of courses would be another issue.

The Chair stated the bill reads "§461 – Veterinary prescriptions. No pharmacist shall dispense a veterinary prescription unless that pharmacist has met the continuing education requirements pursuant to section 461-8(f)." The Chair stated his concern is veterinary prescriptions are not defined. It is not particularly stated that these are medications that are labeled "to be dispensed by a veterinarian" or "on the order of a veterinarian". Without a definition it becomes very vague, it could be interpreted that any type of human drugs that are used for veterinary purposes would require as such.

The Chair also stated the bill reads in closing, "Section 3. By July 1, 2015, the board of pharmacy shall develop a training program for pharmacists who dispense veterinary prescriptions. The board of pharmacy shall consult with the board of veterinary examiners to develop the training program and may adopt, amend, and repeal rules pursuant to chapter 91, Hawaii Revised Statutes, as it deems proper for the purposes of this Act." The Chair stated his concern with this section is the Board is not capable of developing a training program at this time because no one is an expertise in this area.

Further discussion was deferred to the Laws and Rules Committee.

Report on Current Renewals

The EO reported as of November 18, 2013, 89 pharmacies have renewed out of 279 eligible, 792 pharmacists have renewed out of 2,459 eligible, 174 pharmacy miscellaneous permits have renewed out of 472 eligible and 30 wholesale prescription drug distributors have renewed out of 75 eligible.

Correspondence:

National Association of Boards of Pharmacy (NABP)

CPE Monitor Reaches a Milestone with Over Five Million CPE Activities Tracked

The Board was provided with a copy of correspondence from NABP stating the Accreditation Council for Pharmacy Education (ACPE) announced that the CPE Monitor reached a milestone with over five million continuing education pharmacy education (CPE) activity records now stored in the CPE Monitor system. Currently, more than 266,800 pharmacists have created NABP e-Profiles and registered for the CPE Monitor service, allowing them to electronically track CPE activity from participating providers. Boards of pharmacy will be able to verify their licensees' compliance with CPE requirements by logging into the secure Board e-Profile Connect system that is scheduled to launch in November 2013.

Alabama State Board of Pharmacy Newsletter – Veterinarians Not Eligible for NPIs, CMS Clarifies

The Board was provided with a copy of an exert from the Alabama State Board of Pharmacy Newsletter stating that the Centers for Medicare and Medicaid Services (CMS) has become aware of cases in which veterinarians are told, incorrectly, that they must provide a National Provider Identifier (NPI) number for prescriptions they have written to be dispensed. CMS has

issued a clarification, stressing that veterinarians do not meet the regulatory definition of "health care provider," and thus may not obtain NPI numbers.

Louisiana Rulemaking Activities – Compounding for Prescriber Use

The Board was provided with a copy of correspondence from NABP State News Roundup that states the Louisiana Board of Pharmacy issued an emergency rule that places limits on the amount of compounding for prescriber use a pharmacy may prepare without a patient-specific prescription. Since that time the Louisiana Board has been working through the process to develop a permanent rule.

The EO stated the reason this information was provided to the Board is because Louisiana Board issued an emergency rule before they made their rules permanent. The EO thought the Board may want to look into doing something similar.

Extended-Release and Long-Acting Opioid Analgesics Risk Evaluation and Mitigation Strategy-FYI

The EO reported that she met with a representative from Purdue Pharma L.P. who provided an information sheet regarding risk evaluation and mitigation strategy (REMS) for extended-release and long-acting (ER/LA) opioid analgesics. A copy of the information sheet was distributed to the Board members for their information.

Internal Pharmacy Theft, Tips and Practices to Protect Your Pharmacy from Diversion-FYI

The Board was provided with information from Purdue Pharma L.P. on tips and practices to protect your pharmacy from diversion.

The four major topics focused on in the hand-out were:

1. Physical Site Security
2. Employee Screening
3. Controlled Substance (CS) Handling Procedures
4. Common Scams

Tri-Regulator Leadership Collaborative Membership Communique-FYI

The Board was provided with information on the Tri-Regulator Leadership Collaborative Membership meeting of August 27, 2013 to review and discuss issues of mutual concern in the ongoing collaboration between the Federation of State Medical Boards (FSMB), National Association of Board of Pharmacy (NABP), and National Council of State Boards of Nursing (NCSBN). The group discussed a draft position statement on interprofessional team-based patient care proposed for adoption by all three organizations.

Medication Therapy Management Inquiry – Kmart Pharmacy

The Chair lead the discussion on an inquiry from Kmart Pharmacy asking if there are any license requirements or restrictions for out-of-state pharmacists who may be covering at a pharmacy located in Hawaii as it relates to performing medication therapy management services for their patients.

Ms. Keefe stated under the practice of pharmacy, part of a Hawaii pharmacist job is drug utilization review. Therefore, the pharmacist would have to be licensed in Hawaii.

The Chair stated that has always been the Boards position that if you are communicating with an individual in Hawaii, you have to be licensed in Hawaii.

It was the consensus of the Board to inform Kmart Pharmacy that the pharmacists covering for a pharmacy in Hawaii must hold a Hawaii pharmacist license.

CPR Training for Pharmacist

Mr. Lau lead the discussion on an inquiry asking what level of CPR training is required in Hawaii for pharmacist immunization certification.

Ms. Keefe stated in the ACPE guidelines it says basic CPR certification is required.

The EO stated your laws and rules do not specifically address CPR, however, training is required in order to administer immunizations and the training that was approved by the Board includes CPR certification.

It was the consensus of the Board to reply to the inquiry that the immunization training that was approved by the Board includes CPR certification.

Animal Biologics Produced and Administered to House Pets

Ms. Okamura lead the discussion on an inquiry asking if the Board regulates companies/facilities engaging in animal biologics produced for and administered to house pets. The companies contacted have stated they are regulated by the United States Department of Agriculture (USDA) and the products in question do not fall under the definition of "prescription drug."

Ms. Keefe asked if this would come under the Department of Health, Food and Drug Branch.

The Chair stated the USDA does have requirements on medications that are administered to food producing animals, which is why they are probably stating they are regulated by the USDA. The Chair stated there is nothing in the Board's requirements that address this.

The EO clarified there is nothing in the Board's laws and rules that address this.

The Chair stated yes, and also suggested referring the inquiry to Department of Health, Food and Drug Branch.

Biomedical Waste Permit for Pharmacies

Ms. Keefe lead the discussion on an inquiry asking if Hawaii requires a pharmacy to obtain a biomedical waste permit. Ms. Keefe stated there is nothing in our laws and rules that address biomedical waste.

The Chair stated this question has come up before and believes it comes under the Department of Health, Hazardous Waste Division.

The EO asked the pharmacist members what they do at their pharmacies with their waste.

Ms. Okamura stated they use reverse distributors or sharps they mail back.

Ms. Keefe stated they have special bags they put their waste in and it is picked up by private hazards waste disposal companies or mailed back.

The EO stated your laws and rules do not specifically address this but it is common practice for pharmacies to use reverse distributors and other entities that deal with hazards waste disposal to deal with their waste. The Department of Health also has a Hazardous Waste Division.

The Board consensus agrees with what the EO states above.

Questions Regarding Patients and Prescribers of Controlled Substances

Dr. Oliveira Gray lead the discussion on a request to complete a survey regarding an emergency response plan to help mitigate the community impact when a prescriber of controlled substances is suddenly removed from practice.

After a brief discussion it was the consensus of the Board to refer the survey to the Department of Public Safety, Narcotics Enforcement Division since the survey questions reference controlled substances.

Electronic Prescriptions for Non-Controlled Substances Inquiry

The Chair lead the discussion on an inquiry regarding electronic recordkeeping. Four specific questions asked in the inquiry are as stated below with the Board's responses:

1. Can we discontinue printing the erx? We can print on demand - ***Refer to Department of Health, Food and Drug Branch***
2. Can we discontinue printing the fax rx? We can print on demand - ***refer to HAR 16-95-82 and Department of Health, Food and Drug Branch***
3. Can we file non-controlled rx's by day rather than by 100? ***-Refer to Department of Health, Food and Drug Branch***
4. Can we file non-controlled rx's by day without attaching the End of Day information. We can print the rx with the End of Day information on demand. ***- Refer to Department of Health, Food and Drug Branch***

Request for CME Approval – Army Pain Management Tele ECHO Clinics

Mr. Lau lead the discussion on a request from the Army Pain ECHO (Extension of Community Health Outcomes) education sessions at Tripler Army Medical Center for approval of CE credits for pharmacists who take their course.

The EO stated currently your definition of continuing education allows you to accept ACPE or continuing medical education that serves to improve patient safety and prevent medication errors. However, that definition will be revised effective January 1, 2014. Therefore, should you approve any CME courses; the approval would only be good until December 31, 2013.

The Chair stated the CME requirements are very limited by law as to what specifically it had to relate to and the Board was always tasked with the problem of accepting CME's after the fact to justify if an individual met the CE requirements for renewal. The revisions taking effect January 1, 2014 will eliminate that problem of the Board having to approve CME's because the Board is not an accrediting type of organization. It will allow the Board to only recognize ACPE approved programs.

Guest Marcella Chock from HPHA stated it circumvents the fact why we're ACPE administrators for HPHA for example. Ms. Chock stated that Tripler knows the criteria of what qualifies a program for ACPE, so it is interesting that they are asking for approval of a course from the Board. Ms. Chock stated what she means by circumvents is that the processes are out there in the community, in the state, and if they start sending correspondence to the Board asking for approval and circumvent applying and going through the proper channels to qualify a program for certification for pharmacist, it defeats the purpose of why we have that criteria in place.

Mr. Lau stated based on what is being submitted, it looks like after the fact. The courses have already taken place.

The EO stated the bottom line is, what was submitted, does it meet the requirements or the definition of continuing education as stated in Chapter 461.

Upon a motion by the Chair, seconded by Ms. Okamura it was voted on and unanimously carried to deny approval of the CE course as it does not meet the requirements as stated in Chapter 461 under the definition of continuing education.

Phaseout of opioid/acetaminophen combination products

Ms. Okamura lead the discussion on an email inquiry asking if after the phase-out date of January 14, 2014 are pharmacies allowed to dispense stock until it is depleted, or must they stop dispensing on this date.

The Chair stated because it is regarding a controlled substance, this inquiry should be referred to the Department of Public Safety, Narcotics Enforcement Division.

Florida DME Supplier – Miscellaneous Permit "Entity"

Ms. Keefe lead the discussion on an email inquiry asking how the Board is planning on licensing out-of-state DME (durable medical equipment) providers.

The Chair stated this has been an ongoing issue because in Chapter 461 under the Miscellaneous Permit requirements, there is a provision for an out-of-state pharmacy that dispense drugs, also includes devices. Therefore the only way an out-of-state DME provider can dispense equipment/devices into the state is to obtain a miscellaneous permit, however the requirement to obtain a miscellaneous permit is you must have an out-of-state pharmacy license.

It is the Board consensus to respond to the inquiry about how the Board is planning on licensing out-of-state DME providers is that the Board is currently working on making changes to the miscellaneous permit requirements section. However, at this time pursuant to §461-15(7) there are no provisions to license out-of-state DME providers who ship devices into Hawaii.

Old Business: **HAR Title 16, Chapter 95 – Status Report**

The EO stated that she has completed a draft of the justifications and will be providing it to the Deputy Attorney General for his recommendations.

Pharmacy Technician Survey – Status Report

The EO reported she sent a draft of the survey to the Hawaii Pharmacist Association for them to review and it appears they are ok with it. The survey should be sent out to all the pharmacies by the end of the year.

Open Forum: Guest Stacy Pi from Kaiser Permanente asked if the Tri-Regulator Webinar was available only to Board members.

The EO stated she believes it is, but will check and get back to Ms. Pi.

Mr. Lau stated if anyone is filing the electronic prescribing of controlled substances, Surescripts website does not recognize Hawaii as accepting electronic prescriptions of controlled substances. However, after speaking with Keith Kamita, correspondence was sent and hopefully Hawaii will be recognized. Whatever pharmacy software is being used needs to be certified through your vendor and go through a DEA audit and the provider also needs to certify their software on their end as well.

The Chair stated he had a meeting with Keith Kamita and Derrick Nakamura regarding what Mr. Lau is referring to and Mr. Kamita was willing to do a test. The Chair contacted Surescripts and spoke with the Vice President and at that time the Vice President said Surescript had no certified pharmacy providers here. Surescripts was aware of the law change, however they were not sure if there was supposed to be any type of ability for them to start the implementation.
