Attendance at NCSBN 2014 Midyear Meeting, Kansas City, Missouri, March 10-12, 2014

The Chair gave a verbal report on her attendance at the NCSBN Midyear meeting. Topics of discussion included:

- Distance learning The concern with the impact on "for profit" companies and the need to establish guidelines;
- National licensure Recognizing the BSN as the entry level to practice and the negative impact on ADN programs;
- Compact licensure;
- Revisions to the By-Laws, including the upcoming election of a new President;

The Vice Chair stated that she is on the By-Laws Committee and that the Committee worked very hard on the proposed revisions to the By-Laws.

The Chair asked Ms. Tali if she had anything to add.

Ms. Tali mentioned that there was a lengthy discussion on telehealth concerning licensure of the health professional and whether it is based on where the patient is located or the health professional. She stated that she was very surprised as she networked with other Area 1 jurisdictions how we all were dealing with similar issues.

The Chair also added that she spoke briefly with Joe Baker of the Florida Board of Nursing regarding the numerous applicants from Florida nursing programs applying to take the NCLEX through Hawaii.

2014 Legislature

The EO reported on the following bills.

HB 2052/SB 2227 – Relating to Provider Orders for Life-Sustaining Treatment HB 2052, HD2, SD2 passed out of the Senate Judiciary and Labor (JDL) Committee with amendments and should be transmitted back to the House.

SB 2227, HD1 was deferred by the House Consumer Protection and Commerce (CPC) Committee.

SB 2491 – Relating to Nursing

This bill passed out of the House CPC un-amended and should be transmitted back to the Senate.

HB 2099/SB 2492 – Relating to Advanced Practice Registered Nurses

HB 2099, HD 1, SD1 passed out of the Senate Commerce and Consumer Protection (CPN) Committee with amendments and was be transmitted back to the House.

SB 2492, SD1 passed out of the House CPC un-amended and should be transmitted back to the Senate.

SB2469, SD2, HD1 – Relating to Telehealth

This bill was passed out of the House CPC with amendments and referred to the final committee, Finance. However, the EO stated that she believes that tomorrow is the deadline for all bills to be passed out of the final committee and that since this bill was not heard it will not be transmitted back to the Senate for their consideration.

SB 2490, SD2, HD2 – Relating to Continuing Competency for Nurses

This bill passed out of the House CPC Committee yesterday with amendments from the Board and the Department of Commerce and Consumer Affairs. The EO stated that the Chair of the CPC also stated that he would be including a defective date due to the fiscal impact and to promote more discussion.

The Chair stated that she spoke with representatives from the New Hampshire Board of Nursing whose continuing competence program was used as a model for this bill. She was informed that the continuing competence program has been in existence for seven years and with the first renewal, there were many nurses who failed to complete the continuing competence requirement and therefore were unable to renew their license. She also stated that the New Hampshire Board of Nursing is only auditing about 1-2 percent of their nurses and is thinking of hiring a full time person to handle the audit and that they have no

HB 1881/SB 2489 – Relating to the Center for Nursing

HB 1881, SD1 was transmitted back to the House and the House disagrees with the Senate amendments. The EO added that this bill may be scheduled for conference committee.

SB 2489, SD2 was not scheduled for hearing by the House side.

Gallup Poll Results: Nurses, Pharmacists and Grade School Teachers Received High Ranks for Ethical Standards... Lobbyists, members of Congress and Car Salespeople Sit at the Bottom of the List

The EO shared an article about the latest Gallup Poll which place nurses, pharmacists and grade school teachers at the top of the list of professions Americans rated as having honesty and ethical standards. Sitting at the bottom of the list were lobbyists, members of Congress and car salespeople.

Correspondence from the Texas Board of Nursing Regarding APRNs

A copy of a letter from the Texas Board of Nursing was distributed to the members for their information.

According to the letter from the Texas BON, they are advising key stakeholders with an interest in issues related to advanced practice registered nursing licensure and practice in the state of Texas. Specifically, changes to regulatory terminology, "APRN" will be replacing the term "advanced practice nurse" as well as "advanced nurse practitioner" and the issuance of a second license, APRN, to registered nurses.

Policy Perspectives – Competition and the Regulation of Advanced Practice Nurses

Denise Cohen's Report:

Attendance at the Executive Officer's Forum, Chicago, Illinois, March 24-25, 2014

Dr. Cohen gave a verbal report on her attendance at the Executive Officer's Forum that included:

- Discussion on compact states and national licensure:
- Resistence identified such as mandatory criminal background checks;
- Convictions of a felony may prevent an individual from obtaining national licensure:
- Discussion of misdemeanor convictions such as DUIs, shoplifting, assault, etc;
- Educational consistency:
- No clinical no national licensure;
- Foreign educated individuals would have to go through the CGFNS and also pass an English competency test; and
- The fiscal impact on small states.

Dr. Cohen also stated that she was approached by Joe Baker of the Florida Board of Nursing who informed her that the Florida Board of Nursing has initiated an investigation into individuals educated in Florida but applying to sit for the NCLEX in another state.

The EO stated that she would contact Mr. Baker to work collaboratively with them on their investigation.

The Chair asked Dr. Cohen if there was discussion that participation in NURSYS would be required should a board decide they wanted to participate in the national licensure program.

Dr. Cohen said that was not discussed.

The Chair asked if there was discussion on the scope of practice in regards to national licensure since states differ in their practice act and also continuing competence or continuing education requirements.

Dr. Cohen said that was not discussed.
