After due consideration of the information received as well as Dr. Sankey's telephone interview, it was moved by Dr. Desai, seconded by Dr. Kosasa and unanimously carried to deny Dr. Sankey's application for medical licensure, basing its decision on the following legal grounds of the Hawaii Revised Statutes ("HRS"), which find factual support in the records and files of Dr. Sankey's application:

- HRS § 453-8(a)(7): Professional misconduct, hazardous negligence causing bodily injury to another, or manifest incapacity in the practice of medicine, osteopathy, or surgery;
- HRS § 453-8(a)(8): Incompetence or multiple instances of negligence, including but not limited to the consistent use of medical service, which is inappropriate or unnecessary; and
- HRS § 453-8(a)(9): Conduct or practice contrary to recognized standards of the ethics of the medical profession as adopted by the Hawaii Medical Association, the American Medical Association, the Hawaii Association of Osteopathic Physicians and Surgeons, or the American Osteopathic Association.

Grant D. Geske, D.O.

After due consideration of the information received, it was moved by Chair Takanishi, seconded by Dr. Desai and unanimously carried to deny Dr. Geske's application for osteopathic medical licensure, basing its decision on the following grounds of the Hawaii Revised

Statutes ("HRS"), which find factual support in the records and files of Dr. Geske's application:

- HRS § 453-8(a)(4): Being habituated to the excessive use of drugs or alcohol; or being addicted to, dependent on, or a habitual user of a narcotic, barbiturate, amphetamine, hallucinogen, or other drug having similar effects;
- HRS § 453-8(a)(5): Practicing medicine while the ability to practice is impaired by alcohol, drugs, physical disability, or mental disability;
- HRS § 453-8(a)(7): Professional misconduct, hazardous negligence causing bodily injury to another, or manifest incapacity in the practice of medicine, osteopathy, or surgery;
- HRS § 453-8(a)(8): Incompetence or multiple instances of negligence, including but not limited to the consistent use of medical service, which is inappropriate or unnecessary;
- HRS § 453-8(a)(9): Conduct or practice contrary to the recognized standards of ethics of the medical profession as adopted by the Hawaii Medical Association, the American Medical Association, the Hawaii Association of Osteopathic Physicians and Surgeons, or the American Osteopathic Association;
- HRS § 453-8(a)(11): Revocation, suspension, or other disciplinary action by another state or federal agency of a license, certification, or medical privilege for reasons as provided in this section;
- HRS § 453-8(a)(15): Submitting to or filing with the board any notice, statement, or other document required under this chapter which is false or untrue or contains any material misstatement or omission of fact; and
- HRS § 436B-19(12): Failure to comply, observe, or adhere to any law in a manner such that the licensing authority deems the applicant or holder an unfit or improper person to hold a license.

Mario A. Grosso, M.D.

Keoni Nguyen, D.O.

After due consideration of the information received, it was moved by Chair Takanishi, seconded by Dr. Desai and unanimously carried to deny Dr. Nguyen's application for osteopathic medical licensure, basing its decision on the following grounds of the Hawaii Revised Statutes ("HRS"), which find factual support in the records and files of Dr. Nguyen's application:

- HRS § 453-8(a)(7): Professional misconduct, hazardous negligence causing bodily injury to another, or manifest incapacity in the practice of medicine, osteopathy, or surgery;
- HRS § 453-8(a)(9): Conduct or practice contrary to the recognized standards of ethics of the medical profession as adopted by the Hawaii Medical Association, the American Medical Association, the Hawaii Association of Osteopathic Physicians and Surgeons, or the American Osteopathic Association;
- HRS § 436B-19(7): Professional misconduct, incompetence, gross negligence, or manifest incapacity in the practice of the licensed profession or vocation;
- HRS § 436B-19(8): Failure to maintain a record or history of competency, trustworthiness, fair dealing, and financial integrity; and
- HRS § 436B-19(9): Conduct or practice contrary to recognized standards of ethics for the licensed profession or vocation.

Request for
Reconsideration: RoseMarie Toussaint, M.D.

After due consideration of Dr. Toussaint's request for reconsideration dated April 28, 2014 as well as Dr. Toussaint's oral testimony, it was moved by Dr. Desai, seconded by Dr. Kosasa and carried by a majority, with Dr. Bintliff opposing and Dr. Chin abstaining, to affirm its decision of January 9, 2014, denying Dr. Toussaint's application for medical licensure.

Chairperson's
Report:

Chair Takanishi attended the Federation of State Medical Board's Annual ("FSMB") meeting (as did Executive Officer, Ahlani Quiogue) held on April 23 – 26, 2014 in Denver, Colorado.

Chair Takanishi informed members that during the conference, the FSMB along with the input from several state boards created the draft Interstate Compact ("Compact"). The principles of this particular Compact are to: allow states to participate on strictly voluntary basis; creates another pathway for licensure, but does not otherwise change a state's existing medical practice act.

Chair Takanishi went on to say that the following is the proposed licensure pathway:

- Step 1: Eligible physician receives license in a Compact State
- Step 2: Eligible physician applies for expedited licensure in Compact State. Compact state verifies eligibility.
- Step 3: Compact state sends attestation to Commission. Eligible physician transmits fees to Commission.
- Step 4: Compact Commission sends fees and physician information to states indicated by physician.
- Step 5: Indicated states issue physician a license.
- Step 6: Ongoing: Commission used as clearinghouse for shared discipline and investigatory information.
