a. Continuing Education Curriculum

It was moved by Vice Chairperson Yabuta, seconded by Chief Perry and unanimously carried to approve the following Security Guard Continuing Education Curriculum:

Mr. Chang recommended adding an exam/quiz to the continuing education curricula to verify training. DAG Tam indicated that an exam is not statutorily mandated however, the Board could recommend an exam be used for discussion purposes.

2014 Board
Renewals:

a. Update

The Executive Officer informed the Board that the 2014 renewals effective June 30, 2014 will require all licensed guards and private detectives to renew their licenses and guard employees to renew their registration cards. The Licensing Branch is currently establishing an online renewal program. A renewal postcard notice will be sent shortly to remind licensees to renew online and set up an account with MyPVL to effectuate faster turnaround. To receive hard copy renewal notices a registrant must call 586-3000

to have one mailed. Hard copy renewals result in slower processing times because it will require manual input and potential backlog.

An employer can also create subscriber accounts on MyPVL. The employer can then give their employees who do not have charge cards or e-checks the subscriber account number for renewal processing and the employer will be billed later for the fees incurred. The Executive Officer emphasized that renewing online is instantaneous and more efficient. The billing portion of MyPVL will be handled by Hawaii Information Consortium ("HIC") for a fee (3% for credit cards, and 5% for payment after invoice).

The Executive Officer informed the Board that if SB2486 which proposes to delay the continuing education requirements until 2016 does not pass this legislative session, guard employees may still renew their registration cards because proof of continued education will be done through a random audit and only those audited must submit proof of attending a continuing education course. If training starts now and the bill delaying the continuing education requirement passes, the continuing education certificate will be accepted for the 2016 renewal period. The Executive Officer suggests that the guests attending this meeting encourage legislators to pass the delaying of the continuing education requirement and SB2486. The exemption of loss prevention employees was added to the bill and needs further discussion.

The Executive Officer added that the on time renewal fee for guard employees is \$66 and the restoration fee after June 30, 2014 is \$81.

Mr. Owens stated that he has already trained over 100 guards with no testing component in his curriculum. The Executive Officer stated that testing for the continuing education curriculum is not a statutory requirement. The recommendation is that testing will verify learning and may facilitate discussion on items missed. Mr. Owens also asked the Board "If the continuing education is postponed, will the requirement be 4 hours annually or 8 hours biennially?" The Executive Office responded that the current language, (4 hours annually) appeared to allow the Board to require 8 hours biennially should they so choose; however, rule revisions would clarify the Board's position. The Executive Officer indicated that the employer could offer the continuing education 4 hours each year or 8 hours in one course during the renewal period.

Mr. Thomas from AKAL asked if there will be a renewal card because the pocket ID card may take two weeks to receive. The Executive Officer stated that if the employee is renewing online,

they will be able to print a renewal verification, with the actual pocket card being received approximately 2 weeks later.

Legislation:

a. SB2486SD1HD1 Relating to private guards

The Executive Officer informed the Board that Senator Baker made changes in SB2486SD1 by amending the effective date to June 29, 2014. Effectuating this Act prior to the June 30, 2014 commencement of the continuing education requirement insures the delay to June 20, 2016

When the bill crossed over to the House, Representative McKelvey recommended that the 4-hour continuing education requirement remain with a defective date to encourage more discussion and he also added an exemption for loss prevention officers. SB2486SD1HD1, page 4, section 3 is very broad and problematic. This section could be construed as referring to an employee of a guard agency who only works on loss prevention jobs. The bill will now go to conference hearing where additional testimony is not accepted. The Executive Officer emphasized to Senator Baker that the Board agrees that there is a need to delay the effective date of the continuing education requirement and hopes that if no agreement can be reached about the exemption of loss prevention, the conferees can at least agree about the delay.

The Executive Officer asked for the Board's position on the exemption of loss prevention officers from Act 208 (SLH 2010). Mr. Chang said that he was caught by surprise when he attended the House committee on Consumer Protection & Commerce for the hearing on SB2486SD1. He strongly feels that loss prevention officers should not be exempt from Act 208 because they do the most citizen arrests and deal daily with search and seizure laws and they should be trained and registration required.

The Executive Officer added that at its August 15, 2013 meeting, the Board determined that loss prevention officers are subject to the requirements of HRS chapter 463-10.5.

It was moved by Mr. Chang, seconded by Vice Chairperson Yabuta and unanimously carried to oppose the exemption of loss prevention officers from the requirements of HRS chapter 463-10.5.

Scope:

a. Email from Elizabeth Davies from Rogue Atlas Company requesting Board confirmation that a license is not required for their reality show Private Investigator..

The Board reviewed Ms. Davies email inquiry regarding the conflicts, if any, for the cast of licensed private detectives that will

be taking part in the TV program, "Hawaii 5". Based solely on the information provided in the email, the Board determined that airing actual case investigations will require cast members to be licensed as defined under Hawaii Revised Statute ("HRS") section 463-1 or Hawaii Administrative Rules ("HAR") section 16-97-2.

1. HRS section 463-1:

"Detective", "private detective", or "investigator" means a licensed person qualified to obtain information and evidence not readily or publicly accessible."

2. HAR section 16-97-2:

"Detective" means a person licensed under chapter 463, HRS, and this chapter and who for any compensation or consideration obtains information and evidence not readily or publicly accessible with reference to any of the following matters, notwithstanding the fact that other functions and services may also be performed by the same person for fee, hire, or reward:

- (1) Crime or wrong done or threatened or assumed to have been done or threatened against the government of the United States of America, or any of its states, territories, or possessions;
- (2) The identity, habits, conduct, movements, whereabouts, affiliations, associations, transactions, reputation, or character of any person, association, organization, society, or groups of persons, firms, or corporations;
- (3) The credibility of witnesses or other persons;
- (4) The whereabouts of missing persons;
- (5) The location, disposition, or recovery of lost or stolen property;
- (6) The causes and origin of, or responsibility for, fires, accidents, damage, injuries, or losses to persons, firms, associations, or corporations, or to real or personal property;
- (7) The affiliation, connection, or relation of any person, firm, or corporation with any organization, society, association, or with any official member or representative thereof;
- (8) The conduct, honesty, efficiency, loyalty, or activities of employees, agents, contractors, and subcontractors; or
- (9) The securing of evidence to be used before any investigating committee, board of award, board of arbitration, or in any civil or criminal trial.

The terms do not include any lawful activity of any board, body, commission, agency, state, territory, or possession of the United States, or any political subdivision thereof, or any officer or employee employed solely, exclusively, and singly by an attorney or law firm when engaged in the employer's business; or any person, firm, association, or corporation conducting any investigation solely for its own account."

In addition, although the licensed private detectives may not be receiving compensation directly from clients (i.e., they are not being compensated in the traditional manner), if they receive some form of compensation or consideration from the producer/program, they will need to be licensed. The Board also determined that there should not be any conflicts for licensees; provided that the licensees perform the investigations in compliance with the laws and rules of the Board.
