Call to Order:	There being a quorum present, the meeting was called to order by Chairperson Nowak at 1:30 p.m.

Unfinished Business: a. House Concurrent Resolution No. 201, H.D. 1

House Concurrent Resolution No. 201, H.D.1 ("HCR 201") urges the Department of Commerce and Consumer Affairs and the Hawaii Psychological Association ("HPA") to develop draft legislation which would establish, implement, and monitor continuing education requirements for all licensed psychologists in the Hawaii.

Alex Santiago, Executive Director, HPA and Jeffrey Stern, Ph.D., Chair, HPA, Continuing Education Committee appeared before the Board to discuss the above mentioned measure.

> Executive Officer Quiogue informed members that she and Mr. Santiago would need to meet to discuss draft legislation which would be presented to the Board at its November meeting. She went on to say that this Board meeting would serve as means for HPA and the Board to discuss and answer any questions it may have regarding this matter.

Chairperson Nowak asked Mr. Santiago and Dr. Stern for an update regarding the draft legislation.

Dr. Stern indicated that the HPA's Committee on Continuing Education ("Committee") is planning to meet later in the week to discuss this matter and to draft language for a bill. He went on to say that Mr. Santiago had provided the Committee with members' questions from its September 20, 2013 meeting, which included the following:

> 'Chairperson Nowak inquired whether NASW conferences would meet the CE requirements for psychologists. She also inquired whether conferences for any health related profession would meet the CE requirements.'

In response to these questions, Dr. Stern indicated that organizations such as the NASW or ASWB may meet the requirements for continuing education. However, the Board would ultimately be responsible for approving such courses.

Executive Officer Quiogue reminded members and guests that based on the previous discussion at the September 20, 2013 meeting, she was under the impression that courses would be previously approved by a particular organization or organizations. She went on to say that because the composition of the Board changes, it would be difficult administratively to track what was/is approved by the Board. To remain consistent, the CE courses/providers should first be approved by an organization such as the APA or HPA as it has established guidelines in place.

Dr. Stern referred to Dr. Peter's question regarding whether there will be conferences specific to only psychologists.

Dr. Stern indicted that in general, conferences sponsored by the HPA are open to a number of professions, with sessions specific to psychologists.

Dr. Stern expressed his concern that by allowing only approved APA or HPA courses/providers it would be restrictive to some of the neighbor island licensees.

Dr. Adam-Terem answered that there are numerous approved courses provided by the American Psychological Association ("APA") and the HPA. She indicated that in Hawaii there are a total of three (3) approved providers.

Executive Officer Quiogue stated that based on her research, there are also APA approved providers in Canada, Europe, and Puerto Rico.

Dr. Stern referred to Dr. Combs' statement and question, which states that:

'Draft legislation would include recognizing CEs from: teaching university level classes, authoring articles, chapters and books, preparing for (updating literature) and making presentations, and attending continuing medical education or other appropriate offerings. Dr. Combs questioned whether the Board would be responsible for reviewing these types of activities.'

Discussion followed. Executive Officer Quiogue indicated that ultimately the Board would be responsible to review these types of activities.

Dr. Stern referred to DAG Wong's question regarding 'which state would HPA like to mirror regarding its CE requirements?'

Discussion followed. Dr. Stern indicated that the Committee had no preference.

DAG Wong entered the meeting room at 1:36 p.m.

Mr. Santiago expressed similar concerns as Dr. Stern in that neighbor island licensees would have limited access to fulfilling their continuing education requirements.

Executive Officer Quiogue reminded members and guests that that at its September 20, 2013 meeting, it was her understanding that courses would be offered in a number of formats including both in-person conferences and online.

Dr. Peter suggested that courses be sponsored only by nationally accredited agencies/organizations specific to psychology. She went on to say that if the purpose of CE is for professional development, then it should be specific to psychology.

Mr. Santiago indicated that the draft legislation needs to be clear

	about who is an approved course provider.		
	Dr. Combs asked how many licensees would be selected for the audit.		
	Executive Officer Quiogue answered that the Board would randomly audit between five (5) and ten (10) percent of psychologists who hold active licenses.		
	Dr. Stern indicated that one of its members of the Committee suggested only auditing licensees who had deficits with ethics and/or professionalism.		
	Chair Nowak and several members expressed their concern with this suggestion.		
	Dr. Combs indicated that the approved courses should also include other organizations that are not affiliated with APA or HPA.		
	Discussion followed. Executive Officer Quiogue stated that the Board must make a decision regarding whether: 1) it would be responsible for reviewing and approving all sponsors/courses for CE; or 2) it would specify an organization(s) to approve sponsors/courses.		
	After further discussion, the Board determined that each licensee shall complete 20 credit hours of CE every 2 years to satisfy the continuing education requirements. The Board also stated, and guests agreed, that acceptable CE courses shall be approved by the APA, HPA, or other state or provincial psychological association.		
	Mr. Santiago and Dr. Stern left the meeting room at 2:25 p.m.

		Information regarding Education and Training: Changes in the Sequence of Training Leading to Licensure was distributed amongst members for informational purposes only.
	C.	Email dated September 16, 2013 from Gina Reyes, Psy.D. regarding licensure eligibility
		Members reviewed an email from Gina Reyes, Psy.D. dated September 16, 2013, regarding licensure eligibility.
		In particular, Dr. Reyes asked whether her doctoral degree in clinical psychology from Alliant International University (APA accredited in Clinical Psychology) would meet the Board's requirements. Furthermore, Dr. Reyes proposed to complete an additional 329 hours of pre-doctoral hours (to arrive at the 1900 hours) at the Hawaii Guidance Center.
		Discussion followed. Members instructed its Executive Officer to advise Dr. Reyes of the following, that her:
		 Doctoral degree in clinical psychology obtained at Alliant International University (APA Accredited in Clinical Psychology), meets the requirements of §465-7, Hawaii Revised Statutes ("HRS") and §§ 16-98-8 and 16-98-9, Hawaii Administrative Rules ("HAR"). However, because Dr. Reyes' pre-doctoral internship experience consisted of 1,571 hours, the Board determined that she would not meet its requirements for licensure. In order to meet the Board's requirements, Dr. Reyes would have to re- specialize and obtain any additional hours of pre-doctoral internship experience during the re-specialization program. Members noted, as did Dr. Reyes, that she is not eligible for a re-specialization program because she holds a degree in Clinical Psychology. Proposal to complete an additional 329 pre-doctoral hours
		after the conferment of her doctoral degree cannot be

granted. Any hours obtained after the conferment of a doctoral degree would be considered post-doctoral experience.

Members suggested that Dr. Reyes consider one of its other methods of licensure, such as holding a current: Certificate of Professional Qualification in Psychology (CPQ); Health Service Provider Credential issued by the National Register of Health Service Providers in Psychology (NR); or diplomate certificate in good standing granted by the American Board of Professional Psychology (ABPP).

d. <u>Request for Informal Opinion: Proposal of Postdoctoral</u> <u>Experience of Natasha Shanahan, M.A., Psy.D. and Michelle</u> <u>Fukumoto, M.A., Ph.D.</u>

> Members reviewed a letter from Natasha Shanahan, M.A., Psy.D. and Michelle Fukumoto, M.A., Ph.D. dated October 5, 2013 requesting an informal opinion regarding possible postdoctoral work for the year 2013-2014 under the supervision of Donna Goodwin, Ph.D.

> After discussion, the Board informally opined that the proposed postdoctoral experience would meet the Board's requirements as set forth in its statutes and rules.

Lastly, the Board advised that this response is an unofficial, nonbinding opinion in accordance with Hawaii Administrative Rules §16-201-90. It is not an official opinion or decision, and therefore, is not to be viewed as binding upon the Board or the Department of Commerce or Consumer Affairs.
