Executive Officer's
Report:

a. Prov Testing Services

The Executive Officer reported that this company is willing to develop and administer the board's license exams, however the Licensing Administrator must submit requests for proposals and follow procurement procedures. The Professional Vocational Licensing division shall first solicit proposals for multi-area licensing exams as a bundle because some areas have small numbers and the costs of exams would be great since there are less candidates over which to spread costs. The Executive Officer will keep the board apprised of the status.

b. Legislation Update

The Executive Officer informed the board that Senator Kidani is contemplating introduction of a bill to allow guard employee registration applicants to work prior to review and approval. We tried to explain that this would be an administrative nightmare to track and to determine who is appropriately registered. It was manageable in 2013 because there was an end date. Only those who applied on or before July 1, 2013 would be allowed to work until the Board could review.

The deficiencies slow down the licensing process and the employers should be more involved in shepherding the application and making sure all required documents are submitted with the application. Any deficiency adds about 10-15 days to the process.

a. Initial 8 Hour Security Guard Training Curricula

- 1) Classroom Definition (Deferred from the April 16, 2015 meeting.)

It was discussed that the use of Skype for training is real time, interactive and verifiable. After further discussion it was moved by Chief Perry, seconded by Mr. Chang and unanimously carried to defer discussion on the definition of classroom.

b. Background Check Reports

The Executive Officer informed the Board that there have been more background checks reflecting "DAG", "DANC" and "Probation". While still a non-conviction does the Board want to request additional information for these results? Chairperson

Inouye informed the Board that the intent of the DAG and DANC plea is to give the individual a second chance provided the individual stays clean. It is not a conviction. The statutory authority gives the Board the ability to ask about convictions. As these DAG and DANC pleas are not yet convictions, he feels the Board should not request additional info at this time. If the applicant is subsequently convicted, then the Board has the authority to question and review the conviction. The Executive Officer indicated that the subsequent conviction should be reported on a renewal. Of course it may not be caught if the registrant is not truthful. The Executive Officer informed the Board that this concern will be addressed because the Feds will be doing wrap backs where if someone reoffends the Board will be notified. This is currently in the works; however not yet complete. The Board will be apprised when this service is initiated.

It was moved by Chief Perry, seconded by Mr. Chang and unanimously carried that DAG and DANC pleas are not convictions and the applicant is correct in answering "NO" to any conviction and would not be required to provide additional statements or court documents until such time, if any, a conviction is entered. Hence DAGs or DANCs will not slow or preclude guard employee registrations.
