Approval of the February 11, 2015 Meeting Minutes:

It was moved by Dr. Chun, seconded by Dr. Taketa-Wong, and

unanimously carried to approve the May 6, 2015 Meeting

Minutes as circulated.

RICO Naturopathy

Advisory Committee:

RICO requests that the Board review and approve RICO's Naturopathy Advisory Committee list and addendum language

for the 2016 term. It was moved by Dr. Chun, seconded by

Dr. Taketa-Wong, and unanimously carried to approve the list and

addendum language.

#### Old Business: a. Natural childbirth

Members reviewed the Oregon law for requirements for certification of naturopathic physicians to practice natural childbirth provided by Dr. Taketa-Wong.

Dr. Taketa-Wong stated that the Hawaii Society of Naturopathic Physicians is still interested in proposing rule amendments.

Executive Officer Cabral indicated that amendments would have to be done at the legislature.

Dr. Taketa-Wong suggested that the Board needs specification/additional proof of training (midwifery) training program. She also suggested that the Board needs specific requirements such as those established in Oregon.

She indicated that the midwifery training program requires additional education and is an optional certification.

Dr. Gibson would like to have this issue vetted more with HSNP.

This matter will be discussed at a later meeting.

# New Business:

### a. <u>Increasing the Number of Public Members</u>

The Legislature is asking each Board to provide an opinion on whether or not the public member representation on the board should be increased.

After some discussion, it was the consensus of the Board that there is no need to increase the public member representation. However, should it be increased, the Board is open to a percentage of perhaps 60% NDs and 40% public members

#### b. Intrauterine Devices

The Board received an inquiry regarding whether naturopathic physicians are permitted to administer and insert intrauterine devices.

At its August 29, 2014 board meeting, members informally opined that prescribing contraceptive devices falls within the definition of

"naturopathic medicine" as defined in Hawaii Revised Statutes ("HRS") section 455-1.

After discussion, it was the Board's consensus and informal opinion that administering and inserting contraceptive devices falls within the definition of "naturopathic medicine".

#### c. Rules revisions

A draft of the proposed administrative rules on Continuing Education was distributed to members for their review and comments.

Members discussed whether continuing education courses approved by other state boards and associations would be approved by the Board.

After discussion, it was moved by Dr. Taketa-Wong, seconded by Dr. Chun and unanimously carried to revise the rules to include the American Chiropractic Association, the Federation of State Boards of Physical Therapy, and the licensing state associations of the following: the American Association of Naturopathic Physicians, American Medical Association, American Osteopathic Association, American Chiropractic Association, and Federation of State Boards of Physical Therapy.

# d. <u>Accredited, degree granting institutions as continuing education providers</u>

The Board received a request that it include accredited colleges of Naturopathic Medicine in the list of approved organizations to provide continuing education.

After discussion, the Board determined it would include accredited colleges of Naturopathic Medicine in its proposed administrative rules.

# e. <u>August 20, 2015 email from Grace M. Vo regarding</u> naturopaths prescribing physical therapy

The Board received an inquiry regarding whether naturopathic physicians can prescribe physical therapy.

After discussion, it was the Board's consensus and informal opinion that prescribing physical therapy falls within the definition of "naturopathic medicine".

# Naturopathic Formulary:

# a. <u>Corlanor</u>

The Board received an inquiry regarding whether Corlanor would fall under the naturopathic formulary for cardiovascular agents.

After discussion it was moved by Dr. Taketa-Wong, seconded by Dr. Chun, and unanimously carried to determine that Corlanor does not fall within the medication listed on the naturopathic formulary.

a. NABNE August 4, 2015 Advisory Council Meeting Minutes

The NABNE August 4, 2015 Advisory Council Meeting Minutes were distributed to the members for their information.

#### Announcements:

Chairperson Gibson indicated that the Hawaii Society of Naturopathic Physicians ("HSNP") intends to submit legislation on requiring insurers to provide coverage for services provided by licensed naturopathic physicians. HSNP had also intended to submit legislation to authorize naturopathic physicians to prescribe testosterone. However, a bill was introduced to allow naturopathic physicians to prescribe controlled substances, with the exception of narcotic drugs.

The Board discussed the potential legislation and agreed that naturopathic physicians should be able to prescribe testosterone. The Executive Officer asked whether other controlled substances

should be included in the formulary. The Board felt that testosterone would suffice.

Executive Officer Cabral requested that the Board create a legislative committee to testify during the legislative session.

The members decided that Drs. Gibson, Taketa-Wong and Chun would represent the Board as its legislative representatives.
