Executive Officer's Report:

a. DCCA Disciplinary Actions June 16, 2017 and July 21, 2017

EO Matsushima passed around a copy of the DCCA Disciplinary Actions for release, dated June 16, 2017 and July 21, 2017, for the Board's review.

EO Matsushima reported that there were no DCCA disciplinary actions relating to speech pathologists or audiologists in May and June of 2017.

b. Geo Report – Current Number of Licensees

EO Matsushima briefed the Board on the number of Audiologist and Speech Pathologist licensees as of July 20, 2017.

As of July 20, 2017, there were a total of 93 audiologists, 724 speech pathologists and a total of 817 licensees for this Board.

c. <u>RICO Speech Pathology and Audiology ("SPAU") Advisory</u>
<u>Committee and Addendum to Committee List Effective January 1,</u>
2018

After some discussion, it was moved by Ms. Yatogo, seconded by Dr. Ching, and unanimously carried to approve those licensees on RICO's SPAU Advisory Committee list and Addendum language for the 2018 term.

Old Business:

a. Continuing Education ("CE") Requirement Discussion on research conducted by the audiology profession of a possible CE requirement for audiologist licensees in Hawaii

Executive Officer Matsushima asked Chairperson Uyehara-Isono if she had anything further to discuss regarding the status of their efforts in pursuing the CE requirements for licensed audiologists.

Chairperson Uyehara-Isono stated that they have done a cursory survey of 44 audiologists in Hawaii. The consensus is that CE is

needed and accepting 10 hours per year is reasonable. They are trying to get CEs approved by the American Speech-Language-Hearing Association ("ASHA") or American Academy of Audiology ("AAA") but there are many ways to get required CEs. She has spoken to a lobbyist who felt it may be fruitful to do a 100% audit instead of a 10% audit. She noted even industry workshops are sanctioned by the AAA. Hawaii is one of three states that does not require CEs.

EO Matsushima asked if all ASHA and AHA courses are related to the audiology profession.

Chairperson Uyehara-Isono said no. The Board could get strict about course content but it would be more difficult for licensees to find acceptable courses. She feels as long as AAA considers it part of the CE requirement, they will sanction the course and issue a certificate. She believes ASHA is the same way. CE is not retroactively approved. She noted that last year she went to a tinnitus workshop and she did not get any credit because the workshop was not approved. They are hoping to bring the issue to the Legislature in the 2019 session.

New Business:

a. <u>Correspondence from the American Academy of Audiology ("ACAE")</u> regarding accrediting audiology programs

The Board reviewed a letter from the ACAE asking the Board "to verify that the Hawaii Board of Audiology formally recognizes the ACAE as an accrediting body for the purposes of accrediting audiology programs from which potential licensees may graduate". The ACAE is requesting that the Board issue a response "affirming ACAE's status as a recognized accrediting body of audiology programs."

Chairperson Uyehara-Isono stated that ACAE is a division of AAA which does academic accreditation. ACAE certifies programs and are trying to increase standards in the available programs. She believes this is something the Board needs to support.

EO Matsushima said she believes the Board only recognizes ASHA and AAA.

Chairperson Uyehara-Isono said ACAE is a division of AAA, however, they only accredit audiology programs.

Mr. Belcher asked which organizations currently accredit audiology programs.

Chairperson Uyehara-Isono stated that ACAE and ASHA accredit audiology programs. She noted a lot of ASHA programs are umbrella programs that include both speech pathology and audiology programs, however some schools only have either a speech pathology program or an audiology program, not both. She questioned ACAE's purpose of asking the Board for formal recognition as an accrediting body.

EO Matsushima questioned whether the Board can formally recognize ACAE as an accrediting body.

Chairperson Uyehara-Isono noted that ASHA and AAA are already recognized by the Board.

EO Matsushima noted that ACAE does not appear to be recognized by the U.S. Department of Education ("DOE"). She reported that HAR §16-100-20 states that an applicant shall be a graduate of a college or university that is accredited by a regional or specialized accrediting body recognized by the U.S. DOE.

Dr. Ching noted that ACAE's letter states that they are recognized by the Council on Higher Education Accreditation ("CHEA"). He asked if that would make a difference.

EO Matsushima said she does not believe that CHEA is part of the U.S. DOE.

EO Kobashigawa noted that generally, every profession has an accrediting body. All of them should be approved by the U.S. DOE.

Chairperson Uyehara-Isono stated at one time, both professions were under ASHA. Then they split and AAA was created. AAA is fairly new and they have developed their own curriculum. The programs have been revamped to meet needs from Master's Degree to the Doctorate. Some schools have accreditation from both ASHA and AAA. The problem is that ACAE has not been around long enough to establish themselves as an accrediting body for audiologists by themselves.

Upon a motion by Ms. Yatogo, seconded by Ms. Hu, it was voted on and unanimously carried to notify the ACAE that pursuant to

HAR §16-100-20 Requirements for licensure by examination, an applicant shall be a graduate of a college or university that is accredited by a regional or specialized accrediting body recognized by the U.S. Department of Education. Therefore, the Board will not affirm ACAE's status as an accrediting body of audiology programs.

Dr. Ching moved to nominate Dr. Uyehara-Isono as Chairperson and Ms. O'Brien as Vice Chairperson. Mr. Belcher seconded the motion. It was voted on and unanimously carried.
