# Mr. Brady left the meeting at 11:47.

#### **New Business:**

a) Garen Deweese, Government Relations Manager, Hawaiian Electric Company's Proposal to Extend the 5 Year Sunset Date for Act 65, Session Laws of Hawaii, 2013 for Another 5 Years.

Mr. Deweese stated the Hawaiian Electric is going to propose to extend the Sunset Date for Act 65, Session Laws of Hawaii, 2013, for another 5 years. Mr. Deweese explained that Act 65, Session Laws of Hawaii exists to allow utility companies such as Hawaiian Electric to hire contractors to perform high voltage electrical work in case of natural disasters or other emergencies in order to restore power as soon as possible.

Chair Akamu inquired whether Hawaiian Electric had a vetting process in place to insure that the workers are qualified and properly supervised. Mr. Deweese responded that he would have to check and get back to the Board with this information.

Mr. Deweese also informed the Board that whenever high voltage work is required by the State and an outside contractor is brought in by Hawaiian Electric under the licensing exception, the contractor is licensed in another State.

#### Chair Akamu called for a ten minute recess.

b) Keali'i Lopez, Director of Government Relations, Alston Hunt Floyd & Ing, 2018, Legislative Proposal Regarding Exemption for High Voltage Electrical Work.

Ms. Lopes stated that they intend to introduce a proposal similar to Hawaiian Electrics. She sought the Board's input on the proposal and welcomed any comments or question the Board members might have.

Ms. Lopes related the proposal as follows:

Hawaii Revised Statutes Chapter 448E Electricians and Plumbers §448E-14 Exemption for high voltage electrical work: (a) employees of an electrical contractor duly licensed under chapter 444 shall be exempt from this chapter; provided that:

- (1) Such contractor is retained to perform high voltage (six hundred volts or higher) electrical work; and
- (2) Such employees are deemed qualified to perform such high voltage electrical work; provided further that such persons shall be certified through an apprenticeship program authorized by the United States

> Department of Labor's Employment and Training Administration or Hawaii State Department of Labor and Industrial Relations to perform such high voltage electrical work.

(b) Persons retained pursuant to paragraph (a) shall be exempt from the provisions of section 444-9.5.

She added that the concomitant proposal would be submitted for the contractors licensing law.

Ms. Lopes further stated that journeymen linemen are not licensed in the State of Hawaii and, in general, very few states license journeymen linemen.

c) Discussion Regarding Journey Worker Photovoltaic/Solar Electrician License Category.

Board members agreed by consensus to defer this matter until the next meeting.
