## Old Business:

a. Proposed Rule Revisions, HAR Title 16, Chap. 72 Subchapters 1-11

Dr. Kroll suggested that the Board work on the non-controversial topics so the Board can get through those quickly. The controversial topics are animal acupuncture, lab tests, diplomat status, and Continuing Education Units ("CEU's").

The Board discussed and clarified the definitions listed below:

- "Traditional Oriental Medicine", also known as East Asian Medicine, is a complex system that identifies the pattern of disharmony in each patient then builds an individualized treatment plan utilizing Acupuncture techniques and herbal formularies.
- Leave "Acupuncture" as a definition in the statute.
- "Herbal Medicine" can be a formula or single herbal remedy to promote, maintain and restore health. It includes the use of naturally occurring substances of botanical, animal or mineral origin in accordance with Good Manufacturing Practices (GMP) guidance. It does not include controlled substances.
- "Laser Acupuncture" utilizes a Class II Low Level FDA approved cold laser, to promote biological function, regenerate tissue, reduce inflammation and alleviate pain.
- "Moxibustion" means heating moxa on meridians or points on the body to produce analgesia, support the immune system and modulate bodily systems.
- "Auricular Acupuncture" is a diagnostic and treatment system that stimulates specific acupuncture points with needle insertion, magnets or pellets on the external ear surface to stimulate the autonomic nervous system, control pain, and support detoxification.
- "Cupping" is a therapy in which cups are applied to the body either
  with heat or manual suction as a way of improving circulation and
  relieving muscle pain. "Wet Cupping" involves the intentional bleeding
  of the skin prior to cup application and can only be performed by a
  licensed acupuncturist.
- "Lifestyle and Dietary Consult" incorporates Oriental Medicine concepts of food as medicine, a concept that emphasizes the

importance of a food's character with balanced food consumption, as well as herbal and nutritional supplements, environmental, meditation, movement and exercise.

 "Acupuncture Needle" is an FDA approved Class II medical device; a sterile needle of various lengths and gauges, tapered to a sharp point on one end for piercing or non-invasive stimulation of the skin, with one end for manipulation or maintaining the needle in place and inserted by an acupuncture practitioner on a human body.
