2018 Legislature

HSCFN – Healthcare Provider Preceptor Bill

The EO summarized a draft of the bill as follows:

- Proposes to establish a Health Provider Preceptor Tax Credit Working Group convened by the Hawaii Pacific Region Area Health Education Center (AHEC) and the HSCFN, who among other duties and responsibilities will issue the certification form for tax credit for a nominal fee; and
- Establishes a tax credit for preceptors for up to \$5,000

Ms. Reichhardt stated that only schools located in this State would qualify and that currently, Georgia, California and Maryland have similar laws for preceptor tax credit. She also stated that the preceptor for advanced practice would apply.

Ms. Reichhardt was asked which programs were included in the bill.

She stated that preceptors of medical, advanced practice nursing, advanced dental hygienists, pharmacy and psychology students only.

Mr. Boyer clarified that respiratory care, OTs, PTs, PTAs and EMS preceptors were not included in the proposed bill?

That was confirmed.

The EO asked Ms. Reichhardt about the Health Provider Preceptor Tax Credit Working Group.

Ms. Reichhardt stated that the working group would receive certification from the applicable school or employer that the preceptor is precepting a student or employee. She did mention that the bill will be asking for 2 million to cover the preceptor tax exemption, which they are hoping will not be over that amount and if it does then the working group will have to determine how to issue the certificates before the appropriation is spent.

Amendments to Title 16, Chapter 89 – Status Report

The EO reported that she is working on the memo to the Governor and also working for Licensing Branch to ensure a streamline process for the additional NPDB requirement.

Nursys – Status Report

The EO reported earlier that the Department's IT personnel are working on how to get our information to Nursys.

Continuing Competency

Questions from Dianne Okumura

The Board discussed the following email from Ms. Okumura:

“...if you would be able to assist me in obtaining clarification regarding CEU options. I am providing consultation at various long term settings in the role of "preceptor" in many instances in training of new staff transitioning into a new practice area including but not limited to:

1. Understanding the regulations that apply to a specific health care setting of various positions and impact on the quality of care to be provided
2. Understanding the role of the position that this individual will be moving into with all of the clinical, supervisory, and/or managerial responsibilities and effect on the quality of care of residents/clients/patients.
3. Developing presentations regarding clinical conditions such as dementia, wound care, infection control, etc. and the myriad of regulations that apply to these areas including but not limited to Federal/CMS, State requirements and best practices.

I have read the list of learning opportunities and am looking at #5 and/or #8. Also wondered how #10 would apply as appropriate.

If I do move forward to doing the above, would I need to:

1. Obtain approval from the Board before moving forward?
2. What kind of attestation would be required - is it sufficient for the Administrator of the facility to write a letter indicating what I did and certify that the goals/objectives have been accomplished?

I am currently training staff and have developed a training plan with specific modalities listed, timeline to accomplishment and validation/acknowledgement that staff completed the training and understands, is knowledgeable and able to demonstrate competency.

I would appreciate any assistance you can provide me in obtaining clarification, and if more information is needed, do not hesitate to let me know. thank you very much"

The Board reviewed HRS 457-9.3, assuming Ms. Okumura's reference to #5, #8 and #10 was pursuant to the list of learning activity options.

The EO said the Board previously addressed what kind of documentation would be needed to substantiate the preceptor requirement under #5.

Ms. Kodama stated that besides the preceptor requirement, it appears Ms. Okumura is also asking about the development and execution of a nursing education presentation that would qualify as continuing education ("CE") and therefore as a provider of CE, she will have to obtain provider approval and recommend that we refer her to pages 19 -21 of the Continuing Competency booklet that includes the following information on CE providers:

CE Providers: The following providers of continuing education courses are acceptable:

- a. Nationally accredited nursing schools such as those recognized by but not limited to, the Commission on Collegiate Nursing Education (CCNE) at: <http://directory.ccnecommunity.org/reports/rptAccreditedProgramsNew.asp?sort=institution>
- b. National certifying body
Recognized national certifying body means nurse credentialing agencies accredited by one of the following:
 - 1) American Academy of Nurse Practitioners Certification Board (AANPCB)
 - 2) American Board for Specialty Nursing Certification (ABSNC)
 - 3) American Nurses Credentialing Center (ANCC)
 - 4) Institute for Credentialing Excellence (ICE)
 - 5) National Commission for Certifying Agencies (NCCA)

- 6) National Council of State Boards of Nursing (NCSBN)
- c. And organizations recognized by the board which include, but limited to:
 - 1) Council on Certification of the National Board of Certification and Recertification for Nurse Anesthetists
 - 2) Council on Certification of the American College of Nurse Midwives
 - 3) Gynecologic and Neonatal Nursing Specialties
 - 4) National Certification Corporation for Obstetric
 - 5) Pediatric Nursing Certification Board
- d. Or any new national certifying body or a national certifying body which is a successor to any organization accredited by the NCCA or ABSNC and recognized by the board. Any modifications by the national certifying bodies, the NCCA, or ABSNC shall apply unless otherwise provided in the board's policy and board's rules.
- e. Local and National nursing or other professional associations recognized by the Board that include but is not limited to:
 - 1) Accreditation Council for Continuing Medical Education (ACCME);
 - 2) American Nurses Association (ANA);
 - 3) American Nurses Credentialing Center (ANCC)
 - 4) Accreditation Council for Pharmacy Education (ACPE);
 - 5) Joint Accreditation for Interprofessional Continuing EducationTM (IPCE) which is simultaneously endorsed and accredited by ACCME, ACPE, and ANCC.
 - 6) National Council of State Boards of Nursing (NCSBN);

The Board recommends that facilities that offer training in-house have the program accredited/approved by a national certifying body or a Board recognized professional association.

Continuing education approved by another State Board of Nursing is not acceptable.

College courses which are applied toward nursing degree completion such content offered in basic nursing education programs, can be used to satisfy the requirements of "contact hours." Independent study course work can be applied toward State competency requirements if course work is directly related to healthcare and/or to your area of specialty. Potential courses include but not limited to:

- Adult education or adult learning principles
- Biology, anatomy, physiology, or behavioral science
- Culturally competent care
- Disaster preparedness
- Ethics or legal aspects of nursing
- Evidence-based nursing practice

- Health care compliance
- Health care trends, issues, or policies
- Health informatics
- Health/physical assessment
- Medical terminology for health care providers
- Nursing education or research
- Nursing management/administration
- Pathophysiology

CE Documentation: Upon completion of the CE course, please make sure you receive a completion certificate. No credit will be given for CE courses if the completion certificate does not indicate the name of the course, provider, date completed and CE hours.

You are required to maintain your CE completion certificates for at least two bienniums (four years). If you are audited, you will be required to submit the CE documentation within sixty (60) days upon receipt of the notice. If you moved and failed to notify us of your current address, the Board will proceed with appropriate action (disciplinary action) as if you received the notice but failed to respond.

It was the consensus of the Board to inform Ms. Okumura of the preceptor documentation requirements and to refer her to the requirements of developing and presenting a CE course.

Working Solutions, October 2017

The Board was provided a copy of the November 2017 edition of Alliance Work Partners for articles on “Learn To Be More Attentive” and “Psychological Safety at Work”.

Legislative Updates

The EO reported on the following:

- 12/1/17 – Bills enacted: MI – provides for the registration of nurse aides; US H – clarifies that certain CS may be administered by EMS practitioners, including APRNs and Pas, pursuant to a standing order by the medical director or an EMS agency; NY – directs the Civil Service Commission to produce a report on the job title of nurse practitioner, including equitable compensation and opportunities for career advancement.

Bills introduced: PA – establishes the office of Chief Nursing Officer of the Commonwealth to be appointed by the Governor; PA – amends the Medical Practice Act to provide that CRNAs must be supervised by a

physician or supervised student nurse trainee when providing anesthesia care.

- 12/8/17 – Bills enacted: NY – directs the Civil Service Commission to study and produce a report on equitable compensation and opportunities for career advancement for CNPs.

Bills introduced: NJ – require practitioner to check prescription monitoring information before issuing a prescription for a schedule II CS to an ER patient; NJ – allow APRNs with certain training requirements to dispense narcotic drugs for maintenance of detoxification treatment if their collaborative agreement includes the physician's approval for them to do so; NJ would expand the list of CS that require practitioners to check prescription monitoring information before prescribing; US H – require additional registration requirements for prescribers of opioids to restrict schedule II and II opioid prescriptions. The bill also requests the submission of two studies: one from the Comptroller General on any changes to health care policy that may have contributed to the opioid epidemic over the past decade and one from the Commissioner of Food and Drugs on the feasibility of replacing statutory limits on the prescribing of opioids with clinical guidelines; NJ – allow for a period of up to 6 months for an applicant for license endorsement to submit documentation of an out-of-state license in good standing to the licensing board if applying from a state that has recently experienced a natural disaster or other catastrophic event; NJ – would establish reciprocity requirements, including background checks, for out-of-state certified nurse aides and personal care assistants to practice in NJ by endorsement; WI – would create the Council on Offender Employment, which may issue a certificate of qualification for employment to certain people who have been convicted of a nonviolent crime to assist in opportunities for employment, licensing, or occupational certification.

Bills sent to the Mayor: DC – give APRNs signature authority similar to a physician.

- 12/15/17 – Bills enacted: WI – Wisconsin is the 27th state to join the eNLC; IL – requires prescribers with a CS license to register with the Prescription Monitoring Program. The bill also requires documentation in the patient's medical record when providing an initial prescription for a schedule II narcotic.

Bills introduced: US S – makes changes to veterans' health care, including the ability of providers to use telemedicine and requirements for the prescription of opioids; WI - makes changes to the ability of a licensing to deny an applicant's license based on their criminal record or certain pending criminal charges.

Bills sent to the Governor: MI – requires a bona fide prescriber-patient relationship before prescribing schedule II – V CS and also allows the various health care occupational licensing boards, including the board of

nursing, to define the terms of that relationship; MI – requires the same prescriber-patient relationship, as well as requiring the use of an electronic monitoring system for certain prescriptions of schedules II – V CS; MI – requires record review and reporting for the dispensing and prescribing of buprenorphine or methadone to a patient in a substance use disorder program.

- 12/22/17 – Bill enacted: NY – requires all registered professional nurses to have or obtain a bachelor's degree within ten years of initial licensure. This requirement does not apply to current licensees or students enrolled in an educational program for RNs as of the effective date.

Bills that were introduced: NJ – requires a pain management agreement with a patient prior to the prescription of certain CS. This bill also adds to the circumstances under which a practitioner is required to access prescription monitoring information. WI – requires the Technical College System Board to make grants to district boards in nurse aide shortage areas for the purpose of expanding access to nurse aide training. WI – creates an individual income tax credit for CNA training costs. WI – prohibits a political subdivision from imposing occupational licensing requirements on any profession that are more stringent than state requirements; NJ requires occupational licensing boards to provide an online processing system for licensure and certification applications and renewals.

Bills sent to the Governor: MI makes changes to requirements for prescriptions of CS, including requiring registration with the with the prescription monitoring program. The bill also waives the requirement for a CS license in the case of administration by a PN or RN or the dispensing of methadone in a treatment program.

Article “New York raises bar for nursing students”

A copy of the article was distributed to the Board members for their information. This new law would require that nursing students obtain a bachelor's degree within 10 years of obtaining their registered nurse license. Current enrollees of nursing programs and current licensed RNs would be exempt from having to meet the bills requirement.

The EO asked Mr. Reichhardt if such legislation was being proposed in Hawaii.

Ms. Reichhardt stated that they anticipate that by 2020, 80% of Hawaii's nurses will have a BSN so there is no immediate concern to introduce legislation at this time.

Next Generation NCLEX Project

The EO reported that the NCSBN is conducting a study to determine whether clinical judgement and decision making in nursing practice can be reliably

assessed through the use of innovative item types. The Next Generation NCLEX project or NGN consists of several phases of research. In July 2017, a Special Research Section ("SRS") was part of the NCLEX-RN administration. The SRS was given to select candidates taking the NCLEX-RN and was administered after the regular exam and did not count as part of the NCLEX score. By participating in the SRS, candidates are making valuable contributions to the future development of NCSBN examinations as well as to the enhancement of the nursing profession.

Joint Commission's "National Patient Safety Goals Effective January 2018"

The Board members were distributed a copy of the goals for their information.

Hawaii State
Center for Nursing:

Ms. Reichhardt reported that on December 27, 2017, HSCFN released information from their 2017 Nursing Workforce Report that indicates that the number of APRNs licensed in Hawaii has more than doubled since 2005. The report also revealed the developing shortage of LPNs in the State, a shortage that will most severely impact long-term and residential care facilities.

Executive Session:

At 11:45 a.m., upon a motion by Ms. Napoleon, seconded by Ms. Daub, it was voted on and unanimously carried to move into Executive Session in accordance with HRS, 92-5(a) (1) and (4), "To consider and evaluate personal information relating to individuals applying for nurse licensure;" and "To consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities".

At 12:16 a.m. upon a motion by Ms. Daub, seconded by Ms. Napoleon, it was voted on and unanimously carried to move out of executive session.
