After discussion, it was moved by Chairperson McKay, seconded by Ms. Williams, and unanimously carried to approve the minutes of the December 18, 2017 Board meeting, as circulated.

The barber shop and beauty shop applications above were preliminarily reviewed by licensing branch staff, Executive Officer Kai, Executive Officer Cabral, Ms. Williams, and Chairperson McKay (Board members designated to review the barber shop and beauty shop applications for consideration at this Board meeting).

Ms. Williams and Chairperson McKay confirmed that they had reviewed the twenty-eight (28) applications, and determined that they met all requirements for barber shop and beauty shop licenses, and recommends approval.

After discussion, it was moved by Chairperson McKay, seconded by Ms. Severson, and unanimously carried to approve the twenty-eight (28) barber shop and beauty shop applications listed above.

D. Restoration of License

Licensing Examination of The National-Interstate Council of State Boards of Cosmetology ("NIC"):

Chairperson McKay commented that the Board is exploring the possibility of administering the NIC licensing examinations for beauty operators, barbers, and instructors. Mr. Nelson stated that the Board was awaiting a response from Prometric, the current testing proctor of the State written examination, on their possible administration of the NIC licensing exam.

DAG Jayaram commented that the Board has a contract with Prometric; thus, discussion about the NIC exam should be made with them. Mr. Nelson suggested a Prometric representative should attend their meeting and provide an update. Executive Officer Cabral will follow up with Prometric.

Legislation:

A. Senate Bill No. 2354, SD1, Relating to Intimate Partner Violence

Discussion ensued on S.B. 2354, S.D. 1, Relating to Intimate Partner Violence. The bill proposes to require barber, beauty operator, and instructor licensees to complete a one-time, one-hour training program on intimate partner violence awareness and education.

The Board reiterated that this bill is similar to last year's S.B. 518, S.D. 2, of which the Board testified in support of the intent of the bill; however, the Board had identified a number of concerns and questions relating to the specific provisions of the bill. Discussion ensued on those concerns raised, such as that the proposal would elevate the level of responsibility of the licensee beyond their scope of practice, and possible retaliation and additional violence against licensees for being involved in recognizing signs of violence and advising their clients of available resources.

Ms. Severson inquired if the one-hour training program will be made available in another language, as language barriers should be addressed. Chairperson McKay commented that making the training to be mandatory is a "bit much". Mr. Nelson agreed that awareness is great but making it mandatory may be "opening a can of worms".

Discussion ensued on ways the Board may be able to help raise the awareness of the Intimate Partner Violence. The Board suggested a link to the one-hour training webinar could be made available on the Board's website for visitors to their site (which would include licensees and prospective applicants). Ms. Williams suggested loading the webinar on YouTube. Executive Officer Cabral stated she will follow up with the Department Administration whether a link to the webinar would be allowed/possible on the Board's website.

Hawaii  
Administrative  
Rules:

A. Proposed Amendments to Hawaii Administrative Rules  
Chapter 16-78 (Cosmetology )

The Board's Investigative Committee is reviewing possible revisions to Exhibit A "Apprenticeship manual"; Exhibit A with attachments A, B, C, and D; Exhibit C "Apprenticeship Curriculum"; and Exhibit D "Instructor-Trainee Curriculum".

Investigative Committee member, Ms. McKay stated the rules revisions are ongoing. She commented that the aforementioned sections of HAR 16-78 may need further review as she has been apprised that the reporting of monthly training records by beauty shops with apprentices are not maintained by the Licensing Branch, and that some beauty shops are not submitting these records as noted on the section "Beauty Shop Responsibility".

Chairperson's  
Report:

Inquiry regarding Laser Instruction at The Skin Institute Internationale (Massage Establishment License: MAE 3238).

Discussion ensued on a postcard advertisement by The Skin Institute Internationale who holds a current beauty school license, BSC 42, that may be practicing outside their scope of practice by providing laser instruction.

Executive Officer Cabral was instructed to refer the matter to RICO (Regulated Industries Complaints Office).
