Call to Order: The Chair called the meeting to order at 8:31 a.m. at which time guorum was

established.

Chair's Report: Announcements/Introductions

The Board welcomed Mr. Ching.

Approval of the Previous Minutes – March 1, 2018

The Chair called for a motion in regard to the minutes of the March 1, 2018

meeting.

The Vice Chair asked that the minutes be amended to correct his name as Mr. Joslyn and not Mr. Thomas.

There being no further discussion or amendments, upon a motion by Ms. Boyer, seconded by Ms. Daub, it was voted on and unanimously carried to approve the minutes of the March 1, 2018 meeting as amended.

Conferences/Seminars/Meetings

The EO reported on the following conferences:

2018 NCSBN Midyear Meeting, March 5-6, 2018, Chicago, Illinois

Mr. Boyer, Mr. Duldulao and Ms. Kodama reported on their attendance at the Midyear meeting that included sessions and speakers covering topics such a medical cannabis in nursing homes/facilities, midwives regulated by boards of nursing, the nurse licensure compact, and simulation. Mr. Duldulao stated that it was a good opportunity to network with other boards of nursing.

2018 Legislature

The EO reported on the status of the following bills:

HB 1967, HD2/SB 2298, SD1, HD2 - Relating to Healthcare Preceptor Tax Credits HB 1967, HD2 - Allows advanced practice registered nurses, physicians, dentists, psychologists, pharmacists, and social workers to receive tax credits for acting as preceptors in volunteer-based supervised clinical training rotations provided to eligible students that enable the students to obtain an eligible healthcare professional degree or certificate. Establishes the Preceptor Credit Assurance Committee to issue certificates to volunteer preceptors upon verifying that the volunteer preceptors meet the requirements of the tax credit. (HD2)

The House version was in the last committee (FIN) but not scheduled for hearing so unless it is re-referred, this bill will not be moving forward.

SB 2298, SD1, HD2 - Allows advanced practice registered nurses, physicians, dentists, psychologists, pharmacists, and social workers to receive tax credits for acting as preceptors in volunteer-based supervised clinical training rotations provided to eligible students that enable the students to obtain an eligible healthcare professional degree or certificate. Establishes the Preceptor Credit Assurance Committee to issue certificates to volunteer preceptors upon verifying that the volunteer preceptors meet the requirements of the tax credit. (HD2))

The Senate version crossed over to the House and was heard and passed out by the HHS (w/ amendments), CPC (w/ amendments) and FIN (w/ amendments. This bill will go back to the Senate for the Senate to agree or disagree with the amendments made by the House committees.

HB 1906, HD2, SD1/SB 2491, SD2 Relating to Health Care Workers

HB 1906, **HD2**, **SD1** – Makes intentionally or knowingly causing bodily injury to a health care worker a Class C felony. Effective 7/1/2035. (SD1)

SB 2491, SD2 – Makes intentionally or knowingly causing bodily injury to certain health care workers a class C felony. Effective 7/1/2035(SD2)

This bill crossed over to the Senate and was heard and passed out with amendments by both the CPH and JDC. This bill will go back to the House for the House to agree or disagree with the amendments made by the Senate committees.

HB 2375, HD1 & SB 2802, Relating to Temporary Disability Insurance HB 2375, HD1, SD1 – Permits advanced practice registered nurses to certify an employee's disability. Increases the penalty an employer is assessed for failing to submit timely wage and employment information. Permits filing of an appeal of a decision related to temporary disability insurance at the various offices of the Department of Labor and Industrial Relations throughout the State. Allows the department to send notices of hearing electronically or by first-class mail. Clarifies that when the notice of hearing cannot be delivered to a party in the appeal, the notice may be given by online posting on the department's webpage. Allows the parties to a hearing to appear in person, via telephone, or by other communication devices. (SD1)

This bill was heard by the Senate committees on LBR/CPH and JDC. LBR/CPH passed out with amendments, JDC passed unamended.

This bill will go back to the House for the House to agree or disagree with the amendments made by the Senate committees.

HB 2347, HD1 & SB 2774, HD1 - Relating to Insurance

HB 2347, HD1 - Amends various portions of the Hawaii Insurance Code by adopting NAIC model language for corporate governance annual disclosures, establishing a procedure for changes in trade name or an assumed name, and clarifying reimbursement to health insurance providers. Clarifies requirements for reporting and recordkeeping for vehicle protection product warrantors and service contract providers. Makes various housekeeping amendments. (HD1)

House version was not heard by FIN.

SB 2774, SD1, HD1 - Updates various areas of the State's insurance laws to: adopt the NAIC's Corporate Governance Annual Disclosure Model Act beginning on 1/1/2020; allow the Department of Commerce and Consumer Affairs and the Insurance Commissioner to determine whether a request to add or change a trade name or assumed name satisfies certain requirements; clarify certain provider reimbursement requirements; adopt revisions to the Insurance Holding Company System Regulatory Act beginning on 1/1/2020; provide the Insurance Commissioner with additional regulatory authority to supervise or liquidate a captive insurer; enable the Insurance Division to create stopgap measures, until 12/31/2020, to implement the Network Adequacy Model Act; and make various housekeeping amendments to clarify existing language and avoid ambiguities. (HD1)

Senate version crossed over to the House and was heard by CPC (passed w/ amendments) and FIN (passed unamended). This bill will go back to the Senate for the Senate to agree or disagree with the amendments made by the House committees.

<u>SB 2211, SD1, HD2</u> – Relating to Concussions - Expands the scope of the concussion educational program to include middle- and elementary-school students. Appropriates funds. (HD1)

This bill crossed over to the House and heard by HHS< EDN and FIN. HHS and EDN heard bill but was not scheduled for hearing by FIN.

<u>SB 2407, SD1, HD1</u> – Relating to Medical Cannabis - Establishes the Medical Cannabis Study Group to examine the legal issues regarding Hawaii's medical use of cannabis law. (HD1)

Crossed over to the House, referred to HHS, JUD, and CPC. Heard by all House committees, was returned to the Senate. Senate to agree or disagree with House amendments.

HB 2729, HD2, SB 2718, HD2, SD1 Relating to Cannabis for Medical Use – Part I: Establishes a reciprocity process for medical cannabis patients that requires the department of health to register qualifying out-of-state patients and caregivers of qualifying out-of-state patients under certain conditions. Clarifies certain safeguards for qualifying out-of-state patients and caregivers of a qualifying out-of-state patient.

Authorizes the department of health to extend the maximum period of validity of any written certification to three years for debilitating medical conditions that are chronic. Clarifies a dispensary licensee's ability to retest, at its own expense, a batch of cannabis or manufactured cannabis products that do not meet the department of health's standards for patient safety. Prohibits an employer from suspending, discharging, or discriminating against an employee for testing positive for cannabis if the employee is a registered qualifying patient who is authorized for the medical use of cannabis, with certain exceptions. Part II: Allows a bona fide physician-patient or advanced practice registered nurse-patient relationship to be established via telehealth.

Part III: Allows and regulates the manufacturing of edible cannabis products as manufactured cannabis products by licensed medical cannabis dispensaries. Establishes requirements for manufacturing, handling, labeling, and packaging of manufactured cannabis products. Adds certain devices that provide safe pulmonary administration to the list of medical cannabis products that may be manufactured and distributed. Increases the tetrahydrocannabinol limit per pack or container of certain manufactured cannabis products. Part IV: Specifies certain felonies and conditions that will preclude employment, and other felonies and conditions that may preclude employment, at a medical cannabis dispensary. Effective 7/1/2050. (SD1)

Crossed over to the Senate, heard by CPH and WAM, both committees passed with amendments. Went back to the House to agree or disagree with amendments made by the Senate committees.

Amendments to Title 16, Chapter 89 – Status Report

The Board discussed the following amendment being proposed that would further clarify an applicant who is unable to pass the NCLEX for licensure a number of times, regardless of where it was taken or which state or jurisdiction made the candidate eligible, must complete a Board approved remedial course in order to retake the NCLEX.

- §16-89-9 <u>Examination policies.</u> (a) The passing standards for the NCLEXRN and NCLEX-PN examinations accurately reflect the amount of nursing ability currently required to practice competently at the entry level. The passing standards for the NCLEX-RN and the NCLEX-PN shall be established by the National Council of State Boards of Nursing unless otherwise determined by the board.
- (b) Candidates may take the examination [an unlimited number of times], provided candidates register for each examination. Any candidate who fails the license examination three times, regardless of when or where the examination is was taken, and regardless of which state or jurisdiction the candidate was made eligible, shall be required to complete a board-approved remedial course and submit proof of passing the course before the candidate may be approved for reexamination. The candidate shall apply for reexamination within six months after completion of the remedial course. After taking the remedial course, the candidate may be approved to retake the examination up to three additional times before the candidate is required to take remediation again.

The Vice Chair asked what if an applicant/candidate is unable to pass after taking the remedial course.

The EO stated that the applicant/candidate will have to take another remedial course if they cannot pass the exam within three attempts.

The DAG asked if the applicant/candidate applied to retake the exam after six months from completing the remedial course, what happens?

The EO stated that the proposed language requires the candidate to apply within six months after completing the remedial course and if they fail to do so, the applicant/candidate will have to retake the remedial course again if they want to be made eligible to sit for the NCLEX.

There being no further discussion, upon a motion by the Vice Chair, seconded by Ms. Daub, it was voted on and unanimously carried to approve the proposed language that would further clarify the requirements to sit for the NCLEX after failing three times.

Nursys - Status Report

The EO reported that she was recently informed that the IT people anticipate a test extract at the end of April.

Continuing Competency

Receiving volume of inquiries about CE providers

The EO stated that she is getting a lot of inquiries on the continuing education learning activity option, specifically asking if a certain CE course is acceptable.

She's wondering if the continuing competency booklet is not clear enough or perhaps the FAQs need to be expanded to be more specific.

The Chair stated she had one of her co-workers review the continuing education booklet and she did not have any problems understanding the information.

The Vice Chair asked how the Board could help.

The EO asked if the Board could re-review the booklet and make any recommendations.

The Board agreed.

The Vice Chair also asked that the Board revisit the option of accepting continuing education courses approved by other BONs.

<u>CEU Question – One course totaling 34 hours in IV Therapy and Blood Withdrawal</u> The Board discussed the following email inquiry from Vanessa Obando:

"For the CEU compliance for RN licensing. I wanted to know if the class below is acceptable as its accredited by ANCC for 34 hours. Also, does the 34 Hours indicated mean 34 CEUs for Hawaii acceptance?

If the class has ANCC accreditation and classes total over 30 hours/units this should be acceptable, correct? Finally, is it correct that the HI BON will not accept whichever CE class even if it is approved by the CA or NV BRN?"

The EO stated that she already informed Ms. Obando that ANCC approved/accredited courses are acceptable, however, she wanted to bring this to the Board's attention that this course would satisfy the 30 hours of continuing education learning activity option but that it is only on one specific subject so technically the nurse would not have to take any further courses.

After further discussion, the Board decided to defer discussion on this matter.

Developmental Disabilities Nurses Association – Request for Continuing

<u>Education Credit from Department of Health, Developmental Disabilities Division, Outcomes and Compliance Branch, Outcomes Section, Program Services</u>

Evaluation Unit

The Board discussed an email from Kathleen Matsuo, RN with the Department of Health, Developmental Disabilities Division, Outcomes and Compliance Branch, Outcomes Section Program Services Evaluation Unit on a CE course provided by the Developmental Disabilities Nurses Association (DDNA).

Nurses from this division in DOH specifically deal with individuals with developmental disabilities. They are requesting the Board review the information for the Developmental Disabilities Nurses Association conference to see if these courses would satisfy the continuing education hours.

After some discussion, it was the consensus of the Board to accept the courses offered by the DDNA 2018 conference.

Request for Yoga Alliance Certified Teacher Training Course Approval or Extension to Meet Continuing Competency Requirement from Min Lin

The Board discussed the following email inquiry from Ms. Lin:

"I am Margaret (Meg) Lin. I am writing to ask if a course I am taking will fulfill my CE requirements for this next years' license renewal. I am due to renew June 2019.

I am currently working part time as my husband's assistant in his busy OB GYN practice, as a school nurse at Punahou, and as a nurse with HMSA, developing and running the pregnancy support program. (I have had many years of experience as a labor and delivery nurse, a lactation consultant and as a childbirth instructor.) Before I retired from Queens, I was certified as a high risk perinatal nurse.

My problem is this: I have been applying to and was just accepted into a 200 hr. Yoga Alliance Certified Teacher Training that begins in June. I need to read several books/DVD's prior to this series and I will have completed the actual training by the end of July. I believe that this rigorous training satisfies the purpose of continuing education in regular license renewal and I am asking you to look at my curriculum, reading material, audiovisual training and of course, the physical time and money I have already committed to this training. As a nurse at Punahou I teach the puberty class and I would like to add my name to their list of yoga teachers. I specifically have waited and wanted this particular series as it is quite relevant to me as a nurse. There is longevity and integrity to this particular program and I do hope you will see this after looking at the material I have included.

I do not think I could in addition to this training and the three jobs I have, pay for more CE's and devote that amount of time before June 2019. I have paid for this course in full already. (2900.00)

Below, is information regarding this teacher training. I would be most grateful if I could have at least until 2010 if you do not consider this material relevant to nursing."

In additional emails, Ms. Lin also noted that Yoga is now a reimbursable health benefit from most health insurance companies and that the California Board of Nursing recognizes yoga as well as mediation training for CEUs for nurses.

The Board reviewed the information on the course.

Ms. Kim stated that it does not appear that this course meets the definition of "continuing competency" that states:

"Continuing competency" means the long-term educational and professional process by which an individual undertakes and documents with verifiable evidence a personal learning plan that encompasses a periodic self-assessment of personal strengths and weaknesses as present in the individuals practice as a nurse as well as a commitment to furthering the individual's professional knowledge relating to the nursing field."

It was the consensus of the Board that this course is not relative to the nursing field and therefore they would not count this course for credit towards the continuing education hours. The Board also wanted to inform Ms. Lin that there are free online nursing continuing education courses that would meet the continuing education course learning activity option for continuing competency.

<u>Legislative Updates</u>

The following legislative updates from were disseminated to the Board members for their information:2/23/2018, 3/2/2018; 3/9/2018; 3/16/2018 and 3/23/2018. The Board noted that there were a lot of bills introduced regarding opioids.

Scope of Practice

Request from Bala Mohan – LPN, RN, APRN Performing or Using Light and Heat Energy Devices, Chemical Peels, Microdermabrasion, and Dermapen/microneedling, Administering Botox or Cosmetic Laser Treatment as "Cosmetic Treatments

The Board discussed the following email inquiry:

"According to the Hawaii Medical Board Minutes of Meeting from November 13, 2014, "the use of light and heat energy devices; chemical peels; microdermabrasion; and dermapen/microneedling constitute the practice of medicine and that the delegation of these procedures may only be made to those professions which are regulated by the State of Hawaii.

Could you please advise me on the following questions?

1] May a nurse practitioner or registered nurse or licensed practical nurse perform any of the above cosmetic treatments or other cosmetic treatments such as injection of botox/laser treatments either under delegation from a physician or physician assistant?

2] Would injection of botox, cosmetic laser treatment or any of the above mentioned cosmetic medical treatments fall within the scope of practice of a nurse practitioner or registered nurse?

After some discussion, including reference to the October 2015 Board meeting at which time the Board discussed an inquiry if LPNs or RNs can provide laser treatments under their nurse license. In response to that specific inquiry, the Board informally opined that LPNs and RNs could provide laser treatments under their scope of practice based on the following:

1. Pursuant to HRS §457-2 definition of "The practice of nursing as a licensed practical nurse", an LPN who has received the required education preparation and demonstrated competency, whereby the individual shall be accountable and responsible to the consumer for the quality of nursing care rendered and under the direction of a dentist, physician, osteopathic physician, registered nurse, osteopath, or podiatrist license in accordance with chapter 44, 453, 457, 460, or 463E, or under the orders of a physician assistant licensed pursuant to chapter 453 and acting as an agent of the supervising physician, may perform laser treatments;

2. Pursuant to HRS §457-2 definition of "The practice of nursing as a registered nurse", an RN who has received the education preparation and demonstrated competency having specialized knowledge, judgment, and skill, whereby the individual shall be accountable and responsible to the consumer for the quality of nursing care rendered and use of reasonable judgment in carrying out prescribed medical orders of a dentist, physician, osteopathic physician, registered nurse, osteopath, or podiatrist license in accordance with chapter 44, 453, 457, 460, or 463E, orders of an advanced practice registered nurse orders of a physician assistant licensed pursuant to chapter 453 and acting as an agent of the supervising physician, may perform laser treatments;.

After further discussion, it was the consensus of the Board that LPNs and RNs may perform cosmetic medical procedures provided all of the following have been met:

- The nurse has received the appropriate education and training and have specialized knowledge to perform such a task;
- The nurse has demonstrated competency in performing this task;
- The nurse shall be accountable and responsible for the quality of services rendered by the nurse;
- The nurse uses reasonable judgment in carrying out the prescribed medical orders of a dentist, physician, osteopathic physician, registered nurse, osteopath, or podiatrist license in accordance with chapter 44, 453, 457, 460, or 463E, or under the orders of a physician assistant licensed pursuant to chapter 453 and acting as an agent of the supervising physician;
- The nurse shall be responsible for complying with any other State or federal licensing requirements; and
- The nurse shall be responsible for complying with the institution's policies and procedures, if applicable where the nurse is performing such tasks.

In accordance with HAR § 16-201-90, the above interpretation is for informational and explanatory purposes only and based solely on the information provided. It is not an official opinion or decision and therefore not binding upon the Board.

APRN On-Site of Medical Spa That Offers Injectables for Botox and Non-invasive Services Such as Cool Sculpting, Facials and Chemical Peels

The Board discussed the following email inquiry:

"My business partners and I are considering opening a medical spa in your state with cosmetic services for customers. We will have a nurse practitioner on site every day.

We will be offering injectables such as BoTox (done by a highly trained nurse practitioner only) along with non-invasive services such as Cool Sculpting, facials, and chemical peels.

We have a detailed policy and procedures manual detailing what it is to be done and how everything is to be done. For your state, would physician supervision still be needed? On site at all times?"

After some discussion, it was the consensus of the Board to respond to Ms. Kakarala by informing her that Hawaii APRNs do not have to be "supervised" by a licensed physician and of HRS §457-2.7 Advanced practice registered nurse. that states:

- §457-2.7 Advanced practice registered nurse. (a) Practice as an advanced practice registered nurse means the scope of nursing in a category approved by the board, regardless of compensation or personal profit, and includes the registered nurse scope of practice. The scope of an advanced practice registered nurse includes but is not limited to advanced assessment and the diagnosis, prescription, selection, and administration of therapeutic measures including over the counter drugs, legend drugs, and controlled substances within the advanced practice registered nurse's role and specialty-appropriate education and certification.
- (b) The advanced practice registered nurse's scope of practice supersedes the registered nurse's scope of practice. Advanced practice registered nurses shall practice within standards established or recognized by the board and be guided by the scope of practice authorized by this chapter, the rules of the board, and nursing standards established or recognized by the board including but not limited to:
 - (1) The National Council of State Boards of Nursing Model Nursing Practice Act, Article II, Scope of Nursing Practice, Section 4; and
 - (2) The National Council of State Boards of Nursing Model Nursing Administrative Rules, Chapter Two, Standards of Nursing Practice, Section 2.4.1:

provided that NCSBN shall have no legal authority over the board and shall have no legal authority or powers of oversight of the board in the exercise of its powers and duties authorized by law.

(c) An advanced practice registered nurse shall comply with the requirements of this chapter; recognized limits of the advanced practice registered nurse's knowledge and experience and planning for the management of situations that exceed the scope of authorized practice; and consult with or refer clients to other health care providers, as appropriate.

In accordance with HAR § 16-201-90, the above interpretation is for informational and explanatory purposes only and based solely on the information provided. It is not an official opinion or decision and therefore not binding upon the Board.

National Transportation Safety Board (NTSB) – Safety Recommendation: Drug Use Trends in Aviation: Assessing the Risk of Pilot Impairment – NTSB's Dissatisfaction with Department's Response, Including Board of Nursing's Initiative The Board reviewed a letter from Robert L. Sumwalt, III, Chairman of the NTSB expressing his dissatisfaction with the Board's 2016 initiative to post a memorandum on the Board's web page that included information from the NTSB's concerns with pilot's increase use of OTC, prescription and illicit drugs.

At that time, the Board determined that besides the information from the NTSB, that they wanted to include information about HRS Chapter 329, the Uniform Controlled Substances Act and reference to the American Nurses Association's Code of Ethics. Mr. Sumwalt indicated in his letter that the statement, in reference to the ANA code of ethics was "irrelevant" to the NTSB safety recommendations and that they do not believe that the ANA code of ethics "adequately addresses this issue, nor do we believe that providing a patient with important medical information regarding risk constitutes an infringement on the patient's right to self-determination."

Ms. Sumwalt stated in his letter that publishing the article would be more effective than simply disseminating recommendations.

It was the consensus of the Board to post the NTSB's article in conjunction with their March 2016 Memorandum on the Board's web page.
