Call to Order: The meeting was called to order at 1:03 p.m., at which time quorum was established.

Approval of the April 12, 2018, Minutes: It was moved by Dr. Young, seconded by Dr. Holt, and carried by a majority, with the exception of Dr. Akaka, who abstained from voting on this matter, to approve the minutes of the executive session of the April 12, 2018, meeting unamended and the minutes of the regular session of the April 12, 2018, meeting with the following amendments:

On page 7, the third paragraph of Section 'o. Evan J. Zimmer, M.D.' should read as follows:

The Board is authorized to require further [~~evaltion~~] **evaluation** to ensure that Dr. Zimmer is both competent and professional...

On page 8, the first paragraph should read as follows:

After due consideration of the information received, it was moved by Dr. Young, seconded by Dr. Holt, and unanimously carried to approve Dr. Lawrence's application for licensure pending submission of a corrected and revised application answering affirmatively to question 7.a. **Further, Dr. Lawrence is to be issued a non-disciplinary letter of education.**

Dr. Rumler, Dr. Hawk, and Ms. Hawk were invited into the meeting room at 1:04 p.m.

Chair Geimer-Flanders greeted the guests. Board members and staff introduced themselves.

Dr. Rumler introduced herself and stated that she earned a medical degree; however, due to a disability, was unable to finish the last four months of her first year of residency training. Dr. Rumler stated that she hoped the Board was able to provide her guidance on how to resolve her situation and become eligible for licensure in the State of Hawaii. Dr. Rumler informed the Board that she has worked at the Lavender Clinic as its medical director.

Dr. Sam Hawk introduced himself and informed the Board that he attended residency with Dr. Rumler in Alaska and that, when he opened the Lavender Clinic in Honolulu, he invited Dr. Rumler to work with him. Dr. Hawk also explained that his clinic has had a physician job opening for two years and, due to the physician shortage, the vacancy is still not filled. He stated that he was hoping that the Board would be able to help Dr. Rumler find a pathway to licensure. Dr. Hawk explained that Dr. Rumler has received a lot of didactic training at his clinic during the past three years.

Ms. Hawk introduced herself to the Board and stated that she worked closely with Dr. Rumler at the Lavender Clinic.

Dr. Rumler, Dr. Hawk, and Ms. Hawk were excused from the meeting room at 1:10 p.m.

Chair Geimer-Flanders called for a recess from the meeting at 1:10 p.m. to discuss and deliberate on the following adjudicatory matter pursuant to Chapter 91, HRS:

After discussion, it was moved by Dr. Akaka, seconded by Dr. Halford, and unanimously carried to approve the Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order.

SDAG Fukumura was excused from the meeting room at 1:13 p.m.

- b. In the Matter of the License to Practice Medicine of Erin G. Newman, M.D.; MED 2016-56-L

Dr. Young recused herself from the discussion and voting on this matter and left the meeting room at 1:15 p.m.

After discussion, it was moved by Chair Geimer-Flanders, seconded by Dr. Bintliff, and unanimously carried to remove the terms of probation from the license of Erin G. Newman, M.D. and to make the appropriate update of Dr. Newman's license information to the Professional and Vocational Licensing database.

Dr. Young returned to the meeting room at 1:19 p.m.

Following the Board's review, deliberation and decision in this matter pursuant to Chapter 91, HRS, Chair Geimer-Flanders announced that the Board reconvene to its regular Chapter 92, HRS, meeting at 1:19 p.m.

It was moved by Chair Geimer-Flanders, seconded by Dr. Egami, and unanimously carried to approve the following applications:

d. Jason Lee, M.D.

After due consideration of the information received, it was moved by Vice-Chair Halford, seconded by Dr. Akaka, and unanimously carried to defer Dr. Lee's application for licensure.

In deferring this application, the Board determined that Dr. Lee must undergo a comprehensive evaluation to determine his ability to safely and competently practice medicine in the State of Hawaii. Dr. Lee shall contact Pu`ulu Lapa`au, The Hawai`i Program for Healthcare Professionals, to request that they refer him to an appropriate organization for the comprehensive evaluation.

The Board is authorized to require further evaluation to ensure that Dr. Lee is both competent and professional: Hawaii Revised Statutes ("HRS") §453-4(b)(1) (the applicant shall furnish proof satisfactory to the board that the applicant is of demonstrated competence and professional knowledge); HRS §453-8(b)(1) and (4) (the board may impose as a condition of licensure a physical and mental evaluation of the applicant by a licensed physician or osteopathic physician approved by the board, and further education or training or proof of performance competency); §436B-10(a)(9) (an applicant shall provide any other information the licensing authority may require to investigate the applicant's qualifications for licensure); and Hawaii Administrative Rules §16-85-7(c) (it shall be each applicant's responsibility to furnish any information and documentation requested by the board).

The Board has also requested that Dr. Lee submit a detailed statement of explanation regarding loss of employment with the Kern Medical Center.

e. Pernille Ottosen, M.D.

After due consideration of the information received, it was moved by Dr. Young, seconded by Mr. Puleasi, and unanimously carried to approve Dr. Ottosen's application for licensure and issue a non-disciplinary letter of education. The non-disciplinary letter of education shall: (1) express the importance of prescribing appropriately at all times; (2) express to Dr. Ottosen the importance as a physician to remain professional, and to hold paramount

the health, welfare, and safety of her patients at all times; and (3) urge Dr. Ottosen to become familiar with all State laws regarding controlled substances.

Further, the Board also directed Ms. Quiogue to provide the following documents to Dr. Ottosen: (1) the Board's Pain Management Guidelines; and (2) the Template for Informed Consent for Opioid Prescribed Pills.

f. Eric J. Putz, M.D.

After due consideration of the information received, it was moved by Chair Geimer-Flanders, seconded by Dr. Bintliff, and unanimously carried to defer Dr. Putz's application for licensure.

h. Thomas A. Sorbera, M.D.

After due consideration of the information received, it was moved by Dr. Akaka, seconded by Dr. Chun, and unanimously carried to approve Dr. Sorbera's application for licensure and to issue a non-disciplinary letter of education. The non-disciplinary letter of education shall remind Dr. Sorbera of his responsibility as a physician to remain professional in all interactions with his patients, colleagues, and staff.

(ii) Podiatrist:

a. Lee A. Wittenberg, D.P.M.

It was moved by Dr. Young, seconded by Dr. Holt, and unanimously carried to approve Dr. Wittenberg's application for licensure pending submission of a corrected and revised application answering affirmatively to question 6.a. and to issue a non-disciplinary letter of education reminding Dr. Wittenberg of his responsibility as a podiatrist to disclose and provide accurate information at all times.

(iii) Request for sponsorship to sit for the United States Licensure Examination (USMLE) Step 3 and waiver of the Board's post-graduate residency training requirement:

a. Renee P. Rumler, M.D.

It was moved by Vice-Chair Halford, seconded by

Chair Geimer-Flanders, and unanimously carried to deny Dr. Rumler's requests: (1) for sponsorship to sit for USMLE Step 3; (2) and to waive the Board's post-graduate residency training requirement as it does not have that statutory or administrative rule authority.

It was moved by Dr. Bintliff, seconded by Dr. Young, and unanimously carried to ratify the attached list of individuals for licensure or certification.

Federation of State Medical Boards

a. Chair Geimer-Flanders's report regarding her attendance at the FSMB's 2018 Annual Meeting, Charlotte, North Carolina

Chair Geimer-Flanders reported to the Board that this year representatives of some of the state boards were unable to attend the FSMB meeting due to the controversies regarding bathroom laws.

At the meeting, Pat King was installed as the new FSMB Board President and Scott Steingard as the President Elect.

Chair Geimer-Flanders informed the Board members that the topics covered at the meeting were all related to patient safety and mainly involved the legislative issues regarding opiates and pain management, including the mandate for use of the Prescription Drug Monitoring Program ("PDMP"). It was noted that about 20 states mandate the use of the PDMP.

Other topics covered were the physician burnout issue with an impact on patient care in two ways: (1) reporting of mental health, physical limitations, chemical dependence, and burnout treatments as a barrier to getting help; and (2) the aging of the physician population together with the growth of the Medicare population (in 2025, the baby boomers will all age into Medicare and that demographic will constitute 41% of the population).

The FSMB recommended encouraging treatment by using 'remove and replace' language in renewal and initial licensure applications. Another FSMB recommendation was implementation of programs that look to retain physicians in the workforce as long as they desire employment by ways of re-entry (for physicians experiencing burnout) and retraining programs (for physically demanding professions, such as surgery).

Ms. Quiogue inquired what Board members thought regarding the suggestions for the ‘remove and replace’ language and if the Board would like to see a drafted application with such language. The Board members agreed that they saw no need in changing current applications.

Executive Officer's Report:

a. Reminder: financial disclosures are due May 31st, 2018

Ms. Quiogue reminded Board members that the State financial disclosures are due May 31, 2018. She advised the Board members that, if the disclosures are not filed on time, the State Ethics Commission may penalize the member by way of fine, etc.

As of January 1, 2018, the Hawaii State Ethics Commission has a new Electronic Filing System for financial and gift disclosures. The E-Filing System allows State officials to file disclosures electronically and save their documents in one location, making it easier to manage their filings.

2018 Legislation:

Mr. Tenorio entered the meeting room at 2:43 p.m.

The Board reviewed the following legislative measures:

a. SB2653, SD1, HD1, CD1 Relating to Chapter 453, Hawaii Revised Statutes

The above bill was reviewed and discussed in detail at the previous meetings. The Board strongly supports this bill.

The purpose of the bill is to establish licensing requirements by endorsement for physicians, surgeons, and osteopathic physicians to practice medicine in Hawaii.

Ms. Quiogue informed the Board that this measure passed final reading as SB 2653, SD 1, HD 1, CD 1. The Conference Committee amended the measure by:

- (1) Inserting an appropriation amount of \$104,000 out of the compliance resolution fund to implement the licensure by endorsement requirements;
- (2) Inserting a purpose section;
- (3) Changing its effective date to July 1, 2018; provided that the licensure by endorsement requirements shall take effect on December 31, 2018; and
- (4) Making technical, non-substantive amendments for the purposes of clarity and consistency.

Ms. Quiogue informed the Board that the appropriation of funds will allow PVL to hire two staff members: one applications office assistant and one records office assistant. The recruitment of these two staff members would assist in facilitating successful implementation of the bill.

Dr. Akaka briefly left the meeting room from 2:45 p.m. to 2:46 p.m.

b. HB2578, HD2, SD 1, CD1 Relating to Physician Assistants

The above bill was reviewed and discussed in detail at the previous meetings.

The purpose of the bill is to require continuing education ("CE") for physician assistants to renew their licenses. The bill prohibits the Board from requiring a physician assistant to maintain or receive certification by the National Commission of Certification of Physician Assistants ("NCCPA") to satisfy the requirement for continuing education or for license renewal.

The Board supports this measure.

Ms. Quiogue informed the Board that, unfortunately, this measure was not scheduled for a conference committee hearing. The bill crossed over from House to Senate, but the House disagreed with the Senate Draft 1. Ms. Quiogue stated that Mr. Tenorio could probably give more details regarding the reason why no conference hearing was scheduled.

Mr. Tenorio confirmed that an individual representing his organization failed to appear for a meeting with Senator Baker and, as a result, the conference did not get scheduled.

Chair Geimer-Flanders inquired what will be happening to the bill next year.

Ms. Quiogue explained that bills from this session that were not heard or enacted do not carry over to the next legislative session. Thus, if desired, a similar bill will have to be introduced at the beginning of the next legislative session. Ms. Quiogue recommended to Mr. Tenorio that he submit to the Board, before the start of the next legislative session, a draft bill so that it can review the draft and state its formal position regarding this measure.

Ms. Quiogue continued to say that she was asked in the past whether it might be possible to amend administrative rules instead of introducing a new legislative measure and that her response was that going through the legislative process is faster than amending the rules.

Mr. Tenorio stated that a lawyer for the Academy of Physician Assistants has been working on a similar issue with other states. Mr. Tenorio told the Board members that he would like the Board to take a look at the bill language that was suggested by this lawyer.

Ms. Quiogue informed Mr. Tenorio that the bill would have to be provided for the Board's review no later than its September meeting, preferably August.

c. SB2298, SD2, HD2, CD1 Relating to Healthcare Preceptor Tax Credits

The above bill was reviewed and discussed in detail at the previous meetings.

The purpose of the bill is to allow advanced practice registered nurses and physicians to receive income tax credits for acting as preceptors in volunteer-based supervised clinical training rotations provided to eligible students that enable the students to obtain an eligible healthcare professional degree or certificate.

Ms. Quiogue provided the following update regarding the bill's current version. The Committee on Conference recommended the final passage of this bill and amended the measure by:

- (1) Reverting to the S.D. 2 version, which:
 - (a) Provides to healthcare professionals who volunteer as preceptors for advanced practice registered nursing students, medical students, and pharmacy students a tax credit of \$1,000 per rotation, up to a maximum of \$5,000 per taxable year, with an annual aggregate tax credit of \$2,000,000.00;
 - (b) Creates a Preceptor Credit Assurance Committee within the Department of Health to implement the tax credit program and certify the tax credit; and
 - (c) Requires the Department of Health to evaluate the efficacy of the tax credit and submit a report to the Legislature no later than June 30, 2024.

The measure was also amended by:

- (a) Deleting the requirement that eligible students be residents of Hawaii and deleting the definition of “resident of Hawaii”;
- (b) Amending the definition of “primary care”; and
- (c) Decreasing the annual aggregate amount of tax credits that may be certified in a taxable year to \$1,500,000.00.

d. HB1906, HD2, SD1, CD1 Relating to Health Care Workers

The above bill was reviewed and discussed in detail at the previous meeting. The Board is monitoring the above bill.

The purpose of the bill is to make intentionally or knowingly causing bodily injury to certain health care workers a Class C felony.

Ms. Quiogue provided the following update regarding the bill's current version: the bill passed final readings in the House and Senate and was transmitted to Governor on May 2, 2018.

e. SB270, SD1, HD2, CD1 Relating to Minors (Carried over to the 2018 Regular Session)

The above bill was reviewed and discussed in detail at the previous meetings. The Board is monitoring the above bill.

The purpose of the bill is to prohibit specific state-licensed persons who are licensed to provide professional counseling from engaging in, attempting to engage in, or advertising sexual orientation change efforts on persons under eighteen years of age.

Ms. Quiogue provided the following update regarding the bill's current version: the bill passed final readings in House and Senate and was enrolled to Governor on May 3, 2018.

f. SB2646, SD1, HD3, CD1 Relating to Prescription Drugs

The above bill was reviewed and discussed in detail at the previous meetings. The Board is monitoring the above bill.

The purpose of the bill is to require prescribers of certain controlled substances to consult the electronic prescription accountability system before issuing a prescription for the

controlled substance. Provides exemptions for certain circumstances. Provides that a violation by a prescriber shall not be subject to criminal penalty provisions but that a violation may be grounds for professional discipline pursuant to sections 448-17, 453-8, 457-12, and 471-10, Hawaii Revised Statutes.

Ms. Quiogue provided the following update regarding the bill's current version: the bill passed final readings in the House and Senate and was enrolled to Governor on May 3, 2018.

g. HB1602, HD2, SD1, CD1 Relating to Opioids

The above bill was reviewed and discussed in detail at the previous meetings. The Board is monitoring the above bill.

The purpose of the bill is to permit the inclusion of a label warning of the risks of addiction and death on the packaging of any opioid drug dispensed by a health care professional or pharmacist.

Ms. Quiogue informed the Board that the final version of the bill amended Chapter 329, HRS, by adding a new section to part III:

“§329 - Opioid warning label. In addition to any requirements for labeling of drugs under part I of chapter 328, part III of this chapter, and any other requirement for labeling of prescription drugs pursuant to state or federal law, a health care professional or pharmacist who dispenses any opioid drug shall include on the drug's package a warning label that contains wording substantially similar to the following warning: “Caution: Opioid. Risk of overdose and addiction.”

The bill passed final readings in the House and Senate and was transmitted to Governor on May 2, 2018.

h. HB2145, HD1, SD1, CD1 Relating to Medication Synchronization

The above bill was reviewed and discussed in detail at the previous meetings. The Board is monitoring the above bill.

The purpose of the bill is to require health insurance and hospital and medical service plans that provide prescription drug benefits to apply prorated daily cost-sharing rates for prescriptions dispensed by pharmacies.

The Conference Committee amended this measure by:

- (1) Changing the effective date to July 1, 2018;
- (2) Removing the repeal date of July 1, 2023; and
- (3) Making technical, non-substantive amendments for the purpose of clarity, consistency, and style.

The bill passed final readings in House and Senate and was transmitted to Governor on April 30, 2018.

i. HB2729, HD2, SD1 Relating to Cannabis for Medical Use

The Board discussed the above bill in detail at its previous meetings.

Ms. Quiogue provided the following update regarding the bill's current version. Committee on Conference has amended this measure by:

- (1) Deleting provisions relating to employment protections for registered qualified patients;
- (2) Authorizing the registration of two caregivers for minors qualifying out-of-state patients;
- (3) Clarifying that a qualifying out-of-state patient shall not possess more than four ounces of usable cannabis at any given time and shall not possess live plants;
- (4) Deleting provisions authorizing licensed dispensaries to dispense edible cannabis products;
- (5) Clarifying requirements for devices that aerosolize cannabis and devices for safe pulmonary administration that may be dispensed by licensed dispensaries;
- (6) Establishing an Outstanding Issues Working Group to consider and make recommendations on issues related to the employment of registered qualifying patients and the manufacture and distribution by licensed dispensaries of edible cannabis products;
- (7) Changing its effective date to July 1, 2018; and
- (8) Making technical, non-substantive amendments for the purposes of clarity and consistency.

The bill passed final readings in the House and Senate and was transmitted to Governor on May 2, 2018.

Mr. Tenorio left the meeting room at 2:53 p.m.
