Call to Order: Chairperson De Luz called the meeting to order at 9:02 a.m. at which time

quorum was established.

Approval of Minutes of the February 20, 2018 Meeting:

Executive Officer Kleinhans requested for the following amendments to

the February 20, 2018 meeting minutes as follows:

Page 2, last paragraph – continued to Page 3:

"It was moved by Mr. Hansen, seconded by Mr. Johnsen, and unanimously carried by majority vote (Chairperson De Luz recused himself from decision-making, and Mr. Wong vote nay) to approve the

Executive Officer's Report:

a. 2018 First Hawaiian Bank Auto Show, April 13, 2018 – April 15, 2018

Executive Officer Kleinhans informed the Board that several Motor Vehicle Dealer Off-Premise Display Requests were received for the 2018 First Hawaiian Bank Auto Show ("Show"). He stated that he returned the display requests with the Board's 2016 informational letter that states the Show is distinctively a Manufacturers' Show and that the requirements of HRS section 437-4(d) (display of motor vehicle at unlicensed premises) do not apply to motor vehicle manufacturers.

Chairperson De Luz requested Mr. Rolf's assistance in reminding and disseminating this information to Motor Vehicle Dealers ("Dealer").

Chairperson De Luz announced the Board will recess its meeting to go into adjudicatory matters and subsequently go into Executive Session; the meeting recessed at 9:07 a.m.

After discussion, it was moved by Vice-Chairperson Chow, seconded by Mr. Johnsen, and unanimously carried to approve the Recommended Order for the Motor Vehicle Dealer License of Auto Mart USA, LLC; MVI 2016-058-L.

Upon a motion by Vice-Chairperson Chow, seconded by Mr. Hansen, it was unanimously carried to ratify the above lists for the licenses sought (as attached).

It was moved by Vice-Chairperson Chow, seconded by Mr. Hansen, and unanimously carried to defer decision-making on the Motor Vehicle Consumer Consultant application for Mary P. Benson pending receipt of description of duties in accordance with the application instructions.

(ii) <u>Jason A. Doss</u> Motor Vehicle Salesperson

It was moved by Mr. Hansen, seconded by Mr. Ignas, and unanimously carried to approve the Motor Vehicle Salesperson application for Jason A. Doss subject to the Board's receipt of a letter signed by the Dealer principal in accordance with the application instructions and receipt of an amended application with current Dealer information, and to authorize the Executive Officer to approve the application upon receipt of the letter and amended application.

The Board's consensus was to take the following agenda item out of order.

New Business:

a. Request from U.S. Bank Regarding Hawaii Dealer Licensing Requirements and Subsidiaries of National Banks

Executive Officer Kleinhans stated the Board received an inquiry from U.S. Bank that asked if a Dealer's license is required for the following: An operating subsidiary of a national bank not physically located in Hawaii, that leases motor vehicles through Hawaii Dealers and then sells the vehicles at lease termination to the leasing customer.

Executive Officer Kleinhans advised the Board of its informal interpretation at its June 10, 2010, which exempted national banks from the licensing requirements as a Dealer.

Executive Session:

At 10:10 a.m., it was moved by Vice-Chairperson Chow, seconded by Mr. Johnsen, and unanimously carried to enter into Executive Session to consult with the Board's attorney on questions and issues pertaining to the Board's powers, duties, privileges, immunities, and liabilities in accordance with HRS §92-5(a) (4).

EXECUTIVE SESSION

At 10:20 a.m., it was moved by Mr. Johnsen, seconded by Vice-Chairperson Chow, and unanimously carried to return to the Board's regular order of business.

After discussion, it was moved by Vice-Chairperson Chow, seconded by Mr. Ignas, that based on the information provided regarding the activity of an operating subsidiary of a national bank not physically located in Hawaii, that leases motor vehicles through Hawaii Dealers and then sells the vehicles at lease termination to the leasing customer, the subsidiary of a national bank would be exempt from the requirements of a Dealer's license at this time.

In accordance with HAR section 16-201-90, the above interpretation is for informational and explanatory purposes only and based solely on the information provided. It is not an official opinion or decision and therefore not binding on the Board.

Legislation:

b. <u>SB 2490 (and subsequent drafts) Relating to Motor Vehicle</u> Industry Licensing Act

This bill amends various aspects of statutes regarding chapter 437, Hawaii Revised Statutes.

Mr. Rolf provided a recap of the progress of SB 2490 and thanked everyone involved including the Board and Executive Officer. He commented that the bill is now in conference committee, and HADA and the Motor Vehicle Manufacturer ("Manufacturer") stakeholders were in agreement with a proposed SB 2490, SD1, HD2, CD1.

Mr. Rolf summarized the proposed conference draft and highlighted the agreed-upon recall reimbursement rate that would require Manufacturers to pay Dealers 1% per month for the value of used vehicle grounded for lack of a repair part.

After discussion, it was moved by Mr. Hansen, seconded by Mr. Johnsen, and unanimously carried (Chairperson De Luz recused himself from decision-making) to support SB 2490, SD1, HD2.
