#### Legislation:

H.B. 1381 / H.B.1630 / S.B. 2494 – Relating to Elevator Mechanics (and subsequent drafts)

Executive Officer Kleinhans reported that H.B. 1630 was not heard by the House Finance Committee and is effectively "dead" for the session.

Discussion ensued on S.B. 2494 and the definition of "elevator and kindred equipment" as referenced in HRS section 397-3.

Chairperson Morinaga inquired if an elevator mechanic performs work on personal automatic trains. Mr. Nakamine replied that recent DLIR records do not show work performed on personal automatic trains.

Mr. Yamane of the IUEC reported of a bill in the Legislature, S.B. 2803, that removes "personal automatic trains" from the definition of "elevator and kindred equipment".

After a brief discussion, it was moved by Mr. Tsunemoto, seconded by Vice Chairperson Wilburn, and unanimously carried that the Board prefers the language in S.B. 2494, SD2, HD2.
