At 12:05 p.m., the Board recessed the meeting to discuss and deliberate on the following adjudicatory matter pursuant to HRS chapter 91.

A. In the Matter of the Beauty Operator License of SUSAN M. SCHATTAUER-MEDEIROS; BAR 2018-99-L

After discussion, it was moved by Chairperson McKay, seconded by Ms. Williams, and unanimously carried to approve the Settlement Agreement relating to the <u>Matter of the Beauty Operator License of SUSAN M. SCHATTAUER-MEDEIROS</u>; BAR 2018-99-L.

At 12:06 p.m., the Board reconvened its scheduled meeting.

Executive Officer Kleinhans summarized previous discussions by the Board whereby the Board had expressed their interest in the administration of the NIC exam. Mr. Kleinhans reminded the Board that they should first verify the NIC exam is able to be administered and obtain information of test dates, test locations, and availability. Once that is done, a written contract would be drawn between NIC and the Department of Commerce and Consumer Affairs (DCCA"). Once this is complete, the Board would be able to submit an Administration Bill to amend the respective statutes to include the requirement of a national exam.

Executive Officer Kleinhans stated that due to the current lack of information, it would be too late to submit an Administration Bill for the 2019 Legislative Session; thus, the Board should complete/address the concerns before August 2019 for the 2020 Legislative Session.

Executive Officer Kleinhans stated that he has tried contacting the NIC office but has yet received a response. Mr. Nelson suggested contacting Mr. Fred Jones, Legal Counsel for the Professional Beauty Federation of California. He commented that Mr. Jones is close to the California Board of Barbering and Cosmetology and NIC, and he also attended a Board meeting "years ago" to discuss the NIC exam. Mr. Nelson will provide Mr. Jones' contact information to the Executive Officer.

Ms. Williams commented that she was not able to locate the sample NIC theory exam as may be available on the internet. Mr. Nelson volunteered to get that information from Mr. Jones.

The barber/beauty shop applications above were preliminarily reviewed by licensing branch staff, Executive Officer Kleinhans, and Chairperson McKay (Board member designated to review the barber/beauty shop applications for consideration at this Board meeting).

Chairperson McKay confirmed that she had reviewed the twenty-one (21) applications, and determined that they met all the requirements for barber/beauty shop licenses, and recommends approval.

After discussion, it was moved by Chairperson McKay, seconded by Mr. Nelson, and unanimously carried to approve

the twenty-one (21) barber/beauty shop applications listed above.

DUNVILLE, Diane M. (New Beauty Shop)

After discussion, it was moved by Chairperson McKay, seconded by Ms. Williams, and unanimously carried to defer decision-making on the beauty shop application of Diane M. Dunville pending receipt of additional documents in accordance with the application instructions.

HAWAII KAI 101 SALON LLC (New Beauty Shop)

After discussion, it was moved by Chairperson McKay, seconded by Ms. Williams, and unanimously carried to approve the beauty shop application of Hawaii Kai 101 Salon LLC subject to the Board's receipt of the written agreement in accordance with the application instructions and to authorize the Executive Officer to approve the application upon receipt of the written agreement.

 KAIANJOSEPH LIMITED LIABILITY COMPANY (New Beauty Shop)

After discussion, it was moved by Chairperson McKay, seconded by Ms. Williams, and unanimously carried to approve the beauty shop application of KaianJoseph Limited Liability Company, and to send a non-disciplinary Letter of Education advising applicant that the practice of tattoo falls under the jurisdiction of the Department of Health, Sanitation Branch.

 LEO GROUP INC dba SKIN ATTRACTION (New Beauty Shop)

After discussion, it was moved by Chairperson McKay, seconded by Mr. Nelson, and unanimously carried to approve the beauty shop application of Leo Group Inc dba Skin Attraction, and to send a non-disciplinary Letter of Education advising applicant that the practice of laser falls under the scope of practice of a medical doctor or a health care professional whose scope includes the use of lasers independently.

> TONY TRUONG CORP dba NAILS FOR TODAY (New Beauty Shop)

After discussion, it was moved by Chairperson McKay, seconded by Ms. Severson, and unanimously carried to approve the beauty shop application of Tony Truong Corp dba Nails For Today subject to the Board's receipt of the clarification of the acknowledgement of designated beauty operator-incharge and to authorize the Executive Officer to approve the application upon receipt.

WONG, Terry S.K. dba T W SALON (New Barber Shop)

After discussion, it was moved by Chairperson McKay, seconded by Ms. Severson, and unanimously carried to approve the barber shop application of Terry S.K. Wong dba T W Salon, subject to the Board's receipt of the signature on the acknowledgement of the barber-in-charge and to authorize the Executive Officer to approve the application upon receipt.

Old Business: A. Streamlining the Barber/Beauty Shop Application Process

Discussion ensued on the Barber/Beauty shop application procedures and process. Executive Officer Kleinhans provided the Board with a draft copy of the revised Barber/Beauty shop application that included the following revisions to the supporting documents required with the application:

- A letter signed by both the shop's operator-in-charge and the shop's owner will be incorporated into the application;
- Description of barbering/beauty culture services will be incorporated into the application – applicant to check-off the type of services "licensure category/ies" to be provided;
- Affidavit of applicant will include certification that there will be barber/beauty operator-in-charge for each service the shop provides;
- Written agreement between the license applicant and the owner will not be required, (this requirement will be removed);
- Detailed drawing or sketch of the shop's floor plan Shop Floor Plan Form has been created for applicant to draw or sketch; and

> Affidavit certifying that the applicant meets the standards and public health requirements of HAR chapter 11-11, the administrative rules of the Department of Health.

Executive Officer Kleinhans further stated that he believes with the revisions, barber/beauty shop applications may not need the additional review by a Board member (subject-matter expert); thus, the approval of shop applications may be delegated to the Executive Officer and be ratified by the Board.

Discussion ensued on the check off boxes for services to be rendered/licensure categories. Chairperson McKay requested that "cosmetology" be added; thus, the check-off boxes will include:

- ✓ Barbering;
- ✓ Cosmetology;
- ✓ Hairdressing;
- ✓ Esthetics; and
- ✓ Nail Technology.

Mr. Nelson inquired if an operator-in-charge is necessary/required. Executive Officer Kleinhans noted an operator-in-charge is necessary pursuant to HRS section 439-17(a) and HAR section 16-73-3(b).

After discussion, it was moved by Chairperson McKay, seconded by Ms. Williams, and unanimously carried to approve the revisions to the shop applications as noted above and to delegate the review and approval of the shop applications to the Executive Officer and be ratified by the Board.
