Minutes of the July 23, 2018 Board Meeting:

Ms. Williams requested for the following amendments on page 3, third from last paragraph:

After discussion, it was moved by Chairperson McKay, seconded by Ms. Williams, and unanimously carried to approve the July 23, 2018 meeting, with the aforementioned amendments (with new material underscored and repealed material bracketed and stricken through).

Minutes of the August 13, 2018 Board Meeting:

After discussion, it was moved by Chairperson McKay, seconded by Ms. Williams, and unanimously carried to approve the minutes of the August 13, 2018 Board meeting, as circulated.

Executive Officer's Report:

A. <u>Licensing Examination of the National-Interstate Council of</u> State Boards of Cosmetology ("NIC")

Executive Officer Kleinhans stated that as the Board had expressed their interest in the administration of the NIC exam, the Professional Vocational Licensing Division ("PVLD") is looking into NIC procurement. He also stated that he has a meeting with the PVLD Acting Examination Administrator, Dave Grupen, later this week and will provide a report/update the Board at their subsequent meeting.

D. Application for License or Change – Barber Shop/Beauty Shop

(1) GOTO, Colleen M. dba STUDIO510 (New Beauty Shop)

After discussion, it was moved by Chairperson McKay, seconded by Ms. Williams, and unanimously carried to approve the beauty shop application of Colleen M. Goto dba Studio510.

<u>Inquiry</u>: A. <u>Can a licensed esthetician perform "nanoneedling?"</u>

Executive Officer Kleinhans stated the Board received an inquiry on whether a licensed esthetician could perform nanoneedling. He commented that in the past, the Board determined that micro-needling, which is similar to nanoneedling, did not fall within the practice of cosmetology and the Board's regulatory oversight.

After discussion, it was moved by Chairperson McKay, seconded by Mr. Choi, and unanimously carried to determine that nanoneedling does not fall within the practice of cosmetology (which includes esthetics) and the Board's regulatory oversight.
