## Hawaii Administrative Rules:

#### A. Proposed Amendments to HAR §16-73-29 Reader/Interpreter

Discussion ensued on the proposed amendments to HAR §16-73-29 Reader/Interpreter; to delete all verbiage from this section and replace it with: "All examinations shall be conducted in the English language and no applicant shall be permitted the use of a reader or interpreter." Executive Officer Kleinhans suggested to propose this amendment as piecemeal, rather than including it in the whole rules revision package.

Discussion ensued on whether the proposed language may appear discriminating. Executive Officer Kleinhans commented that other Boards have written language in their statute/rules that specifically states that their exam are conduced only in the English language. DAG Jayaram commented that the Board and the DCCA should first decide if they want this policy/proposed amendments and thereafter, this proposed amendments will be reviewed by the Attorney General for their advisement (part of the beginning steps in the adoption procedures of proposed rules amendments).
