<u>Agenda</u> :	The agenda for this meeting was filed with the Office of the Lieutenant Governor, as required by section 92-7(b), Hawaii Revised Statutes ("HRS").
1. Call to Order:	There being a quorum present, Vice Chair lopa called the meeting to order at 9:00 a.m.
2. <u>Additional</u> <u>Distribution</u> :	None.
3. <u>Approval of</u> <u>Board Minutes</u> of the July 10,	Vice Chair lopa asked if there were any comments or concerns regarding the Board minutes of the July 10, 2018 meeting.
2018 Meeting:	There were none.

4. Executive

Officer's Report: There being no further discussion or amendments to the minutes, upon a motion by Ms. Wakabayashi, seconded by Mr. Turner, it was voted on and unanimously carried to approve the minutes of the July 10, 2018 meeting as circulated.

a. Update on Proposed Legislation

EO Taniguchi reported that the proposed legislation on dry needling as well as continuing competence ("CC") for PTAs was submitted to the Department of Commerce and Consumer Affairs' ("DCCA") administration, however, it has been determined that the bills would not be submitted as part of the DCCA's administrative bill package. He noted that the DCCA Director would have to defend any administration bills submitted to the Governor. For the dry needling bill, he stated that there was some concern about a possible conflicting position from the Board of Acupuncture. For the bill to add a CC requirement for PTAs, there were concerns that as PTAs began licensing in December 1, 2014, it may be too soon to require CC units. Also, there were concerns that as PTAs make a lower salary than PTs, the required CC units should be less. In addition, there is a list of questions that the Board is required to provide answers for to justify the need for a CC requirement. Historically, the legislature in general and the Senate Committee on Commerce, Consumer Protection, and Health specifically, are very tough on DCCA bills and require strong justification for any bills submitted.

Mr. Turner asked if someone else could introduce similar bills.

EO Taniguchi said yes.

Ms. Wakabayashi asked if the Board can work on the bills for possible submission for the 2020 legislative session.

EO Taniguchi said yes.

Mr. Pacilio stated that he was surprised by the Administration's response as Senator Roz Baker has always been helpful to HAPTA.

Mr. Turner said if so, Senator Baker may be more open to legislation introduced at HAPTA's request.

Mr. Pacilio said he is surprised that there may be opposition from the Acupuncture Board.

EO Taniguchi said that there is always potential for conflict when trying to add something that is within another profession's scope of practice. He acknowledged that HAPTA had requested to be placed on the Acupuncture

> Board's meeting agenda, however, the meeting has been cancelled twice, once due to lack of quorum and once due to Hurricane Lane. He stated that if HAPTA still would like to be on the agenda for the Acupuncture Board's next meeting, he can let their EO know.

Mr. Pacilio stated that HAPTA would like to remain on the agenda of the Acupuncture Board's next meeting. HAPTA will continue to work to open a dialogue with the Acupuncture Board.

Ms. Zazzera asked if any testimony given on potential bills would be from the Board or from the members as individuals.

EO Taniguchi stated that testimony would be submitted by the Board. He noted that the Board's testimony must be approved by the DCCA Director's office before it is submitted.

Mr. Turner said he thinks it is still possible for the Board to submit similar legislation for the 2020 session. The Board now has the time to do more legwork and provide additional justification.

Mr. Pacilio noted that based on the information from the Board today, HAPTA needs to restructure their plan for the upcoming legislative session as their current plan was based on the discussion at the Board's July meeting.

Ms. Zazzera stated that basically, the bills are not going forward for political reasons.

EO Taniguchi disagreed, stating that there are many reasons. For example, any board or program who requests that a continuing competence requirement be added must justify why such a requirement is necessary. For professions such as physical therapy, it is difficult because there are rarely complaints about a lack of education leading to public harm.

Ms. Zazzera asked if PTs received their CC requirement because of complaints.

Mr. Turner said no, but a reasonable argument could be made that the profession is continually evolving. He noted that this will allow the Board time to work on such a justification.

EO Taniguchi reported that at the end of June, Vice Chair lopa and Ms. Kubota will have reached their term limit. He noted that any physical therapists who may be interested in serving on the Board can apply with the Governor's Office of Boards and Commissions.

5. <u>Old</u> a. Letter from the Hawaii Chapter – American Physical Therapy Association ("HAPTA") regarding their proposed additions to the PT Practice Act -Business: Requested Information from the July 10, 2018 Meeting The Board reviewed HAPTA's letter which provided additional information regarding whether other states that have attempted to implement "health and wellness" language in their practice act have received any pushback and if CAPTE has any intention to include dry needling into the requirements for entry-level PT education. HAPTA also provided a summary of dry needling regulation by state. Ms. Zazzera asked if a bill is introduced, would the Board have a hearing to amend their administrative rules. EO Taniguchi noted that the bill amends the law. Depending on the changes to the law, the Board would potentially draft administrative rules to add more details. He cited dry needling as an example. The proposed bill would have repealed the language in the law which does not allow the puncturing of good skin. If passed, the Board would have then begun drafting proposed changes to their rules to allow for dry needling. Ms. Zazzera said if a definition for "dry needling" has to be addressed during rule revisions, there may still be possible opposition. EO Taniguchi stated that he had a definition for "dry needling" in the proposed bill as adding the definition to the statute is more transparent regarding the Board's intentions in repealing the language which does not allow puncturing of good skin. 6. - Effective immediately, "evidence of participation" for all teaching and service activities will be an original letter from an authorized representative which includes all of the required information. If the physical therapist is the course sponsor or the organizer of the community service event, they must submit an original signed written statement with all of the required information and a selfattestation that the written statement provided is true and correct.
- Effective January 1, 2019, physical therapists are limited to a maximum of four (4) CCUs for service activities.

The Board also determined that revisions to the "List of Other Competence Related Activities Approved by the Hawaii Board of Physical Therapy" document on the Board's website should be made for clarification purposes.

Mr. Turner volunteered to review the document and present any proposed changes at the Board's next meeting.
