### Act 35, SLH 2010 Update

The Executive Officer informed the Board that, in August and September 2018, University of Hawaii Honolulu Community College approved the following electrical academic coursework:

- Columbus State Community College
- Oregon State Apprenticeship and Training Council

# 2018 Legislative Session:

a) Act 060, Relating to Electrical Contractors, (SB2297, H.D.2, C.D.1)

Ms. Tamanaha reminded the Board members that this Act, in Section 3, requires that the Board of Electricians and Plumbers submit a report to the legislature no later than twenty days prior to the convening of the regular session of 2019, 2020, 2021, 2022, and 2023. The reports shall include but not be limited to the following:

- (1) Any program in the State that offer vocational training for licensed electricians to perform high voltage electrical work;
- (2) Availability of continuing education, training, or both, necessary for licensed electricians to acquire or keep current those skills related to performing high voltage work;
- (3) The number of licensed electricians in the State qualified to perform high voltage electrical work; and
- (4) Opportunities for growth in the high voltage work subspecialty.

Chair Akamu indicated that there were no training programs currently that he was aware of, except for the IBEUW 1186 program for cable splicing. One of the minimum requirements for this training program is licensure as a journeyman electrician.

In regard to the current definition of "high voltage work", Ms. Doi stated that she checked with City and County and it appears that all of their inspections are only done for electrical work that involves up to 600V. Anything over 600V is under HECO's jurisdiction.

Discussion followed.

Ms. Tamanaha asked Mr. Takahashi, if possible, to submit any comments or information that he has for the report to the Board's office via email. Mr. Takahashi expressed his agreement.

The Board members discussed other possible sources of information for the report.

Mr. Lucero informed Ms. Tamanaha that, when it comes to continued education regarding specific electrical equipment, equipment manufacturers usually conduct those update classes for licensed electricians.

Ms. Tamanaha inquired whether the manufacturer training is usually provided in Hawaii or the electricians have to go to the U.S. Mainland to receive training.

Mr. Lucero responded, and Chair Akamu confirmed, that representatives of manufacturers usually come to Hawaii.

Mr. Takahashi also noted that any continuing education class is based on demand. If there is no demand, there will be no classes.

Regarding item (4) of the report, DAG Jayaram suggested that the Board solicit information from the industry members.

Ms. Tamanaha also asked if Chair Akamu could check what voltages are covered by the NEC. Mr. Akamu responded that he already started working on this.

#### New Business:

a) Experience Verification Form - Electrician Only

The Board reviewed the final draft of the Experience Verification Form – Electrician Only.

It was moved by Vice-Chair Brady, seconded by Mr. Ta'a, and unanimously carried to approve the new Experience Verification Form – Electrician Only with the following changes:

- 1. Section "Branch circuit wiring" third line: the word "contractors" needs to be changed to "contactors"
- 2. Section "Specialized wiring" fist line: change "wind and/or water power generation" to "wind/water power generating"
- 3. Section "Specialized wiring" second line: "grounding and conductor" change to "grounding/bonding and conductor".
- 4. Section "Specialized wiring" last line: "No minimum requirements for any license types" change to "If applying for EJ minimum of 500 hours"
- 5. Section "Low voltage systems" second line: "perimeter/video and fire alarms" change to "security/video and fire alarms"
- 6. Section "Low voltage systems" add fourth line: "**If** applying for **EJ** minimum of 500 hours"

## b) California requirements for certification of electricians

The Board members reviewed email correspondence between Ms. Tamanaha and the California State Contractors License Board regarding California's licensure requirements for performing electrical work.

Ms. Tamanaha reminded the Board members that this issue came up because of several applicants from the State of California and the questions that the Board members had regarding who is qualified to attest to the applicants' experience.

The Board members noted that, in California, B-General Building classification contractors are not required to have certified electricians as employees to perform electrical work, therefore in these situations a licensed journeyman electrician will not be required to sign an experience verification form and the Board should accept an experience verification signed by a licensed general contractor. If, however, the applicant works for a C-10 electrical contractor who must employ licensed electricians to perform the electrical work, the experience verification form shall be signed by a licensed electrician.
