Western States Chiropractic College sent new documentation to show 20 hours for continuing education.

The Board considered whether Hawaii-licensed doctors of chiropractic are eligible to perform the FAA BasicMed medical exam for general aviation pilots.

		Chair Klein and Dr. Pleiss agreed that chiropractors are physicians who are able to perform physical exams. After a brief discussion, it was moved by Chair Klein, seconded by Ms. Kang-Kaulupali, and unanimously carried to have EO Doi send a response letter stating that the Board informally opined that a Hawaii-licensed doctor of chiropractic may perform the BasicMed medical exam for aviation pilots.
Chair's <u>Announcement</u> :	A.	2018 Federation of Chiropractic Licensing Boards (FCLB) District Meeting
		Chair Klein briefed the Board on the FCLB meeting he attended. He stated that it is a non-profit association of government agencies that license and regulate doctors of chiropractic. It was established in 1926 and works to protect the public and serve member boards by promoting excellence in chiropractic regulation.
		He further stated that FCLB is the only organization that brings board members and officers from various states together to consult with one another on different issues. There are five different districts around the country that consist of thirteen states.
		FCLB has an annual meeting in May that is held in California. He stated that he usually attends these meetings to learn more. Chair Klein feels that Board members would benefit from attending these meetings. He suggested that travel expenses be allocated to fund attendance for future meetings.
		Chair Klein also wanted the Board to be aware of the Providers of Approved Continuing Education ("PACE"). There are about 30 states that participate in this program. Essentially, it is a service provided by the FCLB at no cost for a member.
		PACE will look at the continuing education applications and pre-approve the continuing education to save the Boards the extra work in reviewing and approving.
		If the Board is interested in participating in this type of program, the Board would still retain the authority to approve or deny any particular program.

> The providers would complete details of the materials, such as, Hawaii denies hours for acupuncture. PACE would work closely with the Board to specifically know exactly what the Board will accept and deny, and would give suggested approvals based on the information that the Board provides them.

> Chair Klein noted that PACE might be something that the Board may want to research further and consider using their services, as there is no cost to the Board.
