- 5. <u>Executive</u> a. <u>DCCA Disciplinary Actions (through September 2018)</u>: Officer's Report:

EO Fernandez advised the Board that there were no disciplinary actions regarding Optometry during this period. The report was circulated to the members for their information.

b. <u>Association of Regulatory Boards of Optometry (ARBO) – Advocacy vs.</u> <u>Regulatory</u>

> EO Fernandez shared a brief summary from an ARBO article that offered the perspective that, generally speaking, advocacy organizations protect the profession and Regulatory organizations protect the public. However, ARBO wished to avoid portraying advocacy and regulation as mutually exclusive, and rather promote the profession and protection of the public collaboratively. EO Fernandez mentioned that he could forward a copy if requested.

c. <u>American Optometric Association ("AOA") First Look – AOA President</u> seeks to Expand Scope of Practice

EO Fernandez shared that the newly elected AOA President, Dr. Pierce seeks to broaden optometric scope of practice throughout the country. In the article, he is quoted as saying, "For there to be a future profession, it must continue to evolve and change, and this means the expansion of procedures available to an O.D. to offer to their patients". He went on to say, "And so, what I want to do is to make sure the AOA is standing ready to assist states in any way possible to accomplish expanded scope of practice."

a. <u>Discussion on Telemedicine</u>

Dr. Au mentioned that legislation was passed and questioned who does it impact and how does it impact? DAG Jacob stated that he is aware of the medical statute which states that a patient/doctor relationship must initially be set up face-to-face and thereafter telemedicine would be appropriate. He went on to ask if anyone had specific questions, as it would be better for him to take back (to the office) and report back to the Board at the next meeting. For example, he asked what was the purpose of the conversation regarding telemedicine. Dr. Au shared a scenario where a business allows an optician to refract, yet the doctor who owns the license

is out of state. The O.D. does not log-in at real time, but rather logs in after the procedure, just to sign off on the prescription; making it a legitimate prescription. She added that the O.D. does hold a Hawaii license. The DAG shared that it wouldn't be unlicensed practice per se as the O.D. is licensed (in Hawaii). Chair Shoji mentioned that our laws are archaic and need to be updated. Dr. Au suggested that they mirror what the medical field is doing, without having to reinvent the wheel. DAG Jacob advised that telemedicine is a statute that states that the doctor/patient relationship must first be set up face-to-face. The DAG will see if it is appropriate for the Board to mirror the statute. Dr. Shibayama added that the Board should definitely address this as there are some companies such as 1-800-CONTACTS where you can renew your prescription without going in for an appointment. Dr. Au suggested that this practice was not in the best interest of the patient. DAG Jacob stated that the would research the subject before the next meeting.

Relating to the subject of CE approvals. Dr. Au guestioned what was within the Board's regulatory power if a course provider doesn't want to pay the fee accompanying the application. Also, what security would the Board have regarding approvals of CEs during the biennial renewal when they are due, if a CE is used by licensee and approved by the Board having not getting pre-approval of the course provider prior? Dr. Au was referring to Hawaii Administrative Rules §16-92-39(c) which states: "All courses sponsored by persons or organizations other than those outlined above shall be submitted to the board for approval on a form as provided by the board, unless the course is approved by the Council on Optometric Practitioner Education. Forms shall be submitted to the board no more than forty-five days after the course is completed." DAG Jacob recommended that further general discussion regarding continuing education be put on the agenda for the next meeting. However, to the extent that the Board has questions regarding what approval is required for CE programs and how that approval works including the powers of the Board, He thought those guestions are appropriate under the title request for CE program approval. Mr. Kubota suggested that the Board enter executive session if they were consulting with DAG Jacob about their, immunities, powers and duties.
