Chair Shimabukuro called for a recess from the Board's meeting at 9:02 a.m., to discuss and deliberate on the following adjudicatory matter, pursuant to

After discussion, it was moved by Ms. Kubota, seconded by Vice Chair lopa, and unanimously carried to approve the above-referenced Settlement Agreement.

3. Approval of Board Minutes of the September 11, 2018 Meeting:

Chair Shimabukuro asked if there were any comments or concerns regarding the Board minutes of the September 11, 2018 meeting.

There were none.

There being no further discussion or amendments to the minutes, upon a motion by Ms. Wakabayashi, seconded by Vice Chair lopa, it was voted on and unanimously carried to approve the minutes of the September 11, 2018 meeting as circulated.

4. Executive Officer's Report:

a. 2018 Renewal

EO Taniguchi reported that the 2018 license renewal has begun. He noted that similar to the 2016 renewal, this year's renewal application includes a self-attestation by the licensee that they have completed the continued competence requirement. After the renewal, the Board will again randomly audit 5% of physical therapists who renewed their license at the "active" status.

b. 2019 Board Meeting Schedule

EO Taniguchi stated that the 2019 meeting schedule has been finalized and provided to the Board. He reminded the board members if they are unable to attend any of the meetings, they should notify staff as soon as possible.

c. 2019 Board Appointments

EO Taniguchi reported that Vice Chair lopa and Ms. Kubota will be completing their second terms on June 30, 2018. As board members may only serve a maximum of eight consecutive years on the board, they are not eligible to be reappointed. He noted that Mr. Turner's first term ends on June 30, 2018 and he is eligible for reappointment. The Board also has a public member position open. He stated that any physical therapists or members of the public interested in applying may submit an application through the Governor's Office of Boards and Commissions.

- 6. New Business:
- a. Request from Meredyth Given of MedBridge inquiring if the time for taking the exam/learning assessment be included in the time calculation for continuing competence units ("CCUs") and if so, is the Mergerner Formula acceptable to calculate the exam time

The Board reviewed Ms. Given's inquiry.

After some discussion, upon a motion by Vice Chair Iopa, seconded by Chair Shimabukuro, it was voted on and unanimously carried that based on the information provided in Ms. Givens' email, the Board will allow the time for taking the exam/learning assessment to be included in the time calculation for CCUs and that they will accept the use of the Mergener Formula to calculate the exam time.

7. Old Business:

a. <u>Discussion regarding update of "List of Other Competence Related Activities</u>
Approved by the Hawaii Board of Physical Therapy"

An updated copy of the "List of Other Competence Related Activities Approved by the Hawaii Board of Physical Therapy" document was provided to the Board based on the revisions requested at the Board's last meeting.

EO Taniguchi noted that any changes made would not affect the continuing competence requirement for the December 2018 license renewal.

The following are some of the substantive changes which were discussed:

- For research/scholarship/authorship activities, the CCUs for authoring a publication or contributing to a research project will be per publication/research project.
- For teaching activities, an original letter from an authorized representative (i.e. of the institution, program, event organizer, clinic (for workplace in-service) will be required. If the licensee is the sole event organizer or owner of the clinic (in the case of workplace inservice), the licensee must submit an original signed written statement including a self-attestation that the statement is true and correct.
- For presenting a workplace in-service, a licensee is allowed a maximum of 5 CCUs per licensing biennium.
- For service activities, a licensee is allowed a maximum of 4 CCUs per licensing biennium. An original letter from an authorized representative of the committee/board/organization or community service event will be required. If the licensee is the sole community service event organizer, the licensee must submit an original signed written statement including a self-attestation that the statement is true and correct.
- For serving as committee chairperson, board member, or officer in a
 professional or governmental organization related to physical therapy
 practice, CCUs will only be given for a full year of service. No CCUs
 will be given for less than one year of service.

The Board will resume discussion of the changes at their next scheduled meeting.

d. Other CC Activities Requests for Review

1) Request from Kendra Harrington of the American Physical Therapy Association ("APTA") inquiring about CC units for faculty or mentor participation in an accredited residency or fellowship program

The Board reviewed a request from Ms. Harrington inquiring whether faculty or mentor participation in an accredited residency or fellowship would be considered towards Hawaii's CC requirement. Ms. Harrington stated teaching within an American Board of Physical Therapy Residency and Fellowship Education ("ABPTRFE") accredited residency or fellowship program can be either lecturing for didactic coursework or clinical mentoring (instruction) of residents/fellows-in-training during patient care.

After some discussion, it was the consensus of the Board that based on the information provided, serving as a clinical instructor or mentor to a physical therapist student, physical therapist assistant student or a physical therapist participating in an accredited fellowship or residency program will be acceptable as professional practice CCUs. The Board determined that if the required supporting documentation is submitted, the licensee would

receive 1 CCU for every 40 hours with each student, however, credit will only be given for first delivery during the renewal period.
