Upon a motion by Ms. Boyer, seconded by Mr. Duldulao, it was voted on and unanimously carried to accept the report and recommendations of the Education Committee's January 3, 2019 meeting.

# Executive Officer's Report:

## Conferences/Seminars/Meetings

NCSBN Midyear Meeting, March 26-28, 2019, San Antonio, Texas The EO announced that the Chair and Ms. Kodama will be attending.

## 2019 Legislative Session

The Board discussed the following legislative measures:

**Aspiration Abortions** 

HB 357 Relating to Health

SB 415 Relating to Health

HB 1434 Relating to Advanced Practice Registered Nurses

The EO reported that at the January meeting, the Board wanted clarification from the Hawaii Medical Board (HMB) if uterine aspiration was considered a "surgical" procedure in order to further discuss if the nurse practice act would have to be amended to specifically allow APRNs to perform this procedure should the Board determine that it would benefit the health and safety of the women of this State.

The EO stated that the HMB, at its January 17, 2019 meeting determined that abortions, by either vacuum aspiration or dilation and extraction is considered surgery.

The Chair was concerned with the risk and complications that could occur with any surgical procedure. He stated that this is surgery and would require critical knowledge and expertise as well as performed in a controlled environment.

The Vice Chair also was concerned for insufficient knowledge, education and experience for APRNs to perform this surgical procedure.

Ms. Boyer expressed her concerns that this was framed a surgical procedure that may not fall within the APRN's scope of practice as they may only "assist" in surgery and asked about the outcomes of other states who allowed APRNs to perform this procedure.

Mr. Duldulao concurred with the Vice Chair and expressed that this was within the scope of practice of a doctor.

After further discussion, it was the consensus of the Board that their testimony should reflect the concerns/comments discussed and if amendments to the nurse practice act was inevitable, then APRNs may be allowed to perform aspiration abortions under certain conditions.

Nurse Licensure Compact
HB 1363 Relating to Nurses

The EO explained this bill would require the Hawaii BON join the Nurse Licensure Compact and that at the House Health and Intrastate Commerce joint committee hearing on February 5, 2019, she submitted testimony expressing the Board's concerns with the inconsistent renewal requirements between the states, the ability for the Board to discipline a nurse who holds a multistate license from another state but practicing in Hawaii, the lack of notification of nurses practicing in

this State and the fiscal impact. She said that the Regulated Industries Complaints Office (RICO) also submitted testimony expressing concerns with the ambiguous language in the bill and the fiscal impact.

The EO stated that the committees decided to remove the compact language in the bill and instead, establish a task force to identify potential issues that would arise from joining the nurse licensure compact.

After further discussion, it was the consensus of the Board to support the task force idea.

## **APRN Reimbursement**

HB 984 Relating to Insurance SB 1210 Relating to Insurance

The EO reported that on February 1, 2019, the House Consumer Protection and Commerce committee heard HB 984 and passed out deleting the sections to be amended that pertain to the reimbursement of APRNs and pharmacists.

The companion bill, SB 1210 was not scheduled for hearing at this time.

SB 202 Relating to Professional and Vocational Licensing

The EO reported that she is tracking these bills and wanted the Board to review SB 385 Relating to Professional and Vocational Licensing that repeals defaults to student loans, student loan repayments contracts, and scholarship contracts as grounds for sanctioning a license.

The Chair opposed this bill stating that nurses should financially responsible and payback any loans.

Ms. Boyer stated that nursing schools need to report on loan default rates to their accrediting body.

Ms. Kodama stated that nurses have a financial obligation.

The EO could not recall that this Board has ever disciplined a license for non-payment of a student loan but have seen endorsement applicants who have been disciplined by another BON for non-payment of student loan and also asked what the difference was between paying back a student loan and failure to pay taxes since the Board was opposed to the bill requiring a tax clearance for licensure?

The DAG stated that there is no data that nurses in this State are not paying taxes or student loans because the state or federal agency responsible for certifying the individual is not paying student loan or taxes is not reporting to the Board.

After further discussion, it was the consensus of the Board that nurses should be financially responsible to pay their student loan and that the authority to discipline a nurse for non-payment or default should remain under the Board.

#### 2019 Renewal

## Continuing Competency

Updates to Continuing Competency Booklet - The EO reported that she is preparing a memo to be posted on the Board's web page that includes the both renewal requirements: continued competency and criminal history check for the first group of nurses licensed prior to July 1, 2017. This memo would also include updates to the continuing competency booklet information and FAQs.

Dissertation from Kelly J. Collins – Deferred from January and February 2019 Meetings – Deferred so the Chair and Dr. Napoleon can review.

Request for Board Recognition of National Certification Corporation Neonatal Pediatric Transport (NPT) – The Board reviewed the information for this national certification and determined that since this national certification is recognized by the National Certification Corporation (NCC) and the Board recognizes NCC, this is a national certification that would exempt a nurse from the continuing competency requirement as long as the nurse maintained this current certification at the time of renewal.

The Board also delegated to the EO to approve a national certification if the national certifying body was accredited by the NCC.

#### Criminal History Record Check

The EO reported that the list was posted on the Board's web page and have triggered phone calls on how and why and is hoping that the memo she is preparing will answer some of the questions, but that nurses should go to the Board's web page to read at least the Important Announcement as well as the Renewal and Restoration requirements.

## Concerns from Christopher Paik, RN

The Board reviewed and discussed an email from Mr. Paik expressing his concerns with the fingerprinting requirement and the cost and the Board's failure to recognize ACLS and PALS as meeting the continuing education requirement.

The Board understands the financial impact the fingerprinting and continuing competency requirement will have on the nurses. The fingerprinting will only have to be done once for licensure and unfortunately fingerprinting done for employment purposes does not allow the Board to receive those fingerprint results. As for the recognition of ACLS and PALS as meeting the continuing education requirement, the Board determined that these courses do not meet the definition of "Continuing competency" or "Competency" as defined in HRS §457-2.

## Scope of Practice

RN Performing Sharp Debridement – Deferred from January 3, 2019 Meeting The Board previously discussed the following email and deferred further discussion until they consulted with the HMB to determine if sharp debridement was considered a surgical procedure that could be performed by a nurse:

"My name is Benjamin Ramos. I am the Regional Wound Consultant for Avalon Care Group. I have searched online regarding the Scope of Practice for Registered Nurses for the state of Hawaii in regard to conservative sharp debridement. I did find some information but I wanted a definite answer. The Board of Nursing does not state whether an RN can or cannot perform the procedure. If an RN has appropriate training and certification for sharp debridement, is the RN able to perform the procedure? The reason why I'm asking is we have a large population of patients with necrotic tissues over the wound bed. With the removal of necrotic tissues, the wound will heal faster and decrease the likelihood of developing infections. Please advise."

The EO reported that the HMB's position was that debridement is considered "surgery".

After further discussion, the Board informally opined that in addition to their previous concerns that this was an invasive most aggressive procedure, this procedure is considered "surgery" and is not considered a basic nursing task so therefore a nurse may not perform this procedure.

In accordance with HAR § 16-201-90, the above interpretation is for informational and explanatory purposes only and based solely on the information provided. It is not an official opinion or decision and therefore not binding on the Board.

## <u>APRNs Performing Uterine Aspirations for Miscarriages and Nonviable</u> Pregnancies – Deferred from January 3, 2019 Meeting

The Board already discussed this issue under the 2019 Legislative Session report.

## APRNs Performing Uterine Aspirations for Miscarriages and Nonviable Pregnancies

The Board previously discussed this agenda item during the 2019 Legislative Session agenda item due to the additional distribution of proposed legislation.

## **APRNs Performing Vasectomies**

The matter for APRNs performing vasectomies arose from a discussion at the last Board meeting during the discussion of APRNs perform abortions.

Ms. Boyer noted that the Board has previously determined that an APRN may perform a vasectomy.

The EO confirmed that at the September 7, 2017 meeting the Board determined that the nurse practice act does not specifically prohibit or allow this procedure and therefore referred to the Scope of Practice Decision Making Framework to determine if this falls within the APRNs scope of practice.

The Vice Chair stated that a vasectomy is considered a "medical sterilization procedure" that is considered a surgical procedure.

After further discussion, it was the Board's informal interpretation that APRNs may not perform vasectomies.

In accordance with HAR § 16-201-90, the above interpretation is for informational and explanatory purposes only and based solely on the information provided. It is not an official opinion or decision and therefore not binding on the Board.

# Hawaii State Center for Nursing:

## **Pre-licensure Clinical Placement Capacity**

Ms. Oliveira reported that there is a shortage of clinical placements for nursing students and that there is consideration of HI-def simulation to address the clinical component of nursing students.

Ms. Muraoka stated that the lack of availability in acute care and LTC settings is critical.

The EO stated that she will place this matter on the agenda for the next Education Committee to discuss.

**Reforming America's Healthcare System Through Choice and Competition**Ms. Oliveira stated that the state of Washington introduced bills for APRN reimbursement. She also stated that Hawaii does not have a nursing shortage but there are vacancies for specialty nurses.
