B. Application for Shop License – Beauty Shop

(1) Ashly K. Copp

After discussion, it was moved by Chairperson McKay, seconded by Ms. Williams, and unanimously carried to accept the beauty shop application for shop license of Ashly K. Copp.

C. Application for Exam & License – Barber

(1) Dyson K.P. Ramones

After discussion, it was moved by Chairperson McKay, seconded by Mr. Choi, and unanimously carried to approve the barber application for exam and license of Dyson K. P. Ramones subject to verification of training hours through further documentation such as paystubs or GE license, and to delegate the Executive Officer to approve the application once in receipt of the aforementioned documents.

(2) Louie C. Lazo

After discussion, it was moved by Chairperson McKay, seconded by Mr. Choi, and unanimously carried to conditionally approve the barber application for exam & license of Louie C. Lazo. The conditions are as follows:

- Mr. Lazo must comply with all of the terms and conditions of his probation;
- Mr. Lazo must annually submit to the Board a criminal history record check current at the time of submission with the first submission occurring on April 22, 2020;

 If these conditions are not met, the conditional license will be revoked, and he may re-apply for licensure after a five-year period.

Executive Officer's Report:

A. <u>Licensing Examination of the National-Interstate Council of State Boards of Cosmetology ("NIC")</u>

Executive Officer Kleinhans reported that he had a conference call with Prometric and that they would be able to switch to the NIC examination. He added that there may be some issues that would need further exploration and discussion, however noted that an administration bill may not be necessary.

Total Exams Passed 10 (27% pass rate)
Total Exams Failed 26 (73% fail rate)

Scope of Practice: A. What license is required to perform "dermaplaning"?

Discussion ensued on the issue of "dermaplaning," which is the use of a scalpel to shave off dead skin cells. After discussion, it was moved by Chairperson McKay, seconded by Mr. Choi, and unanimously carried that "dermaplaning" does not fall under the scope of practice of its licensees.

B. What license is required to perform "microblading"?

The Board discussed "microblading," which is a tattooing technique mainly used for eyebrows. After discussion, it was moved by Chairperson McKay, seconded by Mr. Choi, and unanimously carried that "microblading" is outside the Board's jurisdiction as tattooing is regulated through the Department of Health.
