2019 Legislative Session

The EO reported on the following legislative measures:

Aspiration Abortions

SB 415, SD1, HD1, Relating to Health – Bill was amended to establish a task force, but at next hearing, CPC deferred measure so this measure is not moving forward.

Nurse Licensure Compact

HB 1363, HD2, Relating to Nurses – Bill was not scheduled for hearing when it crossed over so it is not moving forward.

APRN Reimbursement

SB 1210, SD1, HD1, Relating to Insurance – This bill no longer includes reimbursement language for APRNs so she is no longer testifying on this bill. SB 25, SD2, HD1, Relating to Insurance – This bill includes the reimbursement language for APRNs but has a defective date of 7/1/2050. This bill passed out of FIN and should cross back to the Senate and may go to conference. APRN Related

HB 658, HD1, SD1, Relating to Health – This bill authorizes that advanced practice registered nurses be included within certain rules adopted by the Department of Health. This bill passed w/amendments by CPH, should cross back to the House and maybe go to conference.

SB 984, SD1, HD1, Relating to School Based Health Services – This bill includes advanced practice registered nurses with prescriptive authority in the list of health care professionals authorized to administer medication to public school students. Requires administration of the medication to be approved by the department of health or other on-campus, school based, health care provider pursuant to a written agreement with the department of education. This bill passed out of FIN and should cross back to the Senate with an effective date 2022, so it may or may not go to conference.

<u>Other</u>

SB 1404, SD2, HD1, Relating to Loan Repayment for Health Care Professionals – This bill appropriates funds for the Hawaii Rural Health Care Provider Loan Repayment Program administered through the John A. Burns School of Medicine of the University of Hawaii at Manoa; provided that the funds are matched on a dollar-for-dollar basis by a private or another public source. The purpose of this Act is to appropriate funds to the department of health to fund the Hawaii rural health care provider loan repayment program administered through the John A. Burns school of medicine to provide loan repayment for physicians, physician assistants, psychologists, **nurse practitioners**, social workers, marriage and family counselors, and **nurses** who agree to work in a federally-designated health professional shortage area or in a geographic area of Hawaii found to be underserved. This bill passed out of FIN and should cross back to the Senate who will probably disagree due to the defective date of 2052 so this may go to conference.

SB 385, SD2, HD2, Relating to Professional and Vocational Licensing – This bill repeals defaults on student loans, student loan repayment contracts, and scholarship contracts as grounds for denying professional and vocational licenses and sanctioning professional and vocational licensees. This bill passed out of FIN and should cross back to Senate who will disagree due to defective date of 3000 and may go to conference.

2019 Renewal

Continuing Competency

Updates to Continuing Competency Booklet – No change in report from the March 2019 meeting.

Dissertation from Kelly J. Collins – Deferred from January, February and March 2019 Meetings

The EO was concerned that perhaps the Board should not be reviewing dissertations to determine if it meets the continuing competency requirement and recommended that it will be up to Ms. Collins to determine if her dissertation meets one of the learning activity options and if/when requested by way of the random audit, to submit her dissertation, the Board can determine whether or not it meets one of the learning activity options.

The Board reviewed the information that was provided, including but not limited to the summary of the course, training provider(s), course content, learning objectives and course content description and determined that this course did not contain nursing related content and there was no indication that this course was approved/accredited by a Board approved provider therefore the Board was not able to approve this course for continuing education credit.

The Board agreed.

Vizient Nurse Residency Program – Lauren Miho

The Board discussed the following email inquiry:

"For the June 2019 license renewal, I have completed a board approved/Vizient Nurse Residency Program and Evidence Based Project in October 2017 at Adventist Health Castle. I was wondering if that would completed my learning activity to renew my license? Or would I also have to complete an additional 30 CEs to renew my license?

Also I would like to know if I am able to renew my license with the NRP completion, what forms would be need for documentation and or proof?"

The Board referred Ms. Miho to page 25 of the Continuing Competency booklet and also required Ms. Miho to submit the "objectives" from Castle.

International Board of Lactation Consultant Examiners – Elizabeth Kealoha

The Board discussed the following email inquiry:

"I would like to request that the IBCLC (International Board Certified Lactation Consultant) credential be approved for the renewal requirements of Registered Nurse. I have included the IBCLE (International Board of Lactation Examiners)requirements which would make a candidate eligible to take the exam. The intensive hours of hands on experience, letter of recommendations and education make this prestigious certification one which not everyone can qualify for. Due to my many years as a labor, delivery, postpartum and nursery nurse I was able to meet that requirement."

The Chair and Ms. Boyer volunteered to review the information and web page and report back to the Board at the May meeting.

Certified Occupational Hearing Conservationist; Iowa BON Approved Continuing Education

The Board discussed the following email inquiry:

"I am working on my continuing competency requirements given that my license is due in June and wanted to verify with the board of nursing if my completion of activities will fulfill the new requirement. I am currently working as a nurse in Occupational Health and hold the following certifications:

- "COHC" (Certified Occupational Hearing Conservationist)—Would this be considered a "National Council" and can be exempt from the continuing competency requirements or qualify as a continuing education? Page 10 has American Board for Occupational Health Nurses but the Occupational Health Council Accreditation is not listed on there.
- I wanted to check if my recent completion of the NIOSH Approved Spirometry Training and Respiratory Surveillance Training Program can be qualified for continuing education activities. This was done in November 2018 and I received 20.4 contact hours.
- Lastly, the Nurse Scholar Program that I received from AgriSafe through Northeast Iowa Community College

I've attached supporting documents for the above items.

My goal for this year is to obtain my Occupational Health Nursing Certification by first completing an Occupational Health and Safety Principles and Nursing Certification Review in Los Angeles, CA which includes 24.3 hours of continuing education credit approved by CA BRN. We are such a small group here in Hawaii that often times, our nurse continuing education is provided from the mainland. I've noticed that the courses that I've seen are geared more for Safety Techs. We don't have an Occupational Health Nurses Association in Hawaii but ideally, I'd to like to start one here.

I have applied for my Hawaii license by endorsement, which my original state is from California. According to their processing timeline on their website they have sent you verification of my CA RN license. I have a travel assignment starting April 22 in Hilo Medical Center, and was wondering if my Hawaii license for endorsement has been approved yet? Please let me know."

After careful consideration, the Board determined that the national certification for Certified Occupational Heating Conservationist does not meet the definition of "Certification" under HAR §16-89-2, however, the continuing education from the Northwest Iowa Community College would be acceptable towards the continuing education learning activity option since Northwest Iowa Community College is accredited by the Higher Learning Commission, a regional accreditation agency recognized by the U.S. Department of Education.

National Board for Certified Counselors (NBCC) – Gayle Kutaka

The Board discussed the following email inquiry:

"My name is Gayle Kutaka and I am licensed as an RN 15975 and an APRN 430 in the State of Hawaii. In May 2018, I took a two day workshop in Thought Field Therapy by Caroline Sakai PhD who has been teaching and practicing Thought Field Therapy since 1998.

The workshop granted 15 CE hours by the National Board of Certified Counselors ("NBCC").

Since then, I have used this modality in my private practice for the treatment of my patients and found the intervention very effective particularly for those who have panic disorders and post traumatic stress disorders.

I am requesting approval of these CE hours to be used in the renewal of my license as an RN and APRN. Information on this modality, workshop, and Dr. Sakai can be found on the link below. https://www.tftcenter.com/"

After careful consideration, it was the consensus of the Board to accept the continuing education from the workshop by the NBCC.

Clinical Documentation Specialist; American Association of Professional Coders, American Health Information Management Association and Association of Clinical Documentation Improvement Specialists Continuing Education – Penny Souder

The Board discussed the following email inquiry:

"I have 2 certifications relevant to my area of nursing: Clinical Documentation Specialist.

I have CEU's through AAPC (American Association of Professional Coders), AHIMA (American Health Information Management Association), and ACDIS (Association of Clinical Documentation Improvement Specialists) Are any of these acceptable CEU's? I have checked the list, and I am not seeing it. Could you direct me to someone who could answer this?

Ms. Boyer stated these certifications do not appear to meet the requirements for "national certification" as it is not related to nursing specifically and the Continuing Competency booklet provides for examples that are not specific to the role of nursing that includes:

"Certification courses or programs *not* accredited by those noted in 1b of the described learning activities and/or which are not specific to the role of nursing *Examples*: Certifications which have been endorsed or accredited by the Commission on Certification for Health Informatics and Information Management (CCHIIM) and is offered through an organization like American Health Information

Management Association (AHIMA) are not specific to the role of nursing. AHIMA provides educational programs geared toward certification in health information management (HIM) subject matter. Non-nursing professionals are eligible to earn HIM related certifications. Certifications such as Registered Health Information Administrator (RHIA®), Registered Health Information Technician (RHIT®), Certified Coding Associate (CCA®), Certified Coding Specialist (CCS®), Certified Coding Specialist-Physician-based (CCS-P®), Certified Documentation Improvement Practitioner (CDIP®), Certified Health Data Analyst (CHDA®), Certified in Healthcare Privacy and Security (CHPS®), or Health Information Technology

Professional (HIT-Pro) which are aimed at the development of HIM skills and knowledge are accredited by the NCCA but are <u>NOT</u> nursing specific. Therefore, these types of certifications are *not* eligible for automatic exemption for continuing competency credit.

However, if the non-nursing certification is accredited by a nationally recognized accrediting body such as those identified on page 20 under "Learning Activity Options–Continuing Education" "b" (i.e. ICE, NCCA, or Joint Accreditation for Interprofessional Continuing EducationTM etc.), then the individual course work leading up to the certification can be applied toward credit-for-credit CE or converted into contact hours as defined on page 4 under definition of "Contact hour" (*Definition of "Contact hour" in HAR §16-89-2*) of the learning activity options to be applied toward state competency requirements...."

She stated that there is a "however" if the non-nursing certification is accredited by a nationally recognized accrediting body, then the individual course work leading up to the certification can be applied toward credit-for-credit CE.

The Board agreed.

International Association for Continuing Education and Training – CEs and/or National Certification, Barbara J. Penniall

The Board discussed the following email inquiry:

"Preparing my documents for RN renewal and wanted to confirm that CE's that are approved and accredited by IACET would be accepted. It is not list but is ANSI/IACET compliant and used by the government for CE credits for RN Surveyors. I do have the Certification Certificate of accreditation. Thank you Barbara J Penniall

The International Association for Continuing Education and Training (IACET) developed the original Continuing Education Unit (CEU) and today ensures that providers of continuing education and training can prove they provide high-quality instruction by following the **ANSI/IACET Standard for Continuing Education and Training** through a rigorous accreditation process."

Dr. Napoleon stated that this certification and the continuing education accreditation appears to be too broad and not specific to nursing practice. When she reviewed the web page, it appeared that this organization certifies many disciplines.

After careful consideration, based on the information that was submitted, it was the consensus of the Board that the national certification or CEs would not meet the exemption or CE learning activity option.

Nurse Residency Program – Megan Heller

The Board discussed the following email inquiry:

"In regards to renewing an RN license, I am wondering if a nurse residency program completed in 2018 in Florida would suffice for this year's renewal as my Hawaii license was achieved in 2017."

It was the consensus of the Board that if the nurse residency program was through a nationally accredited nursing program, employer or professional organization, and completed between July 1, 2017 to June 30, 2019, then it would satisfy this learning activity option.

Evidence Based Project 2018 Educator Workshop – HSCFN

The Board reviewed/discussed the course information submitted and after careful consideration it was the consensus of the Board to approve this workshop for CE credit.

Neonatal Resuscitation Program- Tiffany Nakamura

The Board discussed the following email inquiry:

"I am emailing the Board of Nursing to inquire about whether NRP will count as CE Credits for the new Hawaii Nursing Requirements this 2019."

After careful consideration, the Board decided this course was similar in concept to PALS and ACLS whereby these types of courses are a requirement for some practice areas but do not necessarily lead to the enhancement of nursing practice or improve workforce development.

Criminal History Background Check

The EO reported that a post card reminder was mailed to those nurses on the 2019 "list" who were licensed prior to 7/1/2017 and are required to be fingerprinted in order to renew their license this year.

She stated that if the license is "inactive" and their name appears on the list, they DO NOT have to get fingerprinted in order to renew "inactive", however they will need to be fingerprinted when they reactivate.

Legislative Updates

Copies of the following updates were distributed to the Board members for their information:

The Board noted the following changes in other states:

- 3/8/19 AL authorizes the board to provide loans to currently certified NPs, certified nurse midwives and CRNAs who contract with the board to practice in medically underserved areas of the state; FL – establishes that a health care practitioner's failure to repay a student loan or to comply with service scholarship obligations does not constitute grounds for disciplinary action; and AL – allows the board to enter into the eNLC.
- 3/15/19 KY prohibits occupational licensing authorities from suspending or revoking a license because the licensee is in a default or delinquent student loan; VA – requires health insurers (whose policies or contracts cover services that may be legally performed by licensed NPs) to provide equal coverage for such services when rendered by a licensed NP; VA – requires the BON to issue a license or certification to a military spouse within 30 days if an applicant meets the criteria for licensure or certification and is licensed or certified in another state; MT – requires professional and occupational licensing boards to license out-of-state applicants with equivalent licenses; ME – establishes a refundable tax credit per student for a health care preceptor who provides, without compensation, instruction to and supervision of advanced practice registered nursing students; and ME – allows a PA or APRM to perform abortions.
- 3/22/19 DC establishes the board of certified professional midwives to regulate the practice of midwifery; permits CPMs to supervise services at a maternity birthing center; NC establishes the certified midwives licensing act; SC provides that APRNs may perform specific medical acts pursuant to approved written guidelines, removes the supervision requirement from the definition of approved written guidelines and CRNA practice; AL extends the tax credit for physicians practicing in rural areas to certified registered nurse practitioners and CRNAs who practice in rural areas; and ME establishes a licensing requirement for holistic health practitioners, defines "holistic health practitioner," establishes and scope of practice.
- 3/29/19 IA provides for the procedures to expedite the occupational licensing of an individual licensed in another state and who is the spouse of an active duty member of the military forces; KY provides for the adoption of the Interstate Medical Licensure Compact; KY defines APRN, designated certified nurse midwife, certified professional midwifery services, and licensed certified professional midwife; creates the licensed certified professional midwives advisory council; KY creates a state department of veterans affairs nurse loan repayment program for RNs and LPNs within their employ; KY allows reciprocal occupational licensure for members of the U.S. military, reserves, and national guard, for

veterans and for their spouses; CO – concerns the ability of APRNs with prescriptive authority to obtain Level I accreditation under the state Workers' Compensation Act; GA – provides for the licensure and regulation of community midwives; NV – revises provisions relating to staff privileges for APRNs at hospitals; OH – eliminates the collaborative practice agreement required for APRNs to practice; OR – establishes personal income tax credit for nursing clinical preceptors; and NC – authorizes state to join the Psychology Interjurisdictional Licensure Compact.

Scope of Practice

<u>Cosmetic Laser Use – Nurse License Required?</u> The Board discussed the following email inquiry:

"I am inquiring on Cosmetic Laser use. I wanted to know if you had to be a RN or higher to operate a laser for cosmetic purposes, or can anyone under the supervision of a Medical Director operate a laser for cosmetic purposes, such as Hair Removal, Laser Resurfacing, etc?"

It was the consensus of the Board that since "laser" treatment is considered a medical procedure, it does not fall within an RN's scope of practice and an RN license is not required to perform this procedure under the direction of a licensed physician, that we refer the inquirer to the Hawaii Medical Board.

<u>American Holistic Nurses Credentialing Corporation (AHNCC) – Concerns with</u> <u>Disenfranchised Advanced Practice Holistic Nurses</u> The Board discussed the following email inquiry:

"Letter from the American Holistic Nurses Credentialing Corporation and the American Holistic Nurses Association expressing the following concerns that the APRN Consensus Model:

- Restricts the practice of many graduate nurses who provide essential direct and indirect services;
- Disenfranchises nurses from holistic health and wellness practice as opposed to prevention, management, or control of disease or conditions practice model;
- Disenfranchises the Advanced Practice Holistic Nurses group;
- No resolution related to information about the the disenfranchised Advanced Practice Holistic Nurses role previously sent to the SBON and LACE over the past five years."

The EO stated that the Board currently recognizes the American Holistic Nurses Credentialing Center's national certifications as specialty certification that qualifies for an exemption to the continuing competency requirement but does NOT recognize as a **nurse practitioner** practice specialty.

Also, the Dept. of Veterans Affairs (VA) is "promoting" for lack of a better term, "approach to healthcare that empowers and equips people to take charge of their health and well-being and to live their life to the fullest." As part of this adoption of the whole health approach in the VA, they are in the process of expanding the

| | "delivery of Complementary and Integrative Health (CIH). This would involve identifying "approved" CIH approaches (they have a master list) and determination if the approved CIH approach is within the scope of practice of LPN or RN or scope of practice for APRN. Currently, the BONs must be consulted for final determination, however, VA intends to "move toward an RN and an LPN standardized scope of practice where individual state boards would not need to be consulted to help determine if a CIH approach is within scope." |

| <u>Hawaii State Center</u> for Nursing: | Ms. Reichhardt reported that the Center submitted their application in for ANCC approval. She stated that once they become approved by ANCC, they will now be an approved provider for CEs in Hawaii. |

| <u>American Nurses</u> <u>Association – Hawaii</u> <u>Chapter:</u> | Dr. Beechinor reported on the following for their organization: They are currently surveying their 300+ members and did reach their goal of 50% positive participation Their next task is increasing membership by 40%; they hope to start reaching out to nurses who are not apart of the organization to join. They have been actively filing testimony supporting bills for preceptor tax credits and issues relating to homelessness, mental illness, keiki and Kupuna health and also working with the HSCFN to respond to other bills of interest; and They continue their participation in various community activities such as the Harm Reduction Conference, Annual AIDS Day, NAMI Walk, Opening Day of the 2019 Legislature and other nursing organizations activities. |
