b. Examination Review (Private Detective and Guard)

Executive Session: At 11:40 a.m., it was moved by Mr. Inouye, seconded by the Chief Faaumu, and unanimously carried to move into executive session pursuant to HRS §92-5 to consider and evaluate personal information relating to individuals applying for professional or vocational licenses cited in section HRS §26-9 or both, and to consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities, as provided in HRS §92-5(a)(1) and (4).

EXECUTIVE SESSION

At 11:48 p.m., it was moved by Chief Ferreira, seconded by the Chief Faaumu and unanimously carried to move out of executive session.

The Chair stated that after review of the examination, he would recommend the Board forming a Strategic Review Committee that would look in detail at the questions on both the Security Guard and Private Detective Exam. The committee will include the Chair, Chief Faaumu, and the Vice Chair.

It was moved by the Vice Chair, seconded by Mr. Inouye and unanimously carried to approve the formation of the Strategic Review Committee.

and Any Matters
Relating to its
Implementation:

a. 4-Hour CE Curriculum Certificate Attestation

The EO stated that at the January 2018 meeting the Board approved an attestation to be added to the 8-hour training certificates. She stated that recently we received inquiries if the attestation would also be required for the 4-hour Certificate.

The Board agreed that an attestation should be added to the 4-Hour CE Certificate to hold guard instructors accountable for the delivery of the course.

With a motion by the Vice Chair, seconded by Chief Ferreira, and unanimously carried, the Board approved the following attestation to be required on the 4-Hour CE Certificate:

"I certify that I am a Hawaii Board of Private Detective and Guards approved instructor teaching a board approved curriculum and that on (date) as required by the Hawaii Revised Statutes, Chapter 463, the above referenced individual was provided the mandatory 4-hour continued competency security on the topics and corresponding minimum durations set forth by the Board.

The above statements are true and correct to the best of my knowledge. I understand that this training and information is required by the Hawaii Board of Private Detectives and Guards and that submitting false or untrue information may constitute a violation of Hawaii Revised Statutes §710-1063 and could also result in the suspension or revocation of my guard instructor approval. “

Legislation:

a) HB73/SB774 SD1RELATING TO PROFESSIONAL AND VOCATIONAL LICENSING

The EO reported that opposing testimony was submitted on behalf of the division because the way the bill was initially presented would require all auxiliary personnel to obtain a license. The EO stated that unfortunately, many professions such as contractors are not individually licensed nor are under an apprenticeship program that would qualify them for the exemption. After discussions with Senator Baker the bill was essentially redone to target auxiliary personnel working in the dental industry and all other professions were exempt.

b) HB112/SB1114 RELATING TO TAXATION

The EO reported that this bill would require that every single licensee obtain a tax clearance. The EO stated that although some licensed business entities currently require the tax clearance, the department testified that they had concerns regarding Department of Taxations ability to handle the request, in addition requiring a tax clearance would be burdensome during renewals. Overall, the EO stated that this requirement would be an administrative nightmare that would cause multiple delays in processing licenses in a timely matter. However, the EO noted that the bill did not cross over and is now dead.

The Chair asked if the Board could take a position on the bill. The EO confirmed that the Board may take a position on it, should the bill resurface.

Upon a motion by the Vice Chair, seconded by Mr. Inouye and unanimously carried to oppose any bill requiring all licensees to obtain a tax clearance.

c) SB202 RELATING TO PROFESSIONAL AND VOCATIONAL REGULATORY PROGRAMS

The EO stated that the above bill would establish repeal dates for all professional and vocational regulatory programs under the professional and vocational licensing division of the department of commerce and consumer affairs. The EO stated that back in the 80s, the department was under a automatic review by the auditor every 7 years, at that point the auditor would recommend whether the department continue regulation or discontinue, however, they disbanded that process because the auditor couldn't keep up with all of the boards and commissions. Thus, this bill would put back this requirement and if the review did not occur in time there would be an automatic repeal date.

The Chair asked if there were any other comments or concerns. There were none.

Upon a motion by the Vice Chair, seconded by Mr. Inouye, and unanimously carried to oppose the automatic repeal date of this bill.

d) HB1528 RELATING TO COMMERCE AND CONSUMER AFFAIRS

The EO stated that HB 1528 suspended all of DCCA's fees for nine years. She reported that the Division testified that DCCA is self-funded and therefore, if we the State were to cease fees for that long, the division would not be able to carry out their mission to license all the individuals. Thus, as a result, they gutted out the cessation of all the fees and created HB 1528 HD1.

Upon a motion by Mr. Inouye, seconded by Chief Faamu, and unanimously carried to oppose the cessation of all licensing fees.

e) HB 1528 HD1 RELATING TO COMMERCE AND CONSUMER AFFAIRS

The EO stated that HD1 would now only targets the recovery fund. Therefore, the bill no longer affects this Board, however, we have recovery funds for both real estate and contractors. The EO explained that if you were an aggrieved person and entered into a contract with a licensed person and was harmed by the transaction you may recover for the fund. In this bill, they are requiring us to do an annual review of the funds. The EO pointed out that this bill in its current state is problematic because if they limit the funds and there are many complaints for that year, individuals would need to wait until the following year to potentially collect if the funds run out.

The Chair asked if there were any other questions? There were none.
