Subchapter 3 §16-72-4

> The practice includes cutaneous or invasive stimulation of specific points on the skin with or without retention of needles. Techniques include[d are] ashi needling, aquapuncture, acupressure, electrical, mechanical, thermal therapy, moxibustion, cupping, laser acupuncture, auricular acupuncture, lifestyle and dietary consultation and traditional therapeutic means, including prescribing and dispensing herbal medicine.

a. Chapter 92, HRS, Adjudicatory Matters

In the Matter of Acupuncturist's License of Mike Masayuki Hashimoto: ACU 2016-1-L – Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order.

Upon a motion by Dr. Kroll, seconded by Mr. Corcoran, with the exception of Chair Tsuchiyama who opposed the approval of the settlement agreement, it was voted on and carried by the majority to approve the Board's Final Order.

Report:

Executive Officer's a. Civil Beat article directly addressing the Board of Acupuncture

The Board reviewed the recent Civil Beat article entitled, "Longtime Acupuncturist Agrees to Stop Practicing to Settle Patient Complaint."

- b. Status of Legislative Bills Previously Discussed by the Board of Acupuncture
 - 1. SB547 (Relating to the Physical Therapy Practice Act)

Executive Officer Araceley informed the Board that this bill did not pass during the 2019 legislative session.

2. SB202 (Relating to Professional and Vocational Regulatory Programs)

Executive Officer Araceley informed the Board that this bill did not pass during the 2019 legislative session.

Ongoing Business: a. Finalizing Hawaii Administrative Rules (HAR) Chapter 16-72 Revisions

DAG Levins left the room at 2:04 p.m.

After some discussion, the following changes were requested (underlined material added, while bracketed material is to be deleted):

Subchapter 2 Definitions

§16-72-3 "Acupuncture needle" means [a straight, slender rod] an FDA approved Class II medical device; a sterile filiform needle of various lengths and gauges [diameter], tapered to a sharp point at one end for piercing or non-invasive stimulation of the skin, and the opposite [with one] end for manipulation or maintaining the needle in place. [, and inserted by an acupuncture practitioner into acupuncture points on the human body. A staple is not an acupuncture needle.]

"Auricular acupuncture" is a diagnostic and treatment system that stimulates specific acupuncture points with needle insertion, magnets or pellets on the external ear surface. It stimulates autonomic nervous system to maintain homeostasis, control pain and support detoxification.

"Ashi needling", also known as "Dry needling," "motor point needling,' and "myofascial trigger point needling" is an acupuncture technique that involves the insertion and retention or non-retention of thin, non-medicated solid filiform needles into muscles or connective tissues.

"Acupuncture Injection Therapy" (AIT), also known as point injection therapy, biopuncture, or aquapuncture, is a modern adjunctive Oriental Medicine technique in which a sterile liquid agent is injected into acupuncture points (including ashi or trigger points) to promote, maintain or restore health and to prevent disease. It uses hypodermic needle techniques at specific acupuncture point locations to produce successful clinical outcomes in accordance with Oriental Medicine. Licensees must complete training from an accredited acupuncture school or a Board-recognized state association, submit an application to the Board and provide proof of malpractice coverage of this technique before practicing AIT.

Subchapter 3 Authorized Practice; Scope of Practice; License

§16-72-4 An acupuncture practitioner is authorized to [conduct] examine and diagnose for the purpose of treatment of the human

body by [means of stimulation of a] <u>piercing and/or stimulating</u> certain acupuncture point or points <u>to regulate</u> [for the purpose of controlling and regulating] the flow and balance of energy, <u>neurovascular, immunological, endocrine and pain pathways[</u> in the body]. The practice includes cutaneous or invasive stimulation of [specific] <u>points on the skin with needles. Techniques included are</u> [the techniques of piercing the skin by inserting needles and point stimulation by the use of] acupressure, electrical, mechanical, thermal therapy, moxibustion, cupping, <u>laser acupuncture</u>, <u>acupuncture injection therapy</u>, <u>auricular acupuncture</u>, <u>lifestyle and dietary consultation and</u> [or] traditional therapeutic means[.], including prescribing and dispensing herbal medicine.

§16-72-6 Records. A licensee shall keep accurate <u>and secure</u> records of each patient the licensee treats. <u>Hard copy records shall be stored in a locked cabinet</u>. <u>Electronic records shall be digitally secure</u>.

Subchapter 4 Education and Training Requirements

Dr. Kroll noted that suggested changes to §16-72-14 did not coincide with Hawaii Revised Statues (HRS) 436E-5(d). DAG Levins clarified that the standards set in HRS supersede the rules set forth in Hawaii Administrative Rules (HAR). No changes were accepted.

Subchapter 5 Application for License

§16-72-20 Applications. (b) An application for a license may be filed at any time by an applicant who has taken and passed the examination identified in section §16-72-33 and shall be accompanied by the items required in subsection (a). The applicant shall be responsible for having the testing contractor verify, directly to the board, the passing [score] of the examination.

Subchapter 6 Examinations

§16-72-33 Examination. (a) <u>Effective Jan 2020, all licensed</u> acupuncture practitioners must provide proof of active diplomat status with NCCAOM or its successor testing agency.

Subchapter 8 Public Health and Sanitation

§16-72-53 Sanitation practices. Required practices shall include:

> (1) A fresh, disposable paper or a fresh sheet shall be used on the examining table for each patient; or a fresh disposable paper in the head area if treated in a chair.

It was moved by Dr. Kroll, seconded by Dr. Corcoran, and unanimously carried to approve the abovementioned changes.
