Mr. Kurokawa shared that CLARB has a series of four webcasts. There is a webcast today. They will train its members on Foresight which is what they do on the national board and to explore strategic planning and other matters.

Executive Officer's Report:

Request for NCEES Exam Proctors

EO Matsushima mentioned that NCEES is in need of a Chief Exam Proctor in Hawaii, as Ms. Edna Nakano is retiring. Proctors are required for paper exams. Many of the current proctors are retired teachers and their colleagues.

> Article regarding Waterfront Hotels and Climate Change;

EO Matsushima circulated the article for perusal. There is concern as to the impact climate change will have on the hospitality industry.

Election of Officers:

Ken Ota, Chairperson, Public Member – It was moved by Mr. Katayama, seconded by Mr. Ventura and unanimously carried to elect Mr. Ota as Chairperson.

Daniel Hirota, Vice Chairperson, Land Surveyor – It was moved by Mr. Katayama, seconded by Mr. Fujiwara and unanimously carried to elect Mr. Hirota as Vice Chairperson.

Joel Kurokawa, Secretary, Landscape Architect – It was moved by Mr. Katayama, seconded by Mr. Ventura and unanimously carried to elect Mr. Kurokawa as Secretary.

Presentation and Discussion, Mr. Timothy Hiu

Chair Yumol introduced Mr. Timothy Hiu, Deputy Director of the Department of Planning and Permitting, City and County of Honolulu. Mr. Hiu distributed his written response to questions that were posed by Board members prior to this meeting. One of the questions addressed was about how all of the counties could better communicate to be on the same page and if there were meetings involving representatives from all counties. There is an annual meeting with all the building permit administrators, held on a rotational basis between all four counties. The number of participants range from 20 to 70 individuals representing the four counties, fire department personnel from the various counties, national representatives from the code bodies: International Code Council (ICC), National Fire Protection Association (NFPA), International Association of Plumbing and Mechanical Officials (IAMPO), and other invited or interested parties.

The usual format is one day for educational seminars (which is open to the public), and a day and a half of presentations and breakout sessions, where various matters pertaining to the codes are discussed. The most current was recently held in Hawaii County at the end of May. The next scheduled annual meeting will be in Honolulu, arrangements can be made to have the Board participate in this annual meeting. EO Matsushima noted that she and the Board are interested in attending this meeting next year.

The counties have until the end of this calendar year to recommend changes to proposed code changes or they will automatically be approved. The counties will then have two years in which to adopt changes. In 2021, the process will begin again. There are no technical minutes provided from these meetings.

Mr. Ventura mentioned that Kauai county is adopting the 2018 code books. Honolulu has more amendments than Kauai. Each county is different in regards to their relationship with their local fire department.

Building codes are different in each county. Mr. Ventura asked why can't they be standardized. The reason that the codes are not standardized is because each county is unique.

One of the issues that is important to the counties are, moving in to the electronic age regarding plant/digital signatures. Current rules require wet signatures. This is something the Board may wish to consider.

Besides requiring wet signatures, electronic submittal of plans is not feasible because of the massive number of pages that comprise one plan. The computer system is unable to handle the volume.

There are less people filling the void of retiring professionals. For example, there is a shortage of engineers. There's a need for oversight now more than ever. The electrical and structural disciplines are difficult to fill. Mechanical may be affected as well. Mr. Iwamoto mentioned that it is

difficult to find structural engineers.

There was a question regarding the definition of an architect. In the rules, an architect is allowed to design small infrastructure work. It is very broad. Mr. Kurokawa commented that there are architects stamping things that they shouldn't be stamping. Mr. Hiu mentioned that the older generation architects have broader experience. For example, an architect submitted photovoltaic plans and an engineer was not happy about that. He's not sure if younger architects have the same level of experience, but they are allowed to design structural as well.

Architects must pass zoning code. There is the option of third party review which is available to the applicant. The building permit fee is for administrative review; however, an authorized third party may review plans and the client need not pay the city. Fees to the third party are market driven.

EO Matsushima shared that the issue of electronic signatures has been in discussion for the past two years in rules amendment, but security is a main concern.

Mr. Suzuki asked about the building officials meeting that used to be coordinated by the public works department, as he thought they were meeting sometime in June or July.

The Department of Public Works no longer exists. It is now the Department of Environmental Services.

The Hawaii Association of County Building Officials (HACBO) meets annually and this provides county building officials the opportunity to discuss matters important to their respective counties as well as a forum in which all may collaborate to make improvements to planning, permitting and the various factors involved.

After his presentation and discussion, Mr. Hiu entertained more questions for discussion. The Board had no further questions.
