Call to Order: The Chair called the meeting to order at 8:31 a.m. at which time quorum was established.

Chair's Report: **Announcements/Introductions**

The Chair excused Ms. Boyer and Dr. Napoleon and asked the audience to introduce themselves.

The Chair stated that he wanted to start working on a project for the Board to issue position statements on some nursing scope of practice issues and will be working with the EO and may also call upon some members to help him do research.

Approval of the Previous Minutes – June 6, 2019

The Chair called for a motion in regard to the minutes of the June 6, 2019 meeting.

Upon a motion by Ms. Kodama, seconded by Ms. Daub, it was voted on and unanimously carried to approve the minutes of the June 6, 2019 meeting as circulated.

2019 NCLEX Conference, September 9, 2019, Phoenix, Arizona – Ms. Boyer Attending

Boards and Commissions Member Orientation, October 11, 2019, 8:30 – 12:00, State Capitol Auditorium – The EO stated that this orientation is open to all new and existing members, regardless if you previously attended but would like a refresher.

Ms. Oliveira and Ms. Kodama stated that they would attend.

2019 Legislative Session

The EO gave the following report on the following bills:

APRN Reimbursement

SB 25, SD2, HD1, CD1 Relating to Insurance – This bill was approved by the Governor on 6/7/2019, Act 70

APRN Related

HB 658, HD1, SD1, Relating to Health – This bill establishes the advanced practice registered nurse medical leadership working group chaired by the Department of Health to research and make recommendations regarding advanced practice registered nurses' eligibility for medical leadership positions. (SD1) The House originally disagreed with the Senate's amendments ((1) Include a purpose section; (2) Establish the advanced practice registered nurse medical leadership working group ("working group") to be convened by the Department of Health and chaired by the Director of Health; (3) Specify that the working group is to research and make recommendations regarding APRNs' eligibility for medical leadership positions and identify any circumstances where that eligibility may be inappropriate; (4) Require the working group to report its findings and any proposed legislation to the Legislature prior to the 2020 Regular Session; and (5) Change its effective date to upon approval.), however, the House reconsidered and agreed with the Senate draft. This bill was approved by the Governor on 7/2/2019, Act 205.

Other

SB 1404, SD2, HD1, CD1 Relating to Loan Repayment for Health Care Professionals – This bill appropriates funds for the Health Care Provider Loan Repayment Program administered through the John A. Burns School of Medicine of the University of Hawaii at Manoa; provided that the funds are matched on a

dollar-for-dollar basis by a private or another public source. This bill was approved by the Governor on 7/5/2019, Act 262.

SB 385, SD1, HD2, CD1, Relating to Professional and Vocational Licensing – This bill repeals defaults on student loans, student loan repayment contracts, and scholarship contracts as grounds for sanctioning professional and vocational licensees. This bill was enrolled to the Governor on 5/6/2019.

Working Solutions – June 2019

A copy was distributed to the Board members as information only.

2019 Renewal

Statistics

The EO provided the following statistics as of July 1, 2019:

- APRNs – 1,743 eligible to renew, 1,548 renewed
- LPNs – 2,865 eligible to renew, 1,841 renewed
- RNs – 29, 668 eligible to renew, 23,130 renewed

Continuing Competency

The EO reported that once the hard copy renewal applications are processed, she will request a list of nurses randomly selected. The nurses selected will be sent a letter informing them they were randomly selected and to submit proof of compliance with the continuing competency requirement.

She stated that the Board previously determined that 5% of the total number of nurses was sufficient and that this list would also be posted on the Board's web page. The nurses selected for audit will have 60 days to respond and submit proof of the continued competency requirement.

Once received, the Board will begin reviewing the documents submitted and determine whether to delegate to the EO to approve the continued competency submittals with the exceptions of any questionable learning activity options.

The EO stated that if a nurse fails to respond to the request, he/she will be referred to the Regulated Industries Complaints Office (RICO) for investigation for failure to comply with the continuing competency requirement and for failing to respond to a request from the Board.

Criminal History Background Check

The EO reported that in addition to the continuing competency requirement, approximately 8,000 plus nurses were randomly selected to get fingerprinted for a criminal records history check for the 2019 renewal.

This will require that staff check the name of each nurse on the list with the Hawaii Criminal Justice Data Center ("HCJDC") to see if the nurse's name appears and if not, the nurse either did not get fingerprinted or may not have used the correct code. The nurse will be notified that we were unable to retrieve any results.

If the nurse's name on the HCJDC indicates a prior conviction, the EO stated that she will have to literally search the nurse's file to see if he/she previously disclosed the information and that if the nurse did not, the nurse will be referred for investigation by RICO.

The EO stated that she would keep the Board apprised each step of the way.

Legislative Updates

The Board noted the following bills introduced or new laws enacted in other states:

5/31/2019

Enacted

AL H 245 SUMMARY:

Provides for direct reimbursement for the services of a certified registered nurse anesthetist by insurers.

CO S 227 SUMMARY:

Authorizes schools to obtain a supply of opiate antagonists.

CO S 228 SUMMARY:

Requires APRNs and other prescribers to complete substance use disorder training; prohibits APRNs and other prescribers from accepting benefits for prescribing specific medications; requires opioid prescriptions to bear warning labels.

OK H 2341 SUMMARY:

Broadens practitioners who may make referrals by including APRNs.

OK S 85 SUMMARY:

Authorizes any school nurse, public health nurse, licensed practitioner of the healing arts, nurses working under contract with a school district, or any person designated by the school administration to administer an opiate antagonist in the event of a suspected overdose.

SC H 3821 SUMMARY:

Allows APRNs to sign death certificates.

Enrolled to Governor

NJ S 954 SUMMARY:

Enters State into the enhanced Multistate Nurse Licensure Compact.

TX H 1342 SUMMARY:

Relates to the consequences of a criminal conviction on a person eligibility for an occupational license; provides for various license restrictions.

TX H 1401 SUMMARY:
Provides for the use of money from the permanent fund for health-related programs to provide grants to nursing education programs.

TX S 37 SUMMARY:
Prohibits on the use of student loan default or breach of a student loan repayment or scholarship contract as a ground for refusal to grant or renew an occupational license or other disciplinary action in relation to an occupational license.

TX S 1564 SUMMARY:
Provides that the Commission shall provide medical assistance reimbursement for medication assisted opioid or substance use disorder treatment without requiring a recipient of medical assistance or health care provider to obtain prior authorization or precertification for the treatment.

HEALTH PROFESSIONAL COMPACTS

NJ S 3821 SUMMARY:
Enters State into Interstate Medical Licensure Compact.

OPIOID EPIDEMIC

NJ A 5458 SUMMARY:
Establishes pilot program for integrated system of treatment for opioid use disorders.

NY A 7813 SUMMARY:
Enacts the overdose prevention centers.

ANCILLARY PROFESSIONS

NY S 6223 SUMMARY:
Requires home health aides and nurse's aides to receive training in working with lesbian, gay, bisexual and transgender individuals as part of the education and training for certification.

WI S 222 SUMMARY:
Relates to grants to technical college districts for nurse aide training.

WI S 223 SUMMARY:
Creates an individual income tax credit for certified nursing assistant training costs.

OTHER NOTABLE BILLS

NY A 7910 SUMMARY:
Provides for the licensure by endorsement of certain registered professional nurses and licensed practical nurses who hold a valid license in Puerto Rico, and have actively practiced nursing in Puerto Rico for two of the preceding three years without having their license acted against by the licensing authority of any jurisdiction.

NY A 7813 SUMMARY:

Enacts the Children and Recovering Mothers Act to provide guidance, education and assistance to neonatal nurses, obstetricians, midwives, pediatricians and other health care providers caring for expectant mothers with substance use disorder; also provides for the screening of newborns for substance abuse exposure.

Vetoed

MD S 652 SUMMARY:

Enters state into the Interstate Physical Therapy Licensure Compact.

MD H 365 SUMMARY:

Prohibits health care practitioners and certain students and trainees from performing certain examinations on a patient who is under anesthesia or unconscious unless informed consent has been obtained from the patient for the examination, the examination is within the standard of care, or the patient is unconscious and the examination is required for diagnostic purposes.

6/7/2019

Enacted

NV S 315 SUMMARY:

Requires regulatory boards regulating physicians, physician assistants, and APRNs to encourage practitioners to receive training and education in the diagnosis of rare diseases.

NV S 456 SUMMARY:

Authorizes the admission of APRNs to membership on the medical staff of a hospital.

OR H 2011 SUMMARY:

Requires cultural competency continuing education for professions regulated by boards, including the Board of Nursing.

Governor

FL H 375 SUMMARY:

Relates to the Prescription Drug Monitoring Program; provides an exemption from the requirement to check a patient's dispensing history before the prescribing a controlled substance for the alleviation of pain related to a terminal condition or to patients receiving palliative care for terminal illnesses.

LA S 240 SUMMARY:

Provides authority for APRNs and physician assistants to provide MAT; in order to provide MAT their collaborating or supervising physician shall also be authorized and in compliance with all federal and state laws and rules authorizing the provision of MAT.

NV A 534 SUMMARY:

Grants the governor powers to authorize providers of emergency medical services and providers of mental health services who are not licensed, certified or registered, as applicable, in the State but hold a similar credential in good standing in another state or territory to assist in responding to the emergency or disaster.

OPIOID EPIDEMIC

NJ A 5459 SIMILAR: NJ S 3857

SUMMARY:

Concerns continuing education requirements for health professionals such as RNs, APRNs, LPNs, physicians, dentists, and pharmacists regarding best practices and advances in the care of pregnant women with respect to prescription opioids.

NJ S 3862 SIMILAR: NJ A 5458

SUMMARY:

Establishes pilot program for integrated system of treatment for opioid use disorders.

APRN

NY A 8074 SUMMARY:

Requires all nurse practitioners, physicians, physicians and other health care practitioners who treat a child to provide the parent of such child with evidence-based information about certain immunizations, such information to be provided by the commissioner of health.

PA S 697 SUMMARY:

Provides for provision and supervision of anesthesia care.

WI S 249 SUMMARY:

Creates an additional system of licensure for APRNs, to be administered by the board. The bill also allows a person who has not completed an accredited education program to receive an APRN license if the person 1) on January 1, 2017, was both licensed as an RN in Wisconsin and practicing in one of the four recognized roles; and 2) satisfies additional practice or education criteria established by the board. The bill also requires the board, upon granting a person an APRN license, to also grant the person one or more specialty designations corresponding to the recognized role or roles for which the person qualifies.

WI S 254 SUMMARY:

Extends those allowed to make findings of incapacity upon which a health care power of attorney becomes effective, and issue do-not-resuscitate orders to include nurse practitioners.

OTHER NOTABLE BILLS

NJ A 5477 SUMMARY:

Requires the Director of the Division of Consumer Affairs to provide certain information concerning health care professionals on the License Verification System.

6/14/2019

Enacted

AL H 471 SUMMARY:

Relates to Pike County; Authorizes an attending physician, nurse practitioner, or physician assistant to provide emergency treatment to an individual with a mental illness for up to 72 hours, and to provide protection from civil or criminal liability when acting in good faith for actions taken related to the admission or discharge of the patient.

AL S 425 SUMMARY:

Establishes guidelines for the use of buprenorphine in nonresidential treatment programs.

LA H 423 SUMMARY:

Repeals the provisions for revocation of licenses for defaulting on certain student loans.

LA S 29 SUMMARY:

States that if a licensee enters into a consent decree with an occupational licensing board regarding discipline, the licensee is not required to sign a non-disparagement agreement; An occupational licensing board may initiate discipline against a licensee for providing testimony or records to the legislature or another public body.

ME H 922 SUMMARY:

Allows a physician assistant or an advanced practice registered nurse licensed as such in this state to perform abortions, in addition to a licensed allopathic or osteopathic physician.

ME S 104 SUMMARY:

Provides that a person providing alternative or complementary health care services who is not licensed may provide health care services as long as the person does not perform surgery, prescribe medications, drugs, or devices that require a prescription, perform chiropractic manipulation, or falsely state that the person is a licensed health care professional.

NJ S 2968 SUMMARY:

Permits certain health care professionals to waive health insurance copayments for members of the military serving on active duty and their family members.

OR S 66 SUMMARY:

Authorizes the Board of Nursing to recognize military education or training programs as sufficient to meet requirements for licensure as licensed practical nurse.

OR S 665 SUMMARY:
Directs State Board of Education to adopt rules for administration of naloxone; provides immunity from criminal action or for civil damages related to administration of naloxone or similar medication by trained school personnel, including school nurses.

TX H 387 SUMMARY:
Allows a treating doctor to delegate to an APRN the authority to complete and sign a work status report regarding an injured employee's ability to return to work.

TX H 1899 SUMMARY:
Establishes requirements for the revocation or denial of certain health care professional licenses.

TX H 2454 SUMMARY:
Requires continuing education requirements for APRNs, physicians, physician assistants and dentists regarding pain management and the prescribing of opioids.

TX S 1995 SUMMARY:
Requires the review of certain occupational licensing rules by the office of the governor.

To Governor

DE H 58 SUMMARY:
Increases the numbers of Delaware nursing students eligible for the nursing incentive program by allowing Delawareans pursuing nursing careers at nonprofit hospitals to be eligible for the program.

DE H 115 SUMMARY:
Requires podiatrists, dentists, doctors, nurses and optometrists who issue prescriptions to utilize electronic prescriptions except under certain exceptions.

Introduced

OPIOID EPIDEMIC

DE H 220 SUMMARY:
Requires health insurance carriers to provide coverage for prescription medications approved by the FDA for MAT.

APRN

NY A 8224 SUMMARY:
Provides for the licensure by endorsement of certain RNs/LPNs who hold a valid license to practice professional or practical nursing in a territory of the US, and have actively practiced nursing in a territory of the US for two of the preceding three years without having their license acted against by the licensing authority of any jurisdiction.

6/20/2019

Enacted

NV A 534 SUMMARY:

Grants the governor powers to authorize providers of emergency medical services and providers of mental health services who are not licensed, certified or registered, as applicable, in the State but hold a similar credential in good standing in another state or territory to assist in responding to the emergency or disaster.

TX H 2214 SUMMARY:

Relates to the issuance of a temporary occupational license to certain military service members, military veterans, and military spouses.

TX S 1217 SUMMARY:

Relates to the consideration of certain arrests in determining an applicant's eligibility for an occupational license.

Introduced

ANCILLARY PROFESSIONS

OH H 290 SIMILAR: OH S 166

SUMMARY:

Prohibits unlawful sexual contact between an RN, LPN, dentist, dental hygienist, optometrist, physician, physician assistant, psychologist, chiropractor, speech-language pathologist, audiologist, occupational therapist, physical therapist, athletic trainer, social worker or independent social worker and patients; revokes professional licenses for criminal misconduct.

6/28/2029

Enacted

MI S 200 SUMMARY:

Allows prescribers to prescribe opioid antagonists and pharmacists to dispense to public libraries under certain circumstances.

NH H 350 SUMMARY:

Authorizes physician assistants to prescribe cannabis for therapeutic purposes.

NJ S 3375 SUMMARY:

Establishes a maternal health care pilot program to evaluate shared decision-making tools developed by the Department of Health and used by hospitals and birthing centers providing maternity services.

To Governor

CT S 375 SUMMARY:

Concerns nursing home staffing levels; ensures adequate reporting of the numbers of nursing home staff.

CT S 827 SUMMARY:

Requires physicians and APRNs who provide primary care or emergency treatment for adults to receive training in recognizing the signs and symptoms of Alzheimer's disease and dementia.

CT S 921 SUMMARY:
Updates the general statutes to reflect the current scope of practice of advanced practice registered nurses.

IL H 1652 SUMMARY:
Provides that expedited temporary occupational licenses issued to service members and their spouses meeting specified requirements shall be valid for 3 years after the date of issuance.

IL S 1166 SUMMARY:
No department shall deny an occupational or professional license based solely on the applicant's citizenship status or immigration status.

IL S 1702 SUMMARY:
Permits an advanced practice psychiatric nurse to order restraints or seclusion for a recipient of treatment.

APRN

NJ A 5650 SUMMARY:
Expands list of health care professionals authorized to provide services in connection with stillbirth to include CNMs.

NCSBN and the American Nurses Association (ANA) issue New Joint National Guidelines for Nursing Delegation

The Board asked the EO to post the new guidelines on Board's web page and to remove the "old" version.

Scope of Practice

LPN Case Manager Questions – Home Care Agency

The Board discussed the following email inquiry:

"I am currently an LPN working as a Case Manager at a local home care agency on Maui. I have some concerns related to a client our agency recently signed on to receive our services.

As Case Manager, I perform an assessment and generate a care plan for our caregivers to follow while providing companionship, respite care, housekeeping and personal care services in the home setting. Could I schedule a telephone appointment to discuss my concerns related to my legal scope of practice and this particular client?

This particular client is oxygen dependent at 6L/min. DX: End stage Interstitial Lung Disease and Chronic Hypoxemic Respiratory Failure.

The agency I work for is not licensed as a medical agency, and my concerns are related to my professional duty to perform safe nursing practices and maintain my Nursing Code of Ethics. My agency has contacted the DHS Licensing Department for clarification related to their legal parameters regarding providing oxygen therapy in the home setting but I don't feel my professional concerns have been addressed relating to medication administration and delegation of UAP tasks. I have been counseled by my employer that she will be providing oxygen therapy for clients now and in the future. She has revised her service agreement to reflect this decision. As Case Manager, she expects me to generate care plans and train UAP for these clients.

I disagree. I am requesting guidance from the BON.”

The Vice Chair stated that home care agencies fall under the purview of the Department of Health (“DOH”), Office of Health Care Assurance and that this person should go to DOH’s web page and read Title 11, Chapter 700, Home Care Agencies.

It was the consensus of the Board to also refer the inquirer to the definition of “The practice of nursing as a licensed practical nurse” under HRS 457-1.5 Practice of nursing, 457-2 Definitions, 457-2.6 Licensed practical nurse and 457-7.5 Delegation and to the Scope of Practice Decision Making Framework posted on the Board’s webpage.

Nurses Administering IVs

The Board discussed the following email inquiry:

“Can you tell me who can legally administer IVs in Hawaii?”

After further discussion, it was the consensus of the Board that speaking strictly for nurse professionals, registered nurses may administer IVs under their scope of practice. Licensed practical nurses may also administer IVs if the LPN has the additional education and training and is being supervised by an RN. Also, in both instances, the nurse should be following the institutional policies and procedures.

In accordance with HAR § 16-201-90, the above interpretation is for informational and explanatory purposes only and based solely on the information provided. It is not an official opinion or decision and therefore not binding on the Board.

Can Pediatric NP Treat Adults

The Board discussed the following email inquiry:

“With the appropriate training by a collaborating physician, can a pediatric nurse practitioner crossover to treat adults in the state of Hawaii?”

Background: I have been a pediatric nurse practitioner of 9 years. I am currently licensed in California. My new employer is currently training me to treat adults as well (orientation includes 4 months of theory, didactics, and shadowing for 40

hours a week). Furthermore, my employer would like me to be licensed to treat all ages in other states.

In CA, my NP license allows me to crossover to treat adults as long as I fulfill the requirements of my standardized procedure that must specify the requirements of experience, training, and education. Please see page 3 (2nd question) in the California NP FAQs attachment.”

Ms. Stone Murai cited HRS 457-8.5 Advanced practice registered nurse; qualifications; licensure; endorsement; fees; eligibility.

The Board also discussed the information regarding the roles of a CPNP-PC and CPNP-AC that included age parameters from the Pediatric Nursing Certification Board.

After further discussion, although the Board recognizes that in some cases a Pediatric NP’s patients may include “young adults”, a Pediatric NP may not “cross over” and should be nationally certified to treat adults whether as a Family NP or Adult NP.

Also, unlike the California BON, Hawaii does not review clinical competencies to provide care for a “new” patient population unless that APRN holds a current national certification in that practice specialty.

American Nurses Association – Hawaii Chapter:

Ms. Beechinor reported on the following:

The Hawaii – American Nurses Association will include a trade name “H-ANA” or “Hawaii – ANA” and that they are registered as a non-profit 501c(6) corporation;

Survey of non-members to identify interest in joining – 1,623 nurses from HPH were surveyed with 941 responded “yes”;

Leadership Team – Hawaii – ANA has a minimum of 8 leaders, herself, Katie Kemp, Aggie Pigao Cadiz, Andrea Montgomery-Kylie, Jailua Navarette, Nancy Atmospha-Walch, Marion Poirier and Joan Parker -Diaz;

ANA Standards for Excellence Program – The Leadership Team agrees to adopt and utilize ANA Standards for Excellence and agrees to complete initial assessment of leadership team;

Final Report & Request to ANA Board – Resolution brought forward at ANA Membership Assembly June 22 & 23, 2019 at which Ms. Beechinor and Ms. Pigao-Cadiz attended.

The Board asked for clarification if members of the Hawaii ANA could be LPNs?

Ms. Beechinor stated that membership is only for RNs.

The EO asked if the Hawaii – ANA becomes a CE provider; would they allow non-members and LPNs to take CE courses.

Ms. Beechinor stated that she would check and get back to the board if that would be allowed.

Chapter 91, HRS -
Adjudicatory Matters:

At 9:43 a.m., the Chair called for a recess of the meeting to discuss and deliberate on the following adjudicatory matters:
