<u>Plan of</u> Administration:

Plan of Administration for PROC members to review. He stated that Phyllis Barker provided materials that appears to be the same program as the AICPA (American Institute of Certified Public Accountants).

Discussion ensued regarding AICPA's acceptance of OSCPA Plan of Administration.

Mr. Lau commented that it is important that the OSCPA Plan of Administration was submitted to the AICPA for their acceptance.

Executive Officer Araceley stated that he was in communication with Phyllis Barker and she did confirm that OSCPA was following the AICPA model. However, he did not confirm with her if the OSCPA Plan of Administration was accepted by the AICPA.

Mr. Miyashiro stated that the AICPA Peer Review Program did an oversight on the OSCPA peer review process and issued an annual report on March 22, 2019 for 2017 - 2018.

Chairperson Takeno will reach out to Phyllis Barker to confirm if the OSCPA Plan of Administration was approved by the AICPA.

PROC Monitoring of Oregon Society of CPAS Report Acceptance Body (RAB): Chairperson Takeno stated that the AICPA is requesting a list of PROC members from Oregon and Hawaii. He circulated a template of the confidentiality agreement form for the PROC members to review. Chairperson Takeno agreed to distribute and collect the signed forms from the PROC members and send back to Phyllis Barker.

Chairperson Takeno stated that Phyllis Barker provided three upcoming OSCPA RAB meeting dates: October 25, November 22, and December 20, 2019. The PROC is requested to attend one meeting by the end of year. They also requested the PROC to
